

# THE CITY COUNCIL OF NORTH ROYALTON, OHIO

AN ORDINANCE APPROVING A LOT CONSOLIDATION OF PPN'S 483-22-002, 483-23-005, AND 483-23-009 LOCATED IN THE CITY OF NORTH ROYALTON INTO ONE PARCEL, AND APPROVING A LOT SPLIT OF THE CONSOLIDATED PARCEL INTO PARCEL 1 AND PARCEL 2 AS REQUESTED BY PROPERTY OWNER THE CITY OF NORTH ROYALTON, AND DECLARING AN EMERGENCY

WHEREAS: The City of North Royalton owns PPN'S 483-22-002, 483-23-005, and 483-23-009 located on Royalton Road (Rt. 82) and formerly known as the North Royalton Compost Facility; and

WHEREAS: The city desires to consolidate these three parcels into one parcel; and

WHEREAS: Once consolidated, the city wishes to split this newly formed parcel into two separate parcels to be defined as Parcel 1 and Parcel 2; and

WHEREAS: Council desires to approve this lot consolidation and split.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH ROYALTON, COUNTY OF CUYAHOGA AND STATE OF OHIO, THAT:

Section 1. Council hereby approves the lot consolidation of PPN'S 483-22-002, 483-23-005, and 483-23-009 located in the City of North Royalton into one parcel, and approves a split of the consolidated parcel into two parcels to be defined as Parcel 1 and Parcel 2 as requested by property owner the City of North Royalton, and as further described in Exhibit A attached hereto and incorporated as if fully rewritten.

Section 2. The Law Department shall take all steps necessary to record the property split/consolidation.

Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 4. This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of the city, and for the further reason that it is immediately necessary to approve a lot consolidation and parcel split as outlined above for the public purpose.

THEREFORE, provided this Ordinance receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
