

# THE CITY COUNCIL OF NORTH ROYALTON, OHIO

ORDINANCE NO. 20-10

AN ORDINANCE CONFIRMING THE MAYOR'S APPOINTMENT OF JAMES J. MCDONNELL TO SERVE AS SECOND ASSISTANT PROSECUTOR FOR THE CITY OF NORTH ROYALTON, AND DECLARING AN EMERGENCY

WHEREAS: The position of Second Assistant Prosecutor is an appointive position; and

WHEREAS: The Mayor has appointed James J. McDonnell to the position of Second Assistant Prosecutor; and

WHEREAS: Council confirms the various appointments made by the Mayor; and

WHEREAS: Council desires to confirm this appointment.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH ROYALTON, COUNTY OF CUYAHOGA AND STATE OF OHIO, THAT:

Section 1. The Council of the City of North Royalton hereby confirms the appointment of James J. McDonnell as Second Assistant Prosecutor for the City of North Royalton, and hereby authorizes and directs the Mayor to enter into a contract for Mr. McDonnell's professional services, a copy of which is attached hereto as Exhibit A and incorporated herein as if fully rewritten.

Section 2. The annual salary of said appointed official shall be as previously determined by Council and the Mayor subject to such increases as allowed pursuant to the current non-union wage ordinance.

Section 3. This Ordinance shall supersede all previously adopted ordinances in direct conflict herewith.

Section 4. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 5. This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of the city, and for the further reason that the position of Second Assistant Prosecutor is an appointive one and it is immediately necessary to provide for this appointment.

THEREFORE, provided this Ordinance receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
