AN ORDINANCE CONFIRMING THE MAYOR'S APPOINTMENT OF
JUDITH STAVOLE- MCLAUGHLIN TO SERVE AS THE PART TIME DIRECTOR OF OFFICE ON
AGING/HUMAN SERVICES FOR THE CITY OF NORTH ROYALTON, AND DECLARING AN
EMERGENCY

WHEREAS: The position of Part time Director of Office on Aging/Human Services is an appointive position; and

WHEREAS: The Mayor has appointed Judith Stavole-McLaughlin to the position of Part Time Director of Office on Aging/Human Services; and

WHEREAS: Council confirms various appointments made by the Mayor; and

WHEREAS: Council desires to confirm this appointment.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH ROYALTON, COUNTY OF CUYAHOGA AND STATE OF OHIO, THAT:

Section 1. Council hereby confirms the appointment of Judith Stavole-McLaughlin to the position of Part Time Director of Office on Aging/Human Services for the City of North Royalton.

Section 2. The salary and benefits of said appointed official shall be in accordance with the part time benefit Ordinance and non-union wage schedule, and such subsequent amendments thereto as this Council may from time to time approve.

Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 4. This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of the city, and for the further reason that the position of Part Time Director of Office on Aging/Human Services is an appointive one and it is immediately necessary to provide for this appointment.

THEREFORE, provided this Ordinance receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
