A RESOLUTION ACKNOWLEDGING THE COMMUNITY SERVICE OF DANYLO "DAN" KULCHYTSKY

WHEREAS: In 1683 the City of Vienna was in need of someone to protect it from destruction and turned to Jerzy Franciszek Kulchytsky, who having been of great public service in the action, was awarded the lucrative coffee monopoly for himself and his heirs; and

WHEREAS: In 2012 the City of North Royalton was in need of a Building Commissioner to protect it from a different form of destruction and turned to Danylo "Dan" Kulchytsky, distant and direct descendant of the great Kulchytsky of Vienna; and

WHEREAS: Dan served as the Building Commissioner for the City of North Royalton for nearly a decade from October 22, 2012 until his retirement on June 30, 2022 and was always kind, thoughtful and most knowledgeable in his administration of his department; and

WHEREAS: The Council and the Mayor of the City of North Royalton wish to acknowledge Mr. Kulchytsky for his community service and award him free coffee whenever he visits any North Royalton municipal building hereafter.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NORTH ROYALTON, COUNTY OF CUYAHOGA AND STATE OF OHIO, THAT:

Section 1. The Council and the Mayor of the City of North Royalton hereby acknowledge the community service of Dan Kulchytsky.

Section 2. Council further recognizes the professionalism and dedication that Mr. Kulchytsky has demonstrated through his work for the City of North Royalton and through his willingness and desire to better serve the community.

Section 3. The Director of Legislative Services is authorized and directed to forward a copy of this Resolution to Mr. Kulchytsky in recognition of his community service.

THEREFORE, provided this Resolution receives the affirmative vote of a majority of all members elected to Council, it shall take effect and be in force from and after the earliest period allowed by law.
