

# THE CITY COUNCIL OF NORTH ROYALTON, OHIO

ORDINANCE NO. 23-41

AN ORDINANCE ACCEPTING THE PROPOSAL OF ROCK-N-ROLL CITY HARLEY-DAVIDSON FOR THE PURCHASE OF TWO (2) 2023 HARLEY-DAVIDSON FLHP MOTORCYCLES FOR THE NORTH ROYALTON POLICE DEPARTMENT FOR AN AMOUNT NOT TO EXCEED \$43,000.00, AND DECLARING AN EMERGENCY

WHEREAS: Council has authorized the purchase of two (2) motorcycles for the North Royalton Police Department; and

WHEREAS: The Police Department sought proposals for the purchase of two (2) 2023 Harley-Davidson FLHP motorcycles; and

WHEREAS: It has been determined that the proposal submitted by Rock-n-Roll City Harley-Davidson is the lowest and best proposal; and

WHEREAS: Council desires to accept this proposal.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH ROYALTON, COUNTY OF CUYAHOGA AND STATE OF OHIO, THAT:

Section 1. Council hereby accepts the proposal of Rock-n-Roll City Harley-Davidson for the purchase of two (2) 2023 Harley-Davidson FLHP motorcycles for the North Royalton Police Department (cost includes trade-in value of \$15,400.00 for two (2) 2017 motorcycles) for an amount not to exceed \$43,000.00 (cost of vehicles, options, delivery, and warranty) as the lowest and best proposal.

Section 2. The Chief of Police is hereby authorized and directed to forward a certified copy of this Ordinance to Rock-n-Roll City Harley-Davidson.

Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 4. This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of the city, and for the further reason that it is immediately necessary to provide for the purchase of these vehicles for the North Royalton Police Department for the proper and immediate performance of departmental duties.

THEREFORE, provided this Ordinance receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
