### PUBLIC HEARING LEGAL NOTICE

Pursuant to Section 1264.05 of the City of North Royalton Zoning Code, **Notice** is hereby given that the **Board of Zoning Appeals** of the City of North Royalton, Ohio, will hold a public hearing on Thursday, **July 25, 2024** at 7:00 p.m. local time in the Council Chambers at City Hall, 14600 State Road.

The Public Hearing will be heard on the question of granting of variances to **Chapter 1270 "Residential Districts"**, of the City of North Royalton Zoning Code. Request is being made by Jason Presser for a garage addition located at 6855 Edgerton Road, also known as PPN: 486-02-008, in Rural Residential (RRZ) District zoning. The variances being requested are as follows:

**Variance #1:** Codified Ordinance Section 1270.08 "Front Yards of Developed Blocks." Code states that where fifty percent of the aggregate street frontage is occupied by buildings, the minimum front yard setback for new buildings or additions shall be the average setback of the existing buildings within 100 feet of a given lot. Applicant is requesting a variance of 27.5 feet from the required 90.5-foot front yard setback to construct a garage addition 63 feet from the right of way.

**Variance #2:** Codified Ordinance Section 1270.12(a) "Size, Location, Setbacks and Height for Accessory Buildings and Private Garages." Code permits dwellings between 1,800 square feet and 4,000 square feet in size to have up to 1,000 square feet of private garage space. Applicant is requesting a variance of 260 square feet to construct a garage addition resulting in 1,260 square feet of total garage space.

Hearings for each variance will be taken in order as set forth in agenda. Hearings generally take approximately ten (10) minutes. All applicants and anyone wishing to be heard on a variance request should be present at the start of the meeting. Plans and specifications and other documentation are on file at the Building Division, City of North Royalton Service Center, 11545 Royalton Road, for review by interested parties.
