### REPORTS

**Recreation Department: Jason Swim** – Rec Department moved into the old County building. They are soliciting quotes for fixing lights at York Rd fields. They are hoping to make it a 2-year project. Mayor Antoskiewicz said the city has a grant from NOPEC for 119k that can go toward the project. They plan to replace all equipment on top of poles with LEDs. They also plan to replace 3 leaning poles. Mr. Swim passed out the new sports organization requirements with the \$5 fee removed. He gave a copy for the minutes – see attached. They are working with baseball and soccer on the purchase a motorized spraying unit. They plan to add a water vault with meter and tap for NRSCG. They will be working with Cleveland Water on the project.

**School Board: Dr. John Kelly** – See Attached Report for NRCS

**Council: Jeremy Dietrich** – They are working to get the budget approved by 3/3. They want to have money to replace some of the rec maintenance equipment.

### NORTH ROYALTON RECOGNIZED CLUBS:

**Baseball (NRBB): Craig Barbeck** - Registration is still open. The season starts on 5/18. The updated Rule book has been published. All important dates are on the website in rulebook. There was discussion about requiring a permit to use baseball fields, it is currently open for anyone to use fields – Soccer fields require a permit to use. Mr. DiSiena added that soccer uses the permit to help keep people off the fields when they closed (too wet). Mr. Barbeck says that non-Royalton club teams are using the fields. NRBB is asking for help doing their financial audit from an outside party. Mr. Marnecheck said he may know someone that can help,

**Soccer (NRSC): Guy DiSiena** – NRSC registration is still active. They will take late registrations through March 21. The Spring rec kickoff is March 21. The rec season

begins on 4/4 and travel begins on 4/19. The Rec picture day is 4/25 and travel picture day is 5/3.

**Basketball (BANR): Mike Lee** – BANR will finish season next week. The Reg season had 5 of 7 teams make it to the championship finals - 2 teams won championships (5th and 6th grade boys' teams). The Girls' teams are still being developed and looking to high school to field teams. They only had enough girls to make 3 teams of the allowed 8. Cavs day will be on March 4th. BANR is in the process of completing all their financial audits. Most all practices went well for all the gyms. They only had a few cases where there were issues getting into the gyms.

**North Royalton Community Garden (NRCG): Dejana Cinquepalmi** – The garden is full – 13 on the waiting list. NRCG hopes to start by the end of March. They are hosting Open House on April 7th. They are soliciting donations for fencing and soil. They may have an Eagle scout that is willing to make benches.

## **Spring Sports**

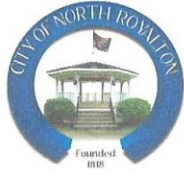
All teams are in full swing with tryouts being held.

Your organization must comply with the following requirements:

1. Provide evidence that the organization is a 501(c) (3) nonprofit organization, and yearly thereafter;
2. Provide an approved copy of its bylaws and any later amendments;
3. Provide an approved registration form. Registration form should be submitted to the City Law Department 45 days in advance for review and approval. Registration forms shall include release language for the organization, City and School as well as indemnification and hold harmless language. All registration forms and releases shall be retained and maintained by the organization unless or until directed in writing by the City;
4. Maintain all records, including but not limited to player waiver forms, until otherwise directed by City;
5. Provide proof of insurance, naming the city and school as additional insured;
6. Provide proof of Cyber Liability Insurance, naming the City as additional insured.
7. Provide financial records to the City Finance Director annually, or as required by the City;
8. Upon request, provide proof that all Coaches and Assistants have completed the following:

9. **President or other Board member must attend all Recreation Board meetings;**
10. **Provide any report or other documents as required by Recreation Director and/or Recreation Board.**

All documentation referenced above shall be submitted to the Recreation Director in a timely matter, unless a request for extension of time is granted by the Recreation Director.

Failure to comply with any of the above stated conditions shall result in the organization losing its recognized status, including but not limited to the organization's use of any city recreational property and/or equipment.
