4. Narrative statement describing the project and its features:

This application is to request preliminary approval of a site plan to construct an office building on PPN 488-01-001 (aka 12289 Ridge Rd). The building will be a total of 2\_\_\_\_\_\_\_ stories and size of 5400 square ft. The parcel is currently zoned OB. The requesting party also owns the adjacent parcel (6785 Wallings) and will petition to consolidate the two lots to create an approximately 1.75 acre conforming parcel on which to build the proposed structure. The structure will be designed consistent with the architectural style of the existing building to form a single office complex with parking between the existing and new building. Stormwater is expected to be handled via underground detention
