Mayor Ochs formally swore in Austin Grunden as the city's newest police officer in front of family and friends.

Allison Biehle was present to request from Council the rezone of properties located at 115, 117, 121, and 127 North State Street from Commercial to Commercial Planned Business. Mrs. Biehle has recently purchased the properties from Tom & Diana Taylor and plans to tear down the four houses and build a new dental office. Jack made the motion to approve the rezone request and the motion was seconded by Baron. Motion carried 4-0-1 (Lamb abstained).

Marie Shepherd, Area Plan Director, requested a rezone of the property at 112 East Main Street from Commercial Office to Residential Single Family on behalf of Phillip & Donita Layman. Jerry made the motion to approve the rezone and the motion was seconded by Jack. Motion carried 5-0.

Jerry Ford, being represented by Eric Pettit, would like to rezone the property at 855 South St Street from Commercial Single Site to Commercial Planned Business. Mr. Pettit is in the process of buying the property from Mr. Ford and plans to build an 80'X40' pole building with doors and a showroom to operate a retail business. Jack made the motion to approve the rezone request and the motion was seconded by Jerry. Motion carried 5-0.

Pamela Israel, being represented by Christina Manning, would like to rezone the property at 54 North Gum Street from Residential Duplex to Commercial Planned Business so she can operate a home day care at the sight. The request comes with the stipulation that if the property is sold or the daycare business is ceased, the zoning will revert back to residential single family. Discussion turned to the lack of parking on the street and concern about extra vehicular traffic in

Police Chief James Webster informed council that a request was made by city police officer Todd Fleetwood to privately purchase his agency issued rifle. The chief explained that officers are eligible to purchase all or part of their issued equipment within General Order 29. The Sig Sauer M400 .223 Rifle (SN 20L024846) was appraised by trade-in with a value of \$671.50 and the department is agreeable to sell the rifle to officer Fleetwood for the appraised value as allowable by IC 5-22-22-6. Baron made the motion to approve the sale of the rifle and the motion was seconded by Jack. Motion carried 5-0.

Trent requested use of the city stage for July 4^{th} on behalf of the Jennings County Small Business Coalition, as they are planning a firework celebration and other entertainment at the Jennings County Fairgrounds on July 4^{th} . At this time, the group wishes to reserve the stage but have not yet requested the waiver of fees.

Those in attendance were reminded by Park Director Chad Speer that the grand opening of the city's new aquatic center was scheduled for 11:45 AM on Sunday, June 14, 2020.

Brian made a motion that a new housing study group be formed of six members, three of which will be appointed by the mayor and three of which would be appointed by council. The motion was seconded by Jack. Motion carried 5-0. Appointments to the group will be named at the council's June 22nd meeting.

Jerry made the motion to approve the minutes of the June 8, 2020 City Council meeting as written and presented and the motion was seconded by Jack. Motion carried 3-0.

Edward Galliher was present to ask council for permission for him to keep chickens and rabbits inside the city limits. His neighbor had recently called animal control with a complaint and he was told that according to the city/county joint ordinance, he needed the city's permission to have livestock inside the city limits. City Attorney Larry Greathouse, after reviewing the ordinance, told Mr. Galliher he was allowed animals at his home so long as he followed the restrictions set forth in the ordinance. Council discussed having Larry create a city ordinance that was more strict than the joint county ordinance for their consideration in the future.

Lieutenant Keith Messer requested from council an amendment to the 2020 salary ordinance to reflect the promotion of Officer Isaac Barkes to sergeant. The promotion was approved unanimously at the June 18, 2020 Board of Public Works and Safety meeting. Jack made the motion to amend Ordinance #988 from officer with 4 years of service at \$21.70/hour to sergeant with 4 years of service at \$23.37/hour. The motion was seconded by Brian. Motion carried 3-0.

Shawn spoke briefly with the council about his concerns for the 2021 budget, specifically noting the effect COVID-19 could have on revenue. The June property tax distribution is likely to be less than that of previous years due to the extension of the deadline for payments, and other sources of revenue like the state MVH distribution and LIT tax are likely to be less than previous years due to the Coronavirus. In light of so many variables, Shawn recommended no increase to the budget in 2021 from 2020, and a reduction may have to be considered as we get more answers.

Appointments to the housing committee were postponed until the next meeting in July.
