

ORDINANCE # 983

**AN ORDINANCE PERTAINING TO
PROHIBITED PARKING ON HIGH STREET**

WHEREAS, the Common Council of the City of North Vernon has authority to regulate parking of vehicles on roadways under the City's jurisdiction; and

WHEREAS, the City Engineer and the North Vernon Police Department have analyzed traffic activity on High Street from the intersection of Indiana State Route 3 to the intersection of Stockwell Street and determined overall street design and condition will not allow for street parking on the south side of the street. It is hereby determined additional parking regulations are necessary and appropriate to enhance the safety of all motorist, and

WHEREAS, the Common Council of the City of North Vernon has determined that it is in the best interest of public safety and welfare of the citizens and motorist of North Vernon that NO PARKING be allowed on the south side of High Street, an east-west direction street, from Indiana State Route 3 to the intersection of Stockwell Street.

NOW, THEREFORE BE IT HEREBY ORDAINED, ENACTED, AND DECLARED by the Common Council of the City of North Vernon, that:

ESTABLISHMENT OF PARKING RESTRICTION

- Sec. 1 **Area Involved**
- A. This ordinance shall prohibit parking on the south side of High Street in North Vernon, Indiana from the intersection of State Route 3 to the intersection of Stockwell Street.
- Sec. 2 **Signage**
- The Street Commissioner of the City of North Vernon is authorized to post reasonable and appropriate signs and/or markings to inform motorists of prohibited parking on High Street.
- Sec. 3 **Penalties**
- All motorists must abide by the above listed parking restriction. Motorists that park their vehicle in a prohibited area are subject to Indiana Traffic Control Regulations and Codes. Enforcement action is required of all authorized law enforcement officers. (See Indiana Code 9-21-16 concerning parking regulations)

Sec. 4 **Repeal of Conflicting Ordinances.**

The provisions of all other city ordinances in conflict with the provisions hereof, if any, are of no further force or effect and are hereby repealed.

Sec. 5 **Severability**

If any part of this Ordinance shall be held invalid, such part shall be deemed severable and the invalidity thereof shall not affect the remainder of this Ordinance.

Sec. 6 **Duration and Effective Date**

The provisions of this Ordinance shall become and remain in full force and effect upon adoption and until its repeal by ordinance.

SAID ORDINANCE is hereby passed and adopted this 29th day of May 2019.


