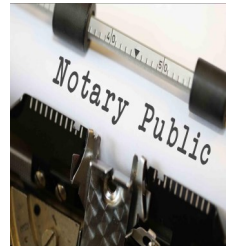

## Town Manager's Report February Commission Meeting

### Mayor, Commissioners & Residents of Ocean

The new year is keeping staff on our toes and the office is humming along. There have been a few bumps in the road with the town hall being short-staffed, but we hope to resolve that by the end of February as we onboard new staff members. In the near term, we will have temporary employees assisting in the town hall to ensure that we can provide the customer service our residents deserve. We recently have had Shanae Davis join us from Robert Half Temporary Staffing to assist Town Hall with answering phone calls, accepting permits, and payments, all other duties as needed until the new Deputy Clerk is able to begin work. We are also working with Robert Half to get some short term accounting assistance for Jean so that she is able to get caught up on her work as she has been overwhelmed with doing her work while also covering the front of town hall duties in the last quarter of 2022 and through January as we experienced a period of time where the front office was severely understaffed due to staff illnesses and absences. It is our hope that with the beginning of the new year, some transition in staff with new hires that operations will once again become a smoothly operating team of professionals that serve the residents and customers of Ocean Ridge.

I have been working throughout January to identify individuals that can provide financial advising for the Town of Ocean Ridge, we have adopted a new Investment Policy and at the February meeting will be considering the resolution to enter into an interlocal agreement to join the Florida Cooperative Liquid Assets Securities System (FLCLASS) to invest the towns cash reserve funds in a liquid interest-earning investment pool that will benefit the town by significantly increasing our monthly interest income. Currently, our money market rate is 1%, and the investment pool is paying over 4.5% monthly in interest on funds invested. The financial advisor will also ensure that the town, has the best advice on the next step for how to move forward with the Town Hall loan which must be refinanced due to the phase-out of the LIBOR portion of the loan by June 23, 2023

I have met with the property owners for a few of the areas that the town has identified as necessary to obtain drainage easements to ensure that proper stormwater drainage projects are completed for the benefit of the community as a whole. We are in the process of initiating land surveys to identify the specific legal description and any current structures or vegetation located in the areas where the easements are needed. We are also speaking with the property owners to determine if they have any issues or concerns that may need to be addressed in order to obtain their cooperation for the easement. Additionally, we are working to ensure that areas where infrastructure easements were to have been exercised in the past, infrastructure piping was placed but not all paperwork was completed that we are able to work with the property owners to ensure that we are able to resolve those issues for the benefit of the town and the property owner moving forward.

The plans for the ARPA water project have been submitted to the state and to the SWFWMD for review and approval so that we can begin moving forward on getting permits if they are approved and finalizing the next steps. We have identified that due to rising costs, the ARPA funds will most likely no longer be able to cover the full cost of the project and it may be necessary to apply either for a legislative appropriation, grant funding or another financing mechanism to fully fund the project.

Town Clerk Avery and I have had several phone calls and a meeting with our FEMA and State representatives about our reimbursement needs for Hurricane Ian and will be meeting with them hopefully soon regarding the needs for Hurricane Nichole. They have asked for the full after-action report from Nichole so that they can forward the concerns about the Ocean Ave evacuation route flooding to be elevated to FEMA to be able to place it at a higher level of concern for both FEMA and FDOT



## Town Manager's Report—March Commission Meeting

In the month of February, we recognized the following employees for their years of service to the town: Dispatch Manager Jessica Simpson – 18 years, Detective Aaron Choban – 5 years and Officer Valentina Clouse – 2 years. We want to thank all of them for their service to the town.

Joining the town hall staff this month was Katrina Pinder our new Deputy Town Clerk. Trina joins us from Mangonia Park where she has been working in the clerk's department for thirteen years. She has completed her training for the Certified Municipal Clerk designation and is currently awaiting her certificate.

You may have noticed what seems like a lot of large machinery and activity going on around town hall this month. Progress is moving forward on a couple of major capital projects. The new generator for the town hall has arrived and been installed. The old generator has been sold and removed from our location. The public works storage building is progressing with the new foundation in place at the back of the parking lot of the town hall property.

We are saying good by this month to Building Official Durrani Guy who has submitted his resignation effective March 13<sup>th</sup>. The building department is extremely important to Ocean Ridge and the town will work to fill this position permanently, in the short term we will be seeking to fill the position with a qualified interim Building Official to prevent any additional disruptions in the building department.

We will also soon be saying goodbye to Chief Richard Jones, the town has been seeking to fill the position with a permanent replacement, but I will not be moving forward with that process at this time. I will work with Chief Jones to identify a qualified interim Chief for the Commission to approve so that the new manager can build the leadership team that works best for their vision and management style.

## MESSAGE FROM THE MAYOR

Happy March! A lot going on in Town, so some quick updates for you.

We had both Greg Weiss, Mayor of Palm Beach County as well as Trevor Fleming from Representative Lois Frankel's office speak at the last two Commission Meetings. I asked them to speak to us regarding Environmental and Infrastructure Funding for priority issues i.e., Stormwater Drainage/ Septic>Sewer progress as well as Conservation and Protections for our fragile barrier Island. I also attended a Florida League of Cities meeting with regards to the National Bipartisan Infrastructure Bill and was made aware of the \$1.3 Trillion available for projects. We will be working towards claiming some of this funding, but a lot of work must be in place before we can officially apply.

There was a joint workshop between the Planning & Zoning Board and the Town Commission. Topics such as Seawalls/ Pave projects/ Floor Area Ration and an updating of Landscape Ordinance with concerns for Dune, Mangrove & Canopy Protections on the Agenda.

Last month there was a Crime Prevention Seminar Event put together by our Police Department, which was overseen by Officer Nubia Savino. We had reps from approx. 9 different entities, including Boynton Beach Fire Rescue who discussed safety programs and gave tours through their individual trucks. A wonderfully informative program.

Police Chief Richard Jones formally announced his desire to resign and move on to Gulf Stream during our March Commission meeting. And our Building Official, Durrani Guy also announced his resignation and will be moving on to work in Westlake.

The Chief has shown grace under pressure during his time here, as well as his never wavered Sense of Duty that has made him the finest leader we could have hoped for. I expressed these same sentiments to my very lucky friends in Gulf Stream, Mayor Scott Morgan and Town Mgr. Greg Dunham.

A reminder that Turtle Nesting Season began March 1st. Sea Turtles are a protected species and know that the County has the densest nesting beaches in the State. Palm Beach County asks that your residential lighting be 'turtle friendly' - which means not visible from anywhere on the beach and that there is no furniture stored on the beach between sunset and sunrise. Keep your eyes open for Turtle tracks & contact Palm Beach County, ERM, (Environmental Resource Management), our local friends at Sea Turtle Adventurers and/or Gumbo Limbo Park with any questions you may have.

As you all know, with our changes in Staff we are in a bit of a 'Transition' period, so I ask for your patience and courtesy. Folks from all over are listening to our meetings and reading our Town's business in the local press. We can all do our part as we move forward and encourage qualified candidates to consider working here, whether for CEO or receptionist, by showing our very best and most respectful side. I have been speaking with a multitude of residents lately, and the overwhelming majority love Ocean Ridge and are happy to reside here.
