## Town Manager's Report - July Commission Meeting

### Mayor, Commissioners & Residents of Ocean Ridge:

In the spirit of interlocal cooperation, I have been asked to serve on the Audit Selection Committee for the City of Greenacres and will begin those duties at the end of the month. It will be an honor to serve one of our fellow municipalities.



The Crown Colony crosswalk installation is expected to happen the week of July 11-15; however, we are still waiting for FPL to install the necessary lighting. FPL updated us that they expect to receive the necessary supplies for this project by July 1<sup>st</sup>, so we should be on track to install the crosswalk during our FDOT permitted dates of 7/11-15.

As we bid farewell and wish all the best to our Town Clerk who is going back to school to study law, we have conditionally offered the position to a candidate who is currently a Deputy Town Clerk in another municipality in Palm Beach County. The offer is contingent upon the candidate passing the necessary background check. Stay tuned for more information!

I attended the Palm Beach County League of Cities meeting recently and received information regarding property fraud alerts. Please see our website at [https://www.oceanridgeflorida.com/news\\_detail\\_T6\\_R428.php](https://www.oceanridgeflorida.com/news_detail_T6_R428.php) for more information and to sign up for this service. In addition to the website and social media, we will also post a story in our next newsletter to alert our residents.

I attended a Finance Officers' Association seminar recently, and the speaker was the Palm Beach County Property Appraiser, Dorothy Jacks. She shared that Ocean Ridge is in the top 10 (we rank #6) for property valuation increases this year. That is incredible! We've never been in the top 10 before, and it just goes to show you how busy our Building Department has been for the past two years! The downside of that is our small staff is becoming very overwhelmed. With our Town Clerk leaving along with her knowledge of our codes in reference to land development, we may see a backlog of land development permits and building permits for the next several months. We appreciate our residents' patience as we are short-staffed and move forward with training new staff.

FDOT is currently performing concrete spalling repairs on the bridge near Ocean Inlet Park on A1A and should be finished by the first week in July.

# Regular Town Commission Meeting Summary

## Town of Ocean Ridge, Florida Office of the Town Clerk Budget and Regular Commission Meeting Summary July 5, 2022

The following is a list of actions taken at the July 5, 2022, Budget and Regular Town Commission Meeting. We hope this helps keep our residents informed in a timely fashion regarding Town Commission and Staff activities.

1. The Town Commission consented to the Following Budget Items for FY23:
  - a. Maintain the Flat Mil Rate of 5.50 to incorporate into the next version of the budget, and set 5.50 as the maximum mil rate. The Town Commission may decide to lower this mil rate throughout the budget process; however, they may not exceed this rate.
  - b. Allocated \$250,000 to a drainage project on Harbour Drive North.
  - c. Allocated \$50,584 for the upgrade of the Town's finance software.
  - d. Allocated \$150,000 to replace the generator at Town Hall.
  - e. Reduced the funding for a lobbyist from \$40,000 to \$20,000.
  - f. Approved the starting pay for the Public Works I position at \$62,000 as the prospective employee has an electrician's license.
  - g. Allocated \$10,000 for signage in reference to the Old Ocean Blvd Pedestrian Safety Program, and directed staff to provide a map of the new sign locations.
  - h. Directed staff to provide additional salary survey information at the next meeting.
  - i. All other line items approved as presented by Management.
  
2. Announcements:
  - a. The meeting schedule for the next month is as follows: Budget Meeting Tuesday, August 1<sup>st</sup> at 2:00 PM followed by the Regular Town Commission Meeting at 6:00 PM. The Planning & Zoning Commission meeting for July has been cancelled.
  - b. There will be no Building Official's forum in the month of August.
  - c. Residents who wish to sign up to receive important Town notifications and news through Civic Ready should sign up on the Town's website or call Town Hall for assistance.

In addition to the above listed activity and regular patrols of the beaches and roadways; officers conducted traffic enforcement activities and completed numerous code enforcement investigations.

Please note: The above listed activity is just a snapshot and not a total accounting of the activity officers of your police department engage in on a monthly basis. This snapshot is to help raise awareness and prevent crime through information sharing and proactive involvement with security, such as locking vehicle doors and closing garage doors when away from these areas.

## MESSAGES AND REMINDERS FROM YOUR POLICE DEPARTMENT

**From Richard Jones, Chief of Police:**

### POLICE ACTIVITY AND STATISTICS UPDATE

As you are all aware, I was appointed as your Chief of Police in August of 2021. Since that time, I have made many changes within the police department which has led to Proactive Policing and Crime Reduction. Proactive Policing is a strategy that involves police officers seeking out criminal activity through traffic stops and face to face encounters with the public.

On January 10, 2022 I instituted a new unit, which we call ACE (Aggressive Criminal Enforcement). This unit is made up of three (3) Police Officers whose primary focus is Proactive Policing. Although every officer participates in this process, the Ace officers work a unique schedule designed to support enforcement during the busiest hours and when we have identified the higher likelihood of criminal presence.

Since that time, we have been tracking the Ace team's performance in connection with criminal activity to see how the unit and the police department are working to combat crime while increasing our police presence. The numbers in the table below represent numbers from the first half of 2021 compared to the first half of 2022.

	January 1, 2021 – July 5, 2021	January 1, 2022 – July 5, 2022
Traffic Stops	315	1962
Arrests	14	44
Stolen Vehicles	4	2
Recovered Stolen Vehicles	1	3

As you can see from these numbers, this new unit has been a success. The unit has also clearly started the process of building a reputation that the Town of Ocean Ridge Police Department does not tolerate crime and will use every resource to combat it. We want this message to be clear to criminals, so they avoid our community altogether.

Not only have we reduced crime, we have also increased the public services that we offer to our residents during this same time. These improvements and increases in public service have been accomplished without any budgetary increases to the Town and ultimately the residents.

We thank you for the opportunity to Protect and Serve you and your family. Should you ever need us, we would be pleased to assist you.

According to the FBI, property and mortgage fraud is the fastest growing white-collar crime in the United States. Scammers file fake deeds, making it appear as if they own homes that are not actually theirs. These scammers then trick people into giving them money to rent or buy those homes.

The Palm Beach County Clerk of Court & Comptroller now offers a tool to help combat this type of Fraud. This tool is free and available at <https://www.propertyfraudalert.com/FLPalmBeach>.

This tool is called "Property Fraud Alert" and is a completely free service that monitors the documents recorded in Palm Beach County. We encourage you to use the link above to register your name and/or your business name to begin receiving these alerts immediately.

## BICYCLE & PEDESTRIAN SAFETY

On behalf of the Town of Ocean Ridge we want you all to have a safe summer. Please follow some basic rules of the road to ensure your safety.

1. Pedestrians need to walk against vehicular traffic on the side of the roadway, and if a sidewalk is provided it must be utilized.
2. Bicycles need to travel with vehicular traffic following all the rules of the road.
  - This means Bicyclists follow the same rules as a vehicle. **Bicyclists MUST stop at ALL stop signs and traffic lights.**
3. Bicyclists need to ride single file, NOT two abreast.
4. Make sure your headlight and taillight are operational prior to riding from dusk to dawn.
5. All bicycle riders under the age of 16 are required by Florida Law to wear a helmet, properly fitted, and securely fasten the strap.
6. Be seen, wear bright reflective colors on clothes, shoes and hats when walking or riding in the dark.

## PET SAFETY

### **“Did you Know”**

- Asphalt temperatures can be much hotter than the air temperature.
- Air Temperature Vs. Pavement Temperature
 

77° F	125° F
87° F	143° F
- Dogs need exercise, but it may be too hot to walk on the pavement. Walking on dirt or grass is a safer alternative.
- If walking on pavement is the only option, consider using dog shoes, socks, or booties. This is an effective way to protect dog paw pads from injury. Paw wax is another alternative to a dog wearing socks or boots.
- Walking your dog early in the day before the pavement heats up, or later in the day after the pavement cools down, will help prevent injury.
- We have a Puppy fountain outside of the Police Departments entrance. Please feel free to stop and give them fresh water, then stop in and see Jessica or Courtney for a puppy treat.
- NEVER leave your pets in your car, even if the windows are cracked. Temperatures are warmer inside than the air temperature outside by 20 degrees.
