Mayor & Commissioners:

The first Septic to Sewer Citizens' Advisory Committee Meeting was held on July 15<sup>th</sup> and it was very well attended by the public. The Town is extremely fortunate to have the caliber of committee members that it does, and I'm confident that the recommendations they will make to the Commission will be made only after thorough investigation and thought. The next committee meeting will be held on August 8<sup>th</sup> at 9:00 a.m.

A couple of coconut trees were removed on Old Ocean in the right of way near Colonial Ridge due to lethal yellowing/bronzing. Public Works is working with our contractor to hopefully save some of our other trees from lethal yellowing, but some trees may be already too far gone and in need of removal. We will let you know more as soon as the assessment is completed.

The Town recently held an informational session and ice cream social introducing our new Civic Ready citizen alert system. Staff has been working with several residents over the past couple of weeks to make sure they are able to sign up properly. Any resident who is having trouble registering is encouraged to notify us at Town Hall so we can help you through the process.

## **Regular Town Commission Meeting Summary**

The following is a list of actions taken at the August 5, 2019 Regular Town Commission Meeting. We hope this helps keep our residents informed in a timely fashion regarding Town Commission and Staff activities.

1. Announcements:

## Turtle Season—March 1 through October 31 in PBC



Turtle season runs from March 1 through October 31 in Palm Beach County. Throughout the season, Ocean Ridge Tidings may provide you with interesting and informative turtle updates from Palm Beach County Environmental Resources Management when available. In addition, there are flyers and small table top signs available at town hall for residents, condo and homeowner associations to display. Supplies are limited.

There are three sea turtle species that nest in Palm Beach County and they are the endangered green and leatherback, and the threatened loggerhead. Artificial lighting may deter females from nesting and can prevent hatchlings from reaching the water. Please adjust or extinguish all beach lighting to

protect the turtles laying eggs and nesting on the beaches. Beach furniture and other obstacles on the beach may block access to suitable nesting locations so please remove them as well.

You can help the sea turtles by following these tips:

- Turn off non-essential beachfront lighting.
- Replace incandescent & fluorescent bulbs with red or amber LED bulbs.
- Reduce lighting visible from the beach by lowering, shielding, recessing, and/or redirecting fixtures.
- Use draperies or blinds to reduce interior lighting.

#### From the Palm Beach County Property Appraiser:

Filing for homestead exemption just got easier.

Now, the day you close on a home in Palm Beach County, you can **E** file for a homestead exemptions on the Palm Beach County Appraiser Public Access website, *without the deed*.

When qualifying for a homestead exemption, you will need the following documents for all property owners applying:

- Florida Driver's Licenses or Florida ID (if you don't drive)
- Florida car registration
- Florida Voter's ID (if you vote)
- Immigration documents if not a U.S. citizen

## How to Prepare Your Yard for Hurricane Season

(Tips from: Solid Waste Authority– SWA)

Hurricane Season starts June 1, Please see following tips from SWA:

- Cut back all trees and weak branches that could come in contact with buildings before hurricane season
- Have foliage thinned so wind can flow freely through branches, decreasing the chance that trees or plants will be uprooted.
- Containerize small pieces of vegetation, such as pine needles, leaves, twigs, etc. in bags or cans that weigh less than 50 lbs. when full and place at the curb on your scheduled day.
- Clean your yard of any items that could pose a danger to you or your neighbors in hurricane -force winds, such as old lumber, broken lawn furniture, etc., and place them curbside on your bulk waste collection.
- Place vegetative material from routine maintenance at the curb on your regularly scheduled collection day.
- Follow the 6/50 rule: each piece of vegetation cannot exceed 6 ft. in length or 50 lbs. in weight.

Officer Parkerson enjoys helping the citizens of Ocean Ridge. He works the night and weekend shift so be sure to say hello when you see him around Town!






#### FROM FPL: Line clearing helps prevent outages

FPL is committed to delivering safe, reliable electric service to our customers. Trees, especially palm trees, can interfere with power lines and are one of the most common causes of power outages and flickers.

FPL's preventative maintenance program annually clears tree limbs and branches that can potentially cause safety issues and power outages from 15,000 miles of power lines. FPL uses "directional pruning" to protect the health of your trees while helping them grow away from power lines. Directional pruning is a professional technique of pruning trees away from power lines by removing entire branches and limbs down to the main trunk of the tree where trees normally shed them. This method directs future tree growth away from the power lines and reduces re-growth.



#### Plant the Right Tree in the Right Place

By selecting the right tree and planting it in the right place, you can help reduce power outages and flickers for you and your neighbors.

Trees come in all shapes and sizes, and often change dramatically over their lifetimes. **Before selecting a tree, make sure you know how tall, wide and deep it will be at maturity.** For a list of recommended trees for your area, please visit FPL.com/trees.

Where you plant your tree is just as important as what type of tree you plant. Blocking an unsightly view or creating some shade may be a priority, but you must also think about your tree's impact on existing utility lines as it grows taller and wider. At maturity, will its canopy reach the overhead lines? Keep in mind that the larger the power pole or structure, the farther back you should plant your tree. Planting trees that will interfere with power lines can jeopardize the reliability of your electric service. Taking the time to consider location now can prevent avoidable power disturbances for years to come.

It's never too late! To correct landscaping missteps of the past, try relocating or removing small trees to prevent future service issues. No amount of trimming can substitute for smart landscaping and responsible maintenance by property owners.

#### Trees in your neighborhood

When landscaping your home or business, remember to:

- » Plant only small trees and shrubs in areas adjacent to power lines.
- » Keep medium and large trees, including palms, at a safe distance from power lines.
- » Keep transformers clear of vegetation at all times.

#### Hurricane Season Continues

As we enter the middle of August, we wish to remind everyone that we are approaching the peak of Hurricane Season. Now is not the time to let your guard down.

Your police department and other Town employees are currently reassessing the town for hazards that may affect the safety and wellbeing of our residents should we be faced with a tropical system this year.

As part of our assessment we will again be looking at overgrowth and trees that are in or may affect the utility lines within the town. As such, I must remind you that trees and vegetation emanating from your property are your responsibility to maintain and are expressly prohibited from being in utility lines. (Town Code 66-151)

Sec. 66-151. - Tree permits

b) Tree removal, replacement, conditions and exemptions

(7) Tree trimming and maintenance. Notwithstanding any other provisions contained in <u>chapter 66</u>, article IV, all trees shall be trimmed and maintained so as not to come in contact or otherwise obstruct or interfere with power or other utility lines or facilities. Property owners shall be responsible for complying with this subsection with respect to all trees located on their property, on privately granted utility easements for which their property exists as the servient estate and on any adjacent rights of way upon which the property owner has sought permission or a license from the town to plant or maintain landscaping including trees. No permit will be required from the Town for such trimming or maintenance provided, however, that such trimming or maintenance shall comply with the provisions of subsection (6) above.

In addition we will begin placing notices and making personal contact at properties that have yet to comply with **the new coconut trimming ordinance**. If you see that your neighbor has not trimmed, please help us and pass the information to them about this new ordinance.

As always we are working with other Town departments and the utility companies on a regular and continuous basis to address these issues.

In addition, we will continue to monitor the many construction sites throughout the Town for compliance with appearance and maintenance standards, so as not to have loose debris and material being blown about and disrupting the safe travel of our residents.

#### SCHOOL IS OPEN

School is now in full swing. Please remember to allow extra time in your travels to compensate for the extra traffic and school busses on the roadway.

We remind you that it is required for all traffic, in both directions, to stop for school busses picking up or discharging children when the red lights on the bus are displayed.

Though we have a limited number of children who receive bus service in our community, the cargo that is picked up and transported by school busses is the most important cargo ever transported! Please be mindful of the children awaiting pickup when driving in the area as they may be out very early and may not be easily seen.

REMEMBER: Your Police Department is OPEN 24 HOURS EVERY DAY OF THE YEAR/ RAIN OR SHINE! We are here to assist you! We will always try to help. If we do not have the answer to your question, we will try to assist you in locating the person or agency that does. Feel free to call upon us anytime.
