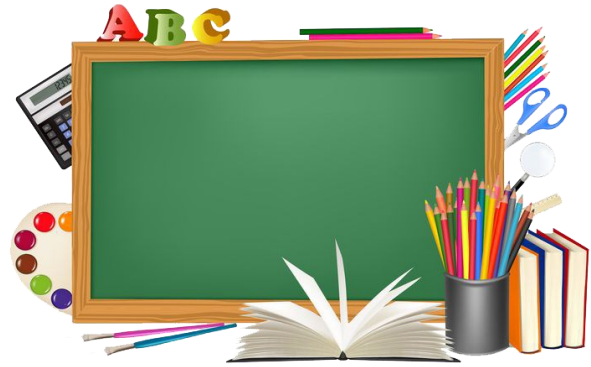

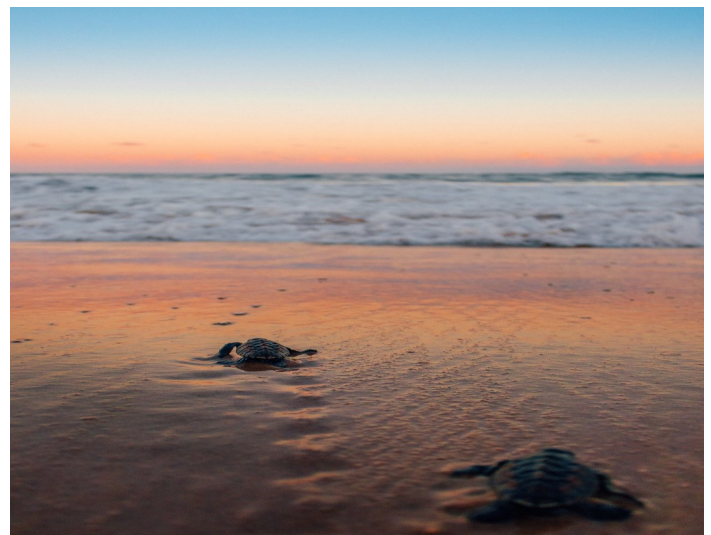
The Crown Colony crosswalk installation has been completed; however, we are still waiting for FPL to install the necessary lighting. They estimate that the parts for the lighting will arrive in September. I recommend that we place "closed" signs at both entrances to the crosswalk until the necessary lighting upgrades are completed and permit finalized by FDOT.

The repairs to the Inlet Cay, Sabal Island, and Island Drive bridges have been completed and inspection reports submitted to the town, along with a field observation report submitted by our Town Engineer. FDOT will be following up with their inspections in the near future.

# Regular Town Commission Meeting Summary

August 1, 2022**

The following is a list of actions taken at the August 1, 2022, Budget and Regular Town Commission Meeting. We hope this helps keep our residents informed in a timely fashion regarding Town Commission and Staff activities.

1. The Town Commission consented to the Following Budget Items for FY23:
  - a. Approval of a 5.5% stipend for Public Works, Administration, Building Dept, Police Chief and Lieutenant payable in this current fiscal year.
  - b. Approval of the proposed salary ranges for the Police Chief, Lieutenant, Dispatchers and Dispatch Manager.
  - c. Addition of a part-time Administrative Assistant for the Building Department.
  - d. Change in hiring policy to give the Town Manager the ability to offer 15% over the minimum salary to new hires.
  - e. Authorized staff to begin the purchasing process for the Town Hall Generator and Dispatch furniture to prevent further price increases, and to move forward with other capital improvements projects if necessary due to pricing. Although ordering may occur now, expenditures will be made after October 1, 2022.
2. Announcements:
  - a. The meeting schedule for the next month is as follows: Regular Town Commission Meeting Tuesday, September 6th at 6:00 PM which will include the first public hearing on the proposed FY23 budget; and Planning & Zoning Commission Meeting Monday, August 15th at 8:00 AM.
  - b. There will be no Building Official's forum in the month of September.
  - c. Residents who wish to sign up to receive important Town notifications and news through Civic Ready should sign up on the Town's website or call Town Hall for assistance.
3. Approved the Consent Agenda including:
  - a. Acceptance of the Revenue & Expenditure Reports for June 2022.
4. FCCMA Senior Advisor Dan Kleman presented information regarding the Town Manager search.
5. Chief Jones recognized Investigator Aaron Choban and Police Officer Nubia Savino for their recent efforts in helping to keep the community safe.
6. Vice Mayor de Haseth addressed the public regarding a comment she made via email.

7. Approval of a reduction of the building permit penalty fees for 6550 N. Ocean Blvd, Unit 10 in the amount of \$500. The amount to be refunded is \$475.
8. Adopted on second Reading Ordinance No. 2022-09 – An Ordinance of the Town of Ocean Ridge, Florida, Amending Its Code of Ordinances, Specifically the Land Development Code, to Extend the Architectural Requirements for Front Elevations to All Elevations for Single Family Dwellings and Accessory Structures and to Permit Flat Roofs With Restrictions on Single-Family Residential Dwellings and Accessory Structures by Making Revisions to Chapter 64, Zoning, Article I, District Regulations, Section 64-1, RSF And RSE Single-Family Residential Districts, Section 64-3, Ocean View Special Area, Article III, Supplemental Regulations, Section 64-50, Location of Exterior Residential Equipment and Accessories, and Section 64-60, Decks, Patios, Driveways, Parking Areas, Steps, Stoops, and Terraces (Unenclosed and Uncovered); Chapter 67, Buildings and Building Regulations, Article III, Technical Codes and Other Construction Standards, Division 1, Generally, Section 67-37, Roof Systems; Providing for Codification, Repeal of Conflicting Ordinances, Severability, and an Effective Date.

## **IF YOU LEAVE IT, LOCK IT!**

Over the last several years, I have consistently sent out this notice and message to the residents of Ocean Ridge. This year, we would love to have the opportunity to prevent any crime from occurring in Ocean Ridge, but we also want you to be alert and aware when you park your vehicle outside the boundaries of our Town.

The entire State of Florida has continued to see an increase in vehicle thefts and vehicle burglaries. These numbers continue to rise higher and higher each year. Our experience shows that this type of crime usually increases during summer months. I contribute these increases to the fact that school is not in session during some summer months and many juveniles are unsupervised during this time.

As you all know, the Ocean Ridge Police Department and been putting forth a huge amount of effort to reduce crime within our community and the efforts have been successful. Although we have seen a decrease in these types of crimes within Ocean Ridge, our statistical numbers remain much lower than many other communities within Palm Beach County. Our numbers are also much lower than the average, but even one crime is too many.

The vast majority of the cases we have investigated in Ocean Ridge result when vehicles are left unattended, unlocked and with an ignition key left inside. Surprisingly, many times in plain sight or even in the ignition.

In addition to the vehicle being unattended, unlocked and having keys present inside them, many of these thefts have also resulted when valuables were left inside the vehicle in plain view.

With all these factors being known, the best way to reduce these crimes is by preventing it from happening in the first place. So the campaign of, ***"IF YOU LEAVE IT, LOCK IT"*** is simply that.

When you leave your vehicle unattended, lock it. In addition to that, please do not keep or leave any vehicle keys or other valuables inside your vehicle when it is parked or otherwise unattended. Keys and Valuables are enticing to the criminal element and believe it or not, but it takes only seconds for these crimes to occur.

As discussed in previous crime prevention tips, opportunity is what a criminal thrives on. If we take away the opportunity, the criminal is left powerless.

### **FRAUD & WIRELESS SECURITY**

With technology today, Fraud has become the primary way for criminals to take advantage of us all without much effort.

Although, we cannot prevent all Frauds from taking place, we are able to safeguard ourselves to help prevent Fraud and Fraud type crimes. One of the most common areas for thieves to target potential victims is through wireless internet connections.

If you currently have wireless internet in your home or office, you should consult with your Internet Provider and/or your IT Vendor about implementing the following security measures:

1. Turn off sharing services.
  - In your own home, sharing is okay but you must remember to disable these settings before using a public Wi-Fi service.
2. Begin Using a VPN or Virtual Private Network that is encrypted.
  - Using a VPN is the best and most secure way to browse the internet, check your email or make on-line purchases.
3. Avoid using the auto-connect feature to Wi-Fi hotspots.
  - When using the auto-connect feature, it seriously endangers the safety of your personal information. Wi-Fi networks can be replicated by hackers causing you to auto connect to their network in place of your own.
4. Use HTTPS rather than HTTP.
  - Using HTTPS connections create a secure and encrypted connection while HTTP connections are done using plain text.
5. Use two factor authentication when possible.
  - This is a security method that requires two separate types of verifications to allow a secure log-in or connection. Most often this takes the form of a password you remember as well as a one-time code sent to your personal cell phone.

6. Confirm the network name of the network you are connecting to.
  - As previously mentioned in bullet #3, many hackers replicate Wi-Fi networks in an effort to steal your personal information. Many times, these networks are misspelled or slightly different than the network you actually intend to connect to. By verifying the name of the network you are connecting to, you are insuring that you are connecting to the correct network.
7. Protect your passwords and do not share passwords or use generic passwords.
  - Never share your password! Do not use generic passwords under any circumstances. Generic passwords are those which a certain group of people share when connecting to a specific service or network.
8. Use a Firewall Device.
  - Microsoft Windows has built in firewall settings that you should enable for your own protections. In addition to those services, you should consider using a commercial Firewall Device such as Sonicwall, Cisco or Linksys. These devices protect hackers from getting access to your network and ultimately those devices on your network.
9. Run Anti-Virus and Malware Software.
  - Every device you use to connect to the internet should contain some form of Anti-Virus and Malware Software. This includes smartphones, tablets, and any other computer type device you may use. This type of software prevents viruses and malware from infecting your computer and ultimately stealing your personal information.
10. Avoid using Public Wi-Fi Networks when at all possible
  - Instead of using public Wi-Fi Networks, use a private Wi-Fi Device that you can purchase from any major cell phone carrier. These devices are much more secure than any public Wi-Fi Network.

### CRIMINAL ACTIVITY AND YOUR ASSISTANCE

**Please lock your cars and take the keys inside. Please do not leave valuables in your car when not necessary and you are not in the car.**

**LEAVE IT, LOCK IT, KEEP IT!**
