The Ogle County Board is requesting that the revenue be split up between the ETSB and the County Board with 40 percent going to the County Board directly. He stated that the previous tower revenue was split between the two entities, and he would like to see the same thing happen again with the new site.

B. Carls stated that Ogle County is 95% migrated over to the Next Generation 911 ESInet. She stated the plots are more accurate, and Rochelle has been receiving approximately 30% more 911 calls since implementing the geo fence for the city limits of Rochelle.
