

**PIKE COUNTY COUNCIL OF GOVERNMENT**

**CALL TO ORDER** - The Pike County Council of Government was called to order at 3:00pm.

She also stated that the dormant account fee has been removed from the account. Keith Raser stated that in the past COG has sponsored classes for municipal staff to attend. These classes cover everything from computer training to the Land Development Process. The group discussed several different ideas for a class and each municipality will bring an idea of what to host at the next meeting.

**COUNTY UPDATES:**

1. Comprehensive Plan – Mike stated that the public survey for the County Comprehensive Plan will be available at the end of the month and will be available until May 31<sup>st</sup>. He stated this is a very important part of the comp plan process as the County can get an understanding of what the general public is interested in.
2. Pike County Office of Community Planning Relocation – Mike stated the Planning office will be moving on Monday April 24<sup>th</sup> to the Pike County Administration Building. The Planning office was joined with the Mapping office.

**MUNICIPAL UPDATES:**

1. Milford Borough – Joe Dooley stated that on May 20<sup>th</sup> the Borough will be partnering with Belle Reve to host a shred event behind the Pike County Administration Building from

**OTHER** – Dan Yelito from NEPA Alliance shared that he is currently working on a curb ramp/cross walk inventory for State owned roads. He stated that his office is working with LTAP to develop a new class that will focus on how municipalities can utilize GIS. He is also researching ADA Transitional Plans.
