

If you have Medicare and have a disability or face other challenges in getting to a location away from home for a vaccination, Medicare will pay a doctor or other care provider to give you the COVID-19 vaccine in your home. You may need to give them your Medicare Number for billing, but there's still no cost to you for the vaccine and its administration.

Contact your regular doctor or health care provider and ask if they're able to give you the COVID-19 vaccine in your home. If they can't, they might be able to refer you to someone who can do this. You can also call 1-800-MEDICARE. (1-800-633-4227)

Remember, don't give out your Medicare Number or accept a vaccine from any one who isn't a known or trusted provider, or who contacts you without your invitation.

Medicare also covers COVID-19 tests, COVID-19 antibody tests and COVID-19 monoclonal antibody treatments.

Clean, Separate, Cook, and Chill:

<u>Clean:</u> Even while handling food outside, it's important to remember food safety begins with proper cleaning. Make sure hands and any surface that food will touch is clean.

Separate: To prevent cross-contamination, never re-use a plate or untensils that previously held raw meat, poultry, or seafood. Otherwise, bacteria can be spread to your read-to-eat foods.

<u>Cook:</u> Cook to the right internal temperature. Undercooked meats can lead numerous food-borne illnesses. See the link for a guide on internal temperature!

<u>Chill:</u> Keeping foods at the right temperature is critical in preventing growth of foodbourne bacteria. Avoid the "Danger Zone". The "Danger Zone" is when food stays between 40-140 degrees for more than 2 hours.
