#### OVERALL PROJECT AREA EVALUATION (HIGH LEVEL): ON GOING

Emily expressed the importance of creating a different product than the Wayne County feasibility study but stressed including enough similarities to allow Wayne and Pike Counties to work together for funding, grants, and promotional opportunities in the future.

#### Map 1: Study Area

- Emily and Nate discussed the study area map and its bounds on the north of the Towpath/State Route 590 and south of the railroad. The existing study area Woodland has demonstrated allows room for areas where tight access or narrow passage will be a hindrance, specifically along the railway corridor.
- Note: Derek Williams noted that the study area was bumped out in the area near Hawley and inquired. Woodland concluded during a visit to the corridor that adjacent township roads may be useful to navigate some tight residential areas. This also creates a possible future connection to the planned "Gorge Trail" past the Hawley Silk Mill.

#### Map 2: Roadways

- Nate noted that the roadways map demonstrates a hierarchy of road classification (State roads, Township Roads, & Local Roads) allowing us to make connections to the surrounding communities (such as Woodloch). Analysis of these areas will allow for the creation of an inventory of possible locations where coordination with PennDOT will be necessary to permit roadway crossings.
- Pennsylvania Bike Route Y follows along Towpath Road (State Route 4006) and Hamlin Highway (State Route 0590) Steve Guccini noted that during the warmer months, the Tow Path sees heavy usage from bikers.
- Note: It was a surprise to some in the group that the Towpath Road and SR 590 are part of State Bike Route even though it is narrow. Jessica noted that there are some safety concerns related to this existing narrow passage.
  - Woodland will have a discussion with PennDOT (April Hannon) regarding future funding and design for adjacent bike lanes in areas where there are designated bike routes on state roads. Woodland was tasked with inquiring about future funding to expand the bike lane along this corridor to address safety concerns.

#### Map 3: Hydrology

- The hydrology map allows Woodland to anticipate possible permitting locations that may be encountered during the site visit portion of the study. Making note of these locations will drive the location of the trail based on any found permitting obstacles that may be encountered.
- The watersheds within the study area are primarily High Quality with the Lackawaxen River being a trout stocked stream. These two variables showcase the importance of having a solid plan for the trail route and incorporating access where possible to make use of these recreational opportunities.
- The Lackawaxen River is a navigable stream (designated public highway within the riverbanks) so anyone us permitted passage up or down the river. This designation illustrates the importance of future access points for river use.

#### Map 4: Land Use

- What allowances are permitted in each district? Kraig Obermiller inquired as to whether hiking and camping were permitted uses within the townships? Nate noted that this information will be part of the information acquired and included within the final report
- o Trailhead creation will be investigated within the limits of the municipal ordinances
  - The study area is largely rural, served primarily by on lot systems. Trailheads, if planned, would function in a similar way and must be self-sufficient.
- Conditional uses and accepted uses are outlined within the Township ordinances for each zoning district and will be investigated as part of the report.
- Map 5: Conservation/Public Lands

- Connecting the trail to existing parks, state, and federal lands.
- Fieldwork Mapping (zoomed in) Nate noted that within the detailed mapping, the railroad right-of-way has been replicated from the Railroad Valuation Maps that had been supplied to us by the Railroad owner. These maps illustrate the ROW that was negotiated at the creation of the railroad corridor. The ROW width throughout the corridor varies from 66' to 100' or more throughout the study area.
- PNDI
  - o Three (3) Pennsylvania agencies and one (1) Federal
  - o Potential impact for a species of concern
  - o Follow up with DCNR and the PA Fish and Boat Commission

Note: Grant inquired about which map the Cultural/Historic features of the corridor would be located on. This map is being created and Woodland will contact Grant to ensure we have all the pertinent locations identified.

#### **KEY PERSONNEL INTERVIEWS**

  - The rest of the team suggested: Lynn Conrad and Owen Worozbyt, Zoning officers from the townships, emergency management (related to accessibility in cases of emergency), Alice's Wonderland, T.C. Crawford, Pike County Outdoors, Pocono Visitors Bureau

#### **EXAMPLE SURVEY: REVIEW**

- Reviewed example questions
  - Emily noted that the intent is for the primary survey to be online (Survey Monkey) but to reach
    more people, hardcopies may need to be distributed at strategic locations and collected at a
    designated time/date.
  - Brad Kiesendahl inquired about the scope of who the survey is intended to reach?
    - Emily responded that there is no limit or intended "target audience" for the survey but a portion of the survey allows us to differentiate where surveys come in from by asking where they are located. There will be an effort to get high response numbers from Lackawaxen and Palmyra townships, as the opinions of those residents are integral. Emily noted that we are aiming at getting approximately 10% of population to reply (roughly 1,200 responses)
    - Brad noted that this region does not have the population centers at each end like the Wayne County study did (Honesdale and Hawley) so marketing to get survey participants may need to be more intense.
    - Sarah asked if the Survey was primarily driven by Social Media
      - Emily noted that the majority of the survey respondents were via social media and online, but utilizing hard copies where necessary, can be accommodated.
        - Grant noted that the committee members of the Wayne County study did an excellent job of getting the word out about the survey to groups that they were involved in outside of the committee.
      - Jessica: A QR code can be created to allow and promote access the survey by phone. This code can be placed at strategic locations within the school district, senior centers etc. Additionally, information can be placed in local newsletters or at public doorways into municipal buildings and local businesses that would like to cooperate.
      - Bill Gibney suggested hardcopies with a drop box be utilized in select locations where access to the internet/service are less prominent.
      - Emily noted that as part of the Wayne County study, Woodland was able to work with Blue Ridge Cable and the local radio station to get information about the survey to a broader range of the public.
- Survey Questions Editing:
  - Question 1: Brad noted that "Municipality" can be confusing to some; Christine suggested the label of "Township/Borough" to make it less confusing.

- Question 2: The committee expressed interest in getting more detailed demographic information from the survey participants including family size.
  - Christine suggested and pointed out that this is a feasibility study. Demographics such as
    these are more useful in an "Open Space Plan and Inventory" and keeping the
    questionnaire as simple as possible will yield the most responses.
- Question 3: No comments.
- Question 4: Jessica suggested an addition of "Camping" to the list of options. Christin: An "Other" to allow people to insert suggestions is the easiest, all encompassing option.
- Question 5: Derek: While commuting may be a less prevalent use for the trail along this corridor, the residents nearest to Hawley may be able to use the trail for commuting to work, so this question should stay.
- Question 6: Ellen suggested adding "Never" as an option for how often you would use the site. Additionally, the group suggested adding other options for when the users will visit seasonally. These changes will create an all-encompassing idea about use year-round.
- Question 7: Kraig noted a suggestion that instead of calling out "educational groups" simply labeling it "Groups" would allow for broader inclusion of users.
- Question 8: Kraig asked whether any sections of the trail would be handicapped accessible.
   Woodland noted that trails of this nature are accessible throughout, with trailheads being accommodating to handicapped access. In most cases, the slope of the trail never exceeds 5% given that the trail follows the railroad corridor making it negotiable.

- Question 10: Bill Gibney suggested adding a location for people willing to donate to the project.

#### PRESENTATION OF THE SURVEY RESULTS, SO FAR: REVIEW

- Emily reviewed the survey answers received and discussed the data.
- A total of 850 responses
- Majority of the votes were from Pike and Wayne Counties but did receive a few from different counties.

#### **Trail Walkdown Results**

- Mike- explains that one important factor of the feasibility study is to look at various routes for trail
  opportunities and if it can be accomplished legally and physically. We will have a hiking trail following
  the railroad, the Lackawaxen River, and the Towpath. The Towpath bike trail is a designated trail
  known as bike route Y and Bike Route 36. It has the opportunity in the ROW already, for bicycles and
  walking.
- Nate- We had a 2-day walkdown. We inventoried points of interest and marked those areas on our plans. We called out mile markers, areas of limitation, railroad, driveway and road crossings and cultural features. Having this information allows for us to pinpoint any obstacles and find ways to resolve them.
  - Example: Rock cut in Rowland. A trail will be unable to run along the side of the track. This is a location where a gap may be present in the trail route.
- Nate- We will have to negotiate with landowners where issues are present in the areas where pinch points are found
- Nate- There were permitted and non-permitted crossings. There were two utility crossings and cultural
  features that can be made part of the trail. This information will be part of the report in the end. There were
  areas where we would have room along the tracks, allowing for a walking bridge.
- Mike- We are very fortunate the rail line is not high speed and can work with the operator for trail use and
  other items. We have obstacles we must address, but ADA accessibility wise, the slope can be extremely
  advantageous as an ADA route. The culvert crossings have a standard design that we can work with, but we
  need to come up with solutions for other obstacles
- Nate- The Lackawaxen River is a public highway. There were red triangle markers along the river that are
  used for emergency services along the Lackawaxen. This will make it easier for creating access points and
  ingress and egress.
- Mike- The railroad operator has created points for emergency access that allows first responders to help on both the railroad and Lackawaxen.
- Nate- We are going to look at the towpath to find opportunities for a trail head or bike lanes. Its already a
  designated bike route that allows for more opportunities for funding.
- Mike- We recognized we need points of access to the river, and we need to have opportunities along the
  route for those to enter and exit safely and legally. We will identify those locations, such as the Rowland
  bridge and other opportunities. This will include conversation with property owners.
  - Grant- Just in relation to river access, as we identify those points it is important to give the emergency services to weigh in on those locations and additionally it allows us to see if there are any other types of funding.

#### WHAT'S NEXT?

- Emily- Maps will be updated along with an excel file that shows the latitude and longitude of the data collected form the trail walkdown.
- We would like to work on a date, time, and location for our first public meeting. Provide the public with introduction, due diligence, survey results, and study area.

- Design Charrette: It would be best done in person; we laminate the maps and use markers to draw all
  over them as a group and create great ideas. Want to make sure everyone feels comfortable
  - Emily- Suggestions for key person interviews are welcome
