## ORDINANCE FOR ADOPTION OF THE 1993 BOCA NATIONAL FIRE PREVENTION CODE

AN ORDINANCE TO ADOPT, BY REFERENCE KNOWN AS "THE 1993 NATIONAL FIRE PREVENTION CODE" FOR THE TOWNSHIP OF PINCONNING, COUNTY OF BAY, STATE OF MICHIGAN, TO ESTABLISHING MINIMUM REGULATIONS GOVERNING THE SAFEGUARDING OF LIFE AND PROPERTY FROM FIRE AND EXPLOSION HAZARDS ARISING FROM STORAGE, HANDLING AND USE OF HAZARDOUS SUBSTANCES, MATERIALS AND DEVICES, AND FROM CONDITIONS HAZARDOUS TO LIFE OR PROPERTY IN THE OCCUPANCY OF BUILDINGS AND PREMISES.

BE IT ORDAINED BY THE TOWNSHIP OF PINCONNING OF BAY COUNTY AS FOLLOWS:

### SECTION 1. ADOPTION OF FIRE PREVENTION CODE BY REFERENCE.

THAT A CERTAIN DOCUMENT, THREE (3) COPIES OF WHICH ARE ON FILE IN THE OFFICES OF THE PINCONNING TOWNSHIP CLERK, PINCONNING FRASER FIRE CHIEF AND PINCONNING TOWNSHIP HALL. THIS DOCUMENT BEING MARKED AND DESIGNATED AS "THE BOCA NATIONAL FIRE PREVENTION CODE, NINTH EDITION, 1993," AS PUBLISHED BY THE BUILDING OFFICIALS AND CODE ADMINISTRATORS INTERNATIONAL, INC. BE AND HEREBY IS ADOPTED AS THE FIRE PREVENTION CODE OF THE TOWNSHIP OF PINCONNING, OF BAY COUNTY IN THE STATE OF MICHIGAN; FOR THE CONTROL OF BUILDINGS, STRUCTURES AND PREMISES AS HEREIN PROVIDED; AND EACH AND ALL OF THE REGULATIONS, PROVISIONS, PENALTIES, CONDITIONS AND TERMS OF SAID BOCA NATIONAL FIRE PREVENTION CODE, ARE HEREBY REFERRED TO, ADOPTED AND MADE A PART HEREOF AS IF FULLY SET OUT IN THIS ORDINANCE, WITH THE ADDITIONS, INSERTIONS, DELETIONS AND CHANGES, IF ANY PRESCRIBED IN SECTION 3 OF THIS ORDINANCE.

### SECTION 2. ORDINANCE REPEALED.

THAT ALL OTHER ORDINANCES OR PART OF ORDINANCES IN CONFLICT HERewith ARE HEREBY REPEALED.

### SECTION 3. ADDITIONS, INSERTIONS AND CHANGES.

THAT THE FOLLOWING SECTIONS ARE HEREBY REVISED AS FOLLOWS:  
SECTION F-101.1, INSERT: TOWNSHIP OF PINCONNING.

### SECTION 4. ESTABLISHMENT OF LIMITS.

THAT THE LIMITS REFERRED TO IN SECTION F-3003.2 OF THE BOCA NATIONAL FIRE

PREVENTION CODE / 1993 IN WHICH THE STORAGE OF EXPLOSIVE MATERIALS IS PROHIBITED ARE HEREBY ESTABLISHED AS FOLLOWS:

**EXCEPTIONS:**

1. TEMPORARY STORAGE UTILIZED IN CONNECTION WITH APPROVED BLASTING OPERATIONS
2. WHOLESALE AND RETAIL STOCKS OF SMALL ARMS AMMUNITION, EXPLOSIVE BOLTS, EXPLOSIVE RIVETS OR CARTRIDGES FOR EXPLOSIVE-ACTUATED POWER TOOLS IN QUANTITIES INVOLVING LESS THAN 500 POUNDS (227 KG) OF EXPLOSIVE MATERIAL.

**SECTION 5. SAVING CLAUSE.**

THAT NOTHING IN THIS ORDINANCE OR IN THE FIRE PREVENTION CODE HEREBY ADOPTED SHALL BE CONSTRUED TO AFFECT ANY LAWSUIT OR PROCEEDING IMPENDING IN ANY COURT, OR ANY RIGHTS ACQUIRED, OR LIABILITY INCURRED, OR ANY CAUSE OR CAUSES OF ACTION ACQUIRED OR EXISTING, UNDER ANY ACT OR ORDINANCE HEREBY REPEALED AS CITED IN SECTION 2, OF THIS ORDINANCE; NOR SHALL ANY JUST OR LEGAL RIGHT OR REMEDY OF ANY CHARACTER BE LOST, IMPAIRED OR AFFECTED BY THIS ORDINANCE.

**SECTION 6. DATE OF EFFECT.**

THAT THE TOWNSHIP OF PINCONNING CLERK SHALL CERTIFY TO THE ADOPTION OF THIS ORDINANCE AND CAUSE THE SAME TO BE PUBLISHED AS REQUIRED BY LAW; AND THIS ORDINANCE SHALL TAKE FULL FORCE AND BE IN EFFECT 30 DAYS AFTER THIS DATE OF FINAL PASSAGE AND APPROVAL.
