RATE ORDINANCE
PINCONNING TOWNSHIP WATER DISTRICT NO. I

ORDINANCE NO. II - B

AN ORDINANCE ESTABLISHING RATES,
 CHARGES, RULES, AND REGULATION FOR THE USE
 AND SERVICE OF THE WATER SUPPLY SYSTEM OF THE
 TOWNSHIP OF PINCONNING AND DISTRICT NO.: I
 AND REPEALING ALL OTHER ORDINANCES INCONSISTENT HEREWITH

The Township of Pinconning, County of Bay, and State of Michigan, ordains as follows:

SECTION 1: There shall be and there are hereby established quarterly rates and charges for the use of and for the services supplied by the Township's water supply system, as follows:

A. Water Rate - Quarterly Billings

Rates for sales above minimum consumption:

\$2.01 per one thousand gallons for each one thousand gallons above minimum consumption.

B. Connection Charge

Connection charges for standard three-quarter inch tap and a three-quarter by five-eighths-inch meter shall be as follows:

Meter charge	\$ 65.00
Inspection fee	\$ 40.00
Tap fee	\$ 460.00
Debt and service	\$ 435.00
Total	\$1,000.00

Any connection not standard connection, must be referred to the engineer of the Department of Public Works for an estimate of cost based upon the size of connection and other problems incurred in connection therewith and which estimate as so determined shall be the connection fee to be billed to the customer.

C. Tank Sales

a. Fifty (50) to Seven Hundred Fifty (750) gallon tank - \$2.00 per tank.

b. Seven Hundred Fifty (750) to One Thousand Five Hundred (1,500) gallon tank - \$3.50 per tank.

c. One Thousand Five Hundred (1,500) to Two Thousand (2,000) gallon tank - \$4.50 per tank.

D. Turn On - Turn Off Charges

There shall be imposed a charge of \$16.00 whenever the Township is requested to turn on or off water services. Provided, however, that whenever the Township is requested to provide turn on or turn off service at times other than regular business hours, there shall be imposed an additional charge of \$16.00

SECTION 2: Billing

Bills for rates and charges as herein established by the Township shall be mailed quarterly. All bills shall be payable on the due date as shown on the bill, and shall be paid at the office of the Department of Public Works or authorized sub-station. If any charge for services of the system shall not be paid by the due date, a delayed payment charge of one (1%) percent per month of the unpaid balance shall be added thereto and collected therewith. If any bills for the services of the system shall remain unpaid after sixty (60) days following the rendition of the bill therefor, the water supply for the lot or

parcel of land, or premises serviced thereby may, at the option of the Township, be turned off and not turned on again except upon payment in full of the delinquent charges therefor in addition to the payment of the turn off - turn on charge of \$16.00. In addition to any other remedy provided by law for the collection of bills for services rendered as provided herein, the Township shall have a lien on the premises as provided by statute in such case made and provided.

SECTION 3: It is hereby made the duty of the Bay County Department of Public Works as agent of the Township to render bills for services and all other charges in connection herewith and to collect all monies due therefrom.

SECTION 4: All ordinances, including Pinconning Township Water Rate Ordinance Number 1 adopted July 25, 1977, and parts of all other ordinances in conflict with provisions of this Ordinance are hereby repealed.

SECTION 5: This Ordinance shall be published in full in the Pinconning Journal, a newspaper of general circulation in the Township. Promptly after its adoption, it shall be recorded in the Ordinance Book of the Township and authenticated and filed in other places as may be required by law.

SECTION 6: This Ordinance is hereby determined by the Township Board to be immediately necessary for the preservation of the peace, health, and safety of the Township and is, therefore, declared to have immediate effect.
