

PINCONNING TOWNSHIP WATER DISTRICT NO.

ORDINANCE NO. II-C

AMENDMENT TO ORDINANCE NO. II ESTABLISHING
RATES, CHARGES, RULES, AND REGULATIONS
FOR THE USE AND SERVICE OF THE WATER SUPPLY SYSTEM
OF THE TOWNSHIP OF PINCONNING, DISTRICT NO.

The Township of Pinconning, County of Bay, and State of Michigan, ordains that Ordinance No. II, an ordinance establishing rates, charges, rules, and regulations for the use and service of the water supply system of the Township of Pinconning in District No. I, shall be and is hereby amended as follows:

SECTION 1:

B. Connection Charge

Connection charges for standard three-quarter inch tap and a three-quarter by five-eighths-inch meter shall be as follows:

Meter charge	\$ 65.00
Inspection fee	\$ 40.00
Tap fee	\$ 460.00
Debt and service	\$ <u>435.00</u>
Total	\$1,000.00

Any connection not standard connection must be referred to the engineer of the Department of Public Works and an estimate of cost based upon the size of connection and other problems incurred in connection therewith and which estimate as so determined shall be the connection fee to be billed to the customer.

Not more than one building, whether residential, commercial, or industrial, or otherwise, shall be connected to one tap. All connections shall be in conformity with the rules, regulations, and procedures of the Bay County Department of Water and Sewer.

In all other respects, Ordinance No. II, adopted by the Township of Pinconning, County of Bay, and State of Michigan on the 14th day of September, 1981, shall remain in full force and effect.

This Amendment to Ordinance No. II is hereby determined by the Township Board to be immediately necessary for the preservation of the peace, health, and safety of the Township and is, therefore, declared to have immediate affect.
