SECTION III

ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT WITH ANY OF THE PROVISIONS CONTAINED HEREIN ARE HEREBY REPEALED AND SHALL BE NO FURTHER FORCE OR EFFECT ON THE EFFECTIVE DATE OF THIS ORDINANCE.

SECTION IV

THIS ORDINANCE SHALL TAKE EFFECT THIRTY (30) DAYS FROM DATE OF PUBLICATION, AND A CERTIFIED COPY OF THIS ORDINANCE SHALL BE EFFECTIVE AFTER LEGAL PUBLICATION AND IN ACCORDANCE WITH PROVISIONS OF PUBLIC ACT 184 OF 1943.
