

PINCONNING TOWNSHIP
ORDINANCE NO. 96-1

AN ORDINANCE TO ADOPT BY REFERENCE THE AMENDMENTS TO THE PINCONNING TOWNSHIP ZONING ORDINANCE REGULATING THE DEVELOPMENT AND USE OF LAND HAS BEEN ADOPTED BY THE TOWNSHIP BOARD OF TRUSTEES, THE TOWNSHIP OF PINCONNING, COUNTY OF BAY, STATE OF MICHIGAN.

SECTION I

PINCONNING TOWNSHIP ZONING ORDINANCES OFFICIAL COPIES OF WHICH ARE ON FILE IN THE OFFICE OF THE TOWNSHIP CLERK, PINCONNING TOWNSHIP HALL AND PINCONNING BRANCH LIBRARY IS HEREBY ADOPTED BY REFERENCE AS PART OF THIS ORDINANCE. EACH AND ALL OF THE REGULATIONS, PROVISIONS, PENALTIES, CONDITIONS, APPENDICES AND TERMS THEREOF, EXCEPT AS MAY HEREAFTER BE AMENDED, SHALL BE DEEMED ADOPTED AND MADE A PART HEREOF BY THIS REFERENCE AS IF FULLY SET FORTH IN THIS ORDINANCE

SECTION II

SHOULD ANY PART OF THIS ORDINANCE ADOPTED HEREBY BE DECLARED UNCONSTITUTIONAL, ILLEGAL, OR OF NO FORCE AND EFFECT BY A COURT OF COMPETENT JURISDICTION, SUCH PORTION THEREOF SHALL NOT BE DEEMED TO AFFECT THE VALIDITY OF ANY OTHER PART OR PORTION THEREOF.

SECTION III

ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT WITH ANY OF THE PROVISIONS CONTAINED HEREIN ARE HEREBY REPEALED AND SHALL BE NO FURTHER FORCE OR EFFECT ON THE EFFECTIVE DATE OF THIS ORDINANCE.

SECTION IV

THIS ORDINANCE SHALL TAKE EFFECT THIRTY (30) DAYS FROM DATE OF PUBLICATION, AND A CERTIFIED COPY OF THIS ORDINANCE SHALL BE EFFECTIVE AFTER LEGAL PUBLICATION AND IN ACCORDANCE WITH PROVISIONS OF PUBLIC ACT 184 OF 1943.

SECTION I

PINCONNING TOWNSHIP ZONING ORDINANCES, OFFICIAL COPIES OF WHICH ARE ON FILE IN THE OFFICE OF THE TOWNSHIP CLERK, PINCONNING TOWNSHIP HALL AND PINCONNING BRANCH LIBRARY, IS HEREBY ADOPTED BY REFERENCE AS PART OF THIS ORDINANCE. EACH AND ALL OF THE REGULATIONS, PROVISIONS, PENALTIES, CONDITIONS, APPENDICES AND TERMS THEREOF, EXCEPT AS MAY HEREAFTER BE AMENDED, SHALL BE DEEMED ADOPTED AND MADE A PART HEREOF BY THIS REFERENCE AS IF FULLY SET FORTH IN THIS ORDINANCE.

SECTION II

SHOULD ANY PART OF THIS ORDINANCE ADOPTED HEREBY BE DECLARED UNCONSTITUTIONAL, ILLEGAL, OR OF NO FORCE AND EFFECT BY A COURT OF COMPETENT JURISDICTION, SUCH PORTION THEREOF SHALL NOT BE DEEMED TO AFFECT THE VALIDITY OF ANY OTHER PART OR PORTION THEREOF.

SECTION III

ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT WITH ANY OF THE PROVISIONS CONTAINED HEREIN ARE HEREBY REPEALED AND SHALL BE NO FURTHER IN FORCE OR EFFECT ON THE EFFECTIVE DATE OF THIS ORDINANCE.

SECTION IV

THIS ORDINANCE SHALL TAKE EFFECT THIRTY (30) DAYS FROM DATE OF PUBLICATION AND A CERTIFIED COPY OF THIS ORDINANCE SHALL BE EFFECTIVE AFTER LEGAL PUBLICATION AND ACCORDANCE WITH PROVISIONS OF PUBLIC ACT 184 OF 1943.

SECTION V

A COPY OF THIS ORDINANCE SHALL BE PUBLISHED IN A NEWSPAPER CIRCULATED WITHIN THE TOWNSHIP OF PINCONNING, BAY COUNTY, MICHIGAN, WITHIN TEN (10) DAYS FOLLOWING THE ADOPTION THEREOF.
