**RESOLUTION**

**BY: PINCONNING TOWNSHIP BOARD**

**RE: COMPLIANCE WITH PUBLIC ACTS 167 AND 168 OF 1993.  
COMPETITIVE BIDDING.**

**WHEREAS**, Public Acts 167 and 168 of 1993 require sealed competitive bidding for contracts of \$20,000.00 or more, except for contracts for professional services or emergency repairs or services pursuant to a written policy adopted or approved by the township board and

**WHEREAS**, the requirement also does not apply to intergovernmental contracts and

**WHEREAS**, without such a policy, a local unit of government is not eligible for income tax and single business tax revenue sharing payments.

**WHEREAS**, the requirement does not affect eligibility for state shared revenues derived from sales tax revenue.

**BE IT RESOLVED**, that the Pinconning Township Board shall solicit sealed bids for all contracts for which the township board anticipates a total township obligation of \$20,000.00 or more. The requirement for sealed bids shall not apply to intergovernmental contracts, contracts for professional services or emergency repairs. At such time as the solicitation of bids is authorized by the township board, the board shall determine if the authority to award a bid shall be delegated to a named official, or if the board reserves to itself the authority to award the bid, also

**BE IT RESOLVED**, that sealed bids shall be submitted to the township clerk/purchasing director/other by a date and time specified and shall be marked on outside "sealed bid for\_(indicate goods or services)\_. The township clerk and one department head/supervisor shall publicly open all bids submitted at the date and time indicated on the request for bids. All bidders shall be notified of the contract award in a timely manner.and

LET IT BE RESOLVED, all request for bids shall include a statement that the Pinconning Township Board reserves the right to accept or reject any or all bids, to waive informalities or errors in the bidding process and accept any bid deemed to be in the best interest of the township, including bids that are not for the lowest amount.
