


**PINCONNING TOWNSHIP, MICHIGAN
RESOLUTION TO ADOPT FEE SCHEDULE UNDER THE
PINCONNING TOWNSHIP COST RECOVERY ORDINANCE
Resolution: # 24-02**

At a regular meeting of the Pinconning Township Board held in the Township Hall on the 13th day of May 2024 at 7:00PM,

The following resolution was offered by Machele Faith
and supported by Dennis Whitney:

WHEREAS, MCL 41.806a expressly gives Pinconning Township the authority to pass an ordinance allowing the Township to collect fees for providing emergency services; and

WHEREAS, the Township adopted a Cost Recovery Ordinance (“the Ordinance”) allowing the Township Board by resolution to set fees for emergency services provided within the Township limits; and

WHEREAS, the Township Board has considered reasonable charges that are intended to cover the costs of providing emergency services.

NOW, THEREFORE, the Township Board of Pinconning Township adopts the following fee schedule under its Cost Recovery Ordinance to cover the costs of providing emergency services:

Section 1: Schedule of Fees. The Township hereby adopts the following Schedule of Fees under the Pinconning Township Cost Recovery Ordinance:

Fire Protection Emergency Services

Hourly Rates for Pinconning Fraser Fire Department Equipment & Vehicles

Engine 16	\$350.00 / hour
Engine 15	\$350.00 / hour
Tanker Pumper	\$400.00 / hour
North Aerial	\$800.00 / hour
Rescue 15	\$250.00 / hour
Rescue 16	\$250.00 / hour
Brush Trucks.....	\$250.00 / hour
Mule	\$200.00 / hour

All vehicles utilized will be charged for a minimum of one hour, and all use beyond one hour will be rounded up to the next full hour.

All Electrical Vehicle Response with Use of EV Blanket\$2,000.00/each

All other fire protection emergency services, including, but not limited to, vehicle extrications, responses to motor vehicle or automobile accidents, or responses to illegal burnings or discharges of hazardous materials Flat Fee of \$150.00.

A person or entity that has billed fees under the Cost Recovery Ordinance that are more than 30 days past due must pay a Late Notice Fee of \$10.00 per each 30 days a fee under the Cost Recovery Ordinance is past due.

If a person or entity has a fee under the Cost Recovery Ordinance that is over 90 days past due, they must pay a \$50.00 fee in addition to the above Late Notice Fee to, in-part, compensate the Township to take lawful actions to collect unpaid fees. This fee does not waive the Township's ability to recoup attorney's fees or other costs associated with recouping overdue fees.

*****Fees imposed must be itemized.***

Section 2: Validity and Severability. The provisions of this Resolution are hereby declared to be severable.

Section 3: Repeal. All prior resolutions and parts of prior resolutions insofar as they conflict with the provisions of this Resolution are hereby rescinded.

Section 4: Effective Date. This Resolution shall take effect immediately upon adoption.


