RESOLUTION NO. 10-67

SPECIAL ASSESSMENT RESOLUTION NO. 2

DETERMINATION TO MAKE PUBLIC IMPROVEMENTS; SUFFICIENCY OF PETITIONS; APPROVAL OF PLANS AND ESTIMATE OF COSTS; FINAL DETERMINATION OF SPECIAL ASSESSMENT DISTRICT; PREPARATION OF SPECIAL ASSESSMENT ROLL

WHEREAS, the Township Board of the Township of Pinconning (the "Township"), pursuant to Act 188 of the Public Acts of Michigan of 1954, as amended ("Act 188"), has tentatively declared its intention to proceed on its own determination to make certain public improvements consisting of the acquisition, construction, and financing of an extension of the Township's water system and related appurtenances thereto (the "Improvements") to serve the proposed Water Special Assessment District No. 10 (the "District"), in the Township; and

WHEREAS, after notice duly given by publication on September 1 and September 8, 2010, in the *Pinconning Journal*, and by first class mail on or before September 3, 2010, pursuant to Act 188, the Township Board held a public hearing on September 15, 2010, at the Township Hall in the Township; and

WHEREAS, at said public hearing the Township Board heard and considered objections to the petitions filed, to the proposed Improvements and to all other matters relating to said Improvements.

NOW, THEREFORE, BE IT HEREBY RESOLVED AS FOLLOWS:

- 1. The Township Board hereby determines that it is necessary and in the best interests of the Township to make and complete the Improvements in accordance with the provisions of Act 188.
- 2. The term of the District shall extend for a period of 30 years from the date of this resolution.
- 3. The plans for the Improvements and the estimate of cost in the amount of Six Hundred Ninety-nine Thousand Five Hundred and no/100 Dollars (\$699,500), attached hereto as Exhibit A, are hereby approved.
- 4. All or part of the cost of the project, currently estimated in the amount of Six Hundred Ninety-nine Thousand Five Hundred and no/100 Dollars (\$699,500), shall be paid by special assessments assessed within the District against the property located in the District and benefitted by the proposed Improvements.
- 5. The Township Supervisor is hereby directed to make a special assessment roll for the District upon which shall be entered and described all parcels of land to be assessed, the names of the respective record owners of each parcel, if known, and the total amount to be assessed against each parcel of land, which amount shall be the relative portion of the whole sum to be levied against all parcels of land in the District as the benefit of the parcel of land bears to the total benefit to all parcels of land in the District. The special assessment roll shall be prepared and certified by the Supervisor in accordance with the form set forth in Exhibit B attached hereto.

- 6. Said special assessment roll, as made and certified by the Township Supervisor, shall be reported to the Township Board and shall be filed in the office of the Township Clerk.
- 7. All actions heretofore taken by Township officials, employees, and agents with respect to the Improvements and proceedings under Act 188 are hereby ratified and confirmed.

DESCRIPTION OF IMPROVEMENTS

WATER SPECIAL ASSESSMENT DISTRICT NO. 10

This project consists of the installation of approximately 15,800 lineal feet of 12-inch water main and related appurtenances thereto to provide adequate service for fire protection and commercial needs. The water main is proposed to be located on the east side of M-13 from Cody Estey Road to Bay Arenac Road at the north end of Bay County.

The estimated cost of the project is:

Engineering, stake-out, observation, contract administration	\$ 84,000
Township Administrative/Publication Costs	\$ 3,280
Legal fees for issuance of special assessment bonds	\$ 4,000

expenses for filing and registration fees)	
Legal fees for special assessment proceedings	\$ 4,500
Total Estimated Costs	\$669,500

All or part of this cost shall be spread by special assessment against properties located in Water Special Assessment District No. 10.
