

**PINCONNING TOWNSHIP
RESOLUTION ALLOWING THE TOWNSHIP TO GRANT TEMPORARY
MARIHUANA EVENT PERMITS**

RESOLUTION NO. 19-04

At a regular meeting of the township Board of Pinconning Township, Bay County, Michigan, held at the Pinconning Township Hall on September 25, 2019 at 10:00 a.m.

PRESENT: Whitney, Beck, Hribek, Switek, Stalsberg

ABSENT: None

The following resolution was offered by Whitney and supported by Beck:

WHEREAS, Pinconning Township, through its Township Board, adopted Ordinance No. 18-02, as amended, (the “Recreational Marihuana Establishments Ordinance”) implementing the Michigan Regulation and Taxation of Marihuana Act, Initiated Law 1 of 2018 (“the MRTMA”); and

WHEREAS, on July 2, 2019 the Marihuana Regulatory Agency and the Department have adopted and filed Emergency Rules with the Secretary of State for the purpose of implementing the Act; and

WHEREAS, the Emergency Rules created new special licenses, including Temporary Marihuana Event licenses; and

WHEREAS, Pinconning Township, through its Township Board, amended the Recreational Marihuana Establishments Ordinance to allow the Township to issue Permits for Temporary Marihuana Events as Marihuana Establishments and authorized the Township to collect annual fees as determined by Resolution of the Township Board; and

WHEREAS, under MRTMA the Township may charge an annual fee of not more than \$5,000 for each permitted Marihuana Establishment, including Temporary Marihuana Event Establishments.

NOW, THEREFORE, BE IT RESOLVED by the Township Board of Pinconning, Bay County, Michigan, as follows:

1. An application for a Temporary Marihuana Event Permit shall be accompanied by a \$500 fee for each day of the scheduled event to cover the Township’s application, administrative, and enforcement costs associated with the event.
2. An application for a Temporary Marihuana Event shall be accompanied by an additional \$500 fee for each licensee authorized to operate at the event to cover the Township’s application, administrative, and enforcement costs associated with the event.
3. If a licensee scheduled to attend an event withdraws from the event prior to the first day of the event, the Marihuana Event Organizer may request a refund of that portion of the fees actually paid to the Township to cover the enforcement costs for that licensee.
4. A Temporary Marihuana Event shall be considered a Permitted Premises for each type or class of Marihuana Establishment authorized to operate at the event under the Pinconning Township Ordinances.
5. The fees collected for one Temporary Marihuana Event Permit shall not exceed \$5,000.


