RESOLUTION # 01-09A

WHEREAS, Pinconning Township recognizes two separate Water Districts within the township boundaries and

WHEREAS, the 2001 waterline construction is under a special assessment district and the Township acknowledges the differences in financing of the two systems hereby

LET IT BE KNOWN the that District # 1 will be the waterline constructed in 1977/1987 along Shore Rd, Maloney Rd, Waibel Rd, Mt Forest Rd, North Saginaw Bay Shore Rd, Lakeside Drive, East end of Cody Estey Rd west to 2366 Cody Estey Rd. and to include Two Mile Rd waterline constructed in 1991. (Note: these are the existing customers of the Township of Pinconning or known as District #1) also hereby

LET IT BE KNOWN due to an agreement with the City of Pinconning signed on 2/04/2000 the City will turn over all Pinconning Township residents that were known as non- city customers to the township once all terms of the agreement are met. These customers will be part of District # 1. The majority of customers are located on South M-13, East Pinconning Rd, Hunter Rd. Second St, portion of Water St and Whyte St. and

WHEREAS the rate schedule for District # 1 , direct and indirect connection fees and tap in fees will be as follows:

WHEREAS, a special assessment district was created in 2001 for the purpose of constructing waterlines in the following areas. Townline 16, Kaiser Rd, Tower Beach Rd., Lapan Rd. North Two Mile, Cody Estey from to 2366 Cody Estey Rd. To Mackinaw Rd., Water St., M-13 North to Cody Estey Rd, Pinconning Rd to I-75, Garden Acres Sub-division, Fenton Sub-division, Riverview Sub-division, Sunset View Sub-division and the parcel located in Pinconning Township (Section 22) on Fourth St. and Third St.hereby

LET IT BE KNOWN this area described will be known as District #2 under a special assessment of 302 taps at \$4,559.60 for 40 years at 5.75% interest. and

WHEREAS the rate schedule for any new connections that were not part of the special assessment in **District # 2** the following fees will be:

Direct Connection fee	\$4,600.00 paid to Pinconning Township
Tap in Fee:	Cost charged by West Bay County for Tap, Meter and Inspection.
Indirect connection fees	\$2,400.00 per connection, paid to the Township of Pinconning.

Capital Improvement & Debt Retirement for **District #1 & District # 2** will be follows:

Quarterly Charge:	1" Line	\$ 20.00 per Quarter
	2" Line	\$ 30.00 per Quarter
	3" Line	\$ 40.00 per Quarter
	4" Line	\$ 50.00 per Quarter
	5" Line	\$ 60.00 per Quarter
	6" Line	\$ 70.00 per Quarter
	7" Line	\$ 80.00 per Quarter
	8" Line	\$ 90.00 per Quarter

Note: any larger line the rate will be determined by the Township Board.

Water Rate: \$3.85 per 1000 gallons, \$ 5.66 for ready to serve charge and a minium usage charge for 3000 gallons per quarter.

NOTE: Indirect cost is when a person or developer subdivides a parcel of property into (3) or more lots or parcels and pays the cost of extending the waterline to new lots or parcels.

WHEREAS, any future extensions will be the same rates as new customers in **District #2** unless a special assessment district is created for extensions or the Township Board of Trustees changes the rates to cover any additional cost that is incurred for maintenance or construction and

WHEREAS, this resolution has been presented to the Pinconning Township of Trustee hereby

LET IT BE RESOLVED that at a special meeting held on JUNE 12, 2001 the Township of Pinconning Board of Trustees adopted the rates presented in this resolution for all water customers of **District #1 & District #2**.
