FAIR SUMMARY OF ORDINANCE 2019-OR-04

This is to give notice that the Riverdale Park Town Council has introduced and intends to take action on Ordinance 2019-OR-04.

Ordinance 2019-OR-04 would approve a certain Purchase Agreement with Werrlein Properties, LLC, for the sale of certain property at 4603 East-West Highway in the Town of Riverdale Park; determine that such property as described in the Purchase Agreement is not needed for public use and authorize the conveyance of such property pursuant to such Purchase Agreement; and all matters generally related to the disposition of certain Town-owned property.

Ordinance 2019-OR-04 is available for inspection by the public at Town Hall during normal business hours, 8:30 a.m. to 4:30 p.m., Monday through Friday.

Mayor's Report

Mayor Alan K. Thompson

It is May, a fantastic month. It starts with spring in full glory, with cool nights and warm, pollen-filled days. At the end of the month we have Memorial Day Weekend, which starts summer! I hope that we have a big turnout at the Veteran's Monument on Memorial Day — check the calendar for the schedule!

Town Budget

The Finance Committee held two public hearings on the budget during the first half of April. Staff had spent weeks preparing the detailed, 300-page document, and the quality of the preparation showed. While we on the Council and some members of the public asked a lot of clarifying questions about expenditures and revenues, almost no changes were requested. We had additional discussion of the budget at the April 29 work session, and expect to formally introduce it at the May 6 legislative session (with adoption later in May). At the time I am writing this, we have managed to hold the tax rate flat, and with a reorganization (keeping a command position unfilled and eliminating a civilian position) will be able to have three additional police officers on the street, as has been requested by many town residents.

New Assistant Chief of Police

On April 3, I was pleased to swear in Rosa Guixens as Riverdale Park's Assistant Chief of Police. Assistant

Chief Guixens was born in Puerto Rico and has served in the command staff of the Prince George's County Police for many years, most recently in the District 1 (Hyattsville) Station. I look forward to working with Assistant Chief Guixens in the years ahead!

Town Elections

Town elections are scheduled for May 6, from 7 am to 8 pm, with all Council positions (Ward representatives and the Mayor) on the ballot. I encourage all eligible voters in town to come to the polls and help choose the next Council and Mayor. Candidates for each position are listed on the front page of this Town Crier.

Purple Line Construction

I typically only get a few weeks (at best) of advance notice on Purple Line activities, so it is best to sign up for announcements directly from https://www.purplelinemd.com/construction/. The schedule for the closing of the Campus Drive underpass (under the Metro/railroad tracks near the College Park metro station) is still anyone's guess at this point. The one part of the project that seems to still be on schedule is the widening of the underpass where East-West Highway goes under the Baltimore-Washington Parkway – they are currently thinking the transition to a temporary bridge will happen the weekend of May 18. There are a lot of lane closures for River Road, Kenilworth Avenue, and East-West Highway planned over the next month. Ward 2 Report

Field of Dreams

On March 23rd, we held a feedback session on the concepts that the Neighborhood Design Center proposed for the park space at the Field of Dreams. The "lazy meadow" concept or Concept 1 had the most support and seems to be the basis of any future design. The feedback form is located on the website and really helps show the ideas that the participating individuals had. Some of the major concerns involved water drainage issues on the site and the general topography of the landscape. These are two issues that will be dealt with early on in the process. Other concerns were with lighting, sight lines, shade spaces, and the features that we would like to see in this "lazy meadow" park. Another discussion point revolved around involving local expertise and the University of Maryland in order to help best equip the park with the amenities discussed at the meeting. The local participation in the creation of the park was one of the highlights for me as an elected official. It was a fantastic meeting and I am tremendously excited to see the early work start in this park over the next year.

Denizen's Brewing Company

I was able to participate in a ceremony with Denizen's Brewing Company where we awarded them a \$5000 dollar grant from the Town's newly created business development fund. They were incredibly appreciative of the Town's willingness to assist financially with their new facility in Riverdale Park Station. They commented that it was the first grant money they have received from any municipality where they have opened and they were excited to "come grow with us" here in Riverdale Park. We need to continue to support the Town's Business Development Grant Programs for exactly this reason. It is an incredible opportunity to foster a positive relationship between the business community and the town and increases the likelihood of drawing better and more unique businesses into our wonderful town. Look for a "spring opening" from Denizens at Riverdale Park Brewing. I hope to see you there!

Department of Public Works

As I was driving to the school I work at the other day, I noticed cars veering around a tree that had fallen in the northbound lane of Taylor Road. I pulled over and emailed town staff at 6am to notify them about the disturbance. By 8am, I had received a confirmation

email that the fallen tree debris had already been cleaned up and our roadways restored to normal driving conditions. I just wanted to say a huge "thank you" to our Department of Public Works for their amazing responsiveness in what could have been a very dangerous situation for our residents and commuters. Their hard work often goes unnoticed, but over the past year they have been incredible. Thank you DPW!

Budget Hearings

On a final note, I was able to attend our budget hearing that was held at Town Hall on April 13th from 9:30 to 1:30. I want to say thank you to town leadership and staff that have been hard at work on this incredible 306 page document for months and months. We were able to move over \$118,000 dollars in the next fiscal year to Community Improvement Projects (Field of Dreams, Lafayette Bridge Underpass Project, and possible Community Gardens) located within Ward 2. I am incredibly proud of this accomplishment and thank those that helped achieve it. If we make our voices heard we are capable of making the changes that we want to see within our community. Thank you for making your voices heard and thank you for allowing me to find mine.

The goals of a Neighborhood Watch group are to encourage residents to get more involved with reporting crimes, connect with other residents in their community, and engage with the Riverdale Park Police Department to assure that their public safety needs are being met. The Neighborhood Watch program is an important pillar of the Community Policing philosophy of the Riverdale Park Police Department and represents a collaboration between the police and the community that identifies and solves community problems, where all members of the community become active allies in the effort to enhance the safety and quality of neighborhoods.

Everyone living in Riverdale Park deserves to be safe and the Riverdale Park Police Department is committed

to protecting and serving all members of our community.

If you have any public safety concerns, please reach out directly to our Police Department or attend a Chief's Community Advisory Committee (CCAC) meeting (see below). Get Out to Vote!

If you are not registered to vote anywhere else in the United States, you may be eligible for the Town's Supplemental Voter Registry. Please see below for more information.

WHAT ARE THE REQUIREMENTS FOR THE TOWN'S SUPPLEMENTAL VOTER REGISTRY?

If you have, or will have, the Town of Riverdale Park as your primary residence, for at least forty-five (45) days immediately prior to May 6, 2019 (March 22, 2019 to May 5, 2019); are at least 16 years old; do not claim the right to vote elsewhere in the United States; and have not been found by a court to be unable to communicate a desire to vote; you can register to vote by using the Town of Riverdale Park Supplemental Voter Registry Voter Registration Form. Registration Forms are available on the Town's website www.riverdaleparkmd.gov or at Town Hall.

WHAT FORMS OF IDENTIFICATION AND PROOF OF RESIDENCE WILL BE ACCEPTED FOR THE SUPPLEMENTAL VOTER REGISTRY?

 An identification card issued by a federal, state, or local government entity of the United States or any foreign country or school provided that the

- identification document contains the applicant's name and date of birth; **AND**
- A document that establishes your current residence in the Town of Riverdale Park if not already established by (1.) above. Examples include a copy of house or apartment lease, utility bill, paycheck, bank statement, school record, or other document that shows your legal name and current address in the Town of Riverdale Park.

CAN I REGISTER TO VOTE ON THE DAY OF ELECTION? Yes, all residents who meet the requirements listed above may register to vote on the day of the election.

Neighborhood Services Frequently Asked Questions

I want to build something on my property, do I need a Town building permit?

In most cases, yes. If you are planning to build a fence, driveway, garage, or anything that will require a building permit from Prince George's County, you will also need to obtain a building permit from the Town. To contact Prince George's County Department of Permitting, Inspections, and Enforcement, call (301) 883-5900 or visit

https://www.princegeorgescountymd.gov/1024/Permitt ing-Inspections-and-Enforcement.

Town permits are also required for storage receptacles (PODS) and dumpsters. Who should I call to report a concern regarding an animal?

To report a missing, vicious, injured, or deceased animal, please call the Prince George's County Animal Services Division at 301-780-7200. You will need the following information when you call:

Name, address, phone number (this information will be kept confidential)

- Address where the animal was last seen
- Animal's physical condition
- Color of animal
- Type of animal

I have a concern about a property in my neighborhood, what should I do?

If you have concerns regarding a property in your neighborhood, please contact Neighborhood Services. One of the primary duties of the Neighborhood Services team is to educate residents about the Town's community standards. In most cases residents simply do not know that they are not meeting the Town's community standards as defined in the Town Code. In some cases, another community partner such as Prince George's County, may be needed to address your concerns. Information about the Town's community standards can be found on the Town's website, www.riverdaleparkmd.gov, under Town Code and TRP's Vision and Commitment Statements.

Community Spring Clean Up

The annual Community Spring Clean Up will be held on Saturday, May 18th. Residents are offered the opportunity to put their yard waste/bulk trash items on the curb on Friday, May 17th for pick-up on Saturday, May 18th. This event replaces the May Saturday Bulk Trash Drop-off, normally held on the third Saturday of each month. The Public Works facility will NOT be open for drop-off of any bulk trash items on Saturday, May 18th. Please note that all items must be curbside no later than 8:00 a.m.

The following items are <u>not</u> eligible for pick-up:

- Remodeling lumber, flooring material, plaster, plasterboard, and interior tile
- Fencing material or poles
- Air conditioners, refrigerators, and freezers
- Lawnmowers or other gas-powered tools
- Automobile major components
- Tires
- Dirt, stone, gravel, and sod
- Concrete blocks and bricks, cement
- Antifreeze and/or oil
- Glass, windows, door panels, fish tanks
- Paint
- Hazardous materials and/or chemicals



May is Building Safety Month Building Codes Save Lives

Building Safety Month is an annual, global event presented by the International Code Council (ICC), its members and partners celebrating the importance of building safety, current safety codes and the role of code officials in ensuring safe structures. This year is the 39th anniversary of Building Safety Month.

Pedestrian and Traffic Safety Initiative

Look Up. Look Out. Stay alert, walk smart and drive smart. The Town of Riverdale Park proudly partners in promoting Maryland's pedestrian safety campaign which includes both drivers and pedestrians, because pedestrian safety is a two-way street. Pedestrian safety is an issue that affects our entire community; young and senior, drivers and walkers, in the day and at night. On average, more than 100 pedestrians are killed each year in Maryland. Most of the incidents are preventable.

The Look Up, Look Out campaign reminds drivers and pedestrian to stay alert, and follow the rules of the road and traffic laws. Following are some simple yet effective measures to keep our pedestrians safe:

For pedestrians:

- Use sidewalks and marked crosswalks whenever possible.
- Press the pedestrian signal button and wait for the walk signal.
- Always stop at the curb and look left, right and left before crossing a street.
- Watch for cars turning in or leaving driveways.

- Wear light or bright colored clothing.
- Stay visible at night.
- Pay attention and take off headphones while walking – no texting or playing games.

For drivers:

- Stay alert.
- Always stop for pedestrians.
- Follow traffic signs, signals and markings.
- Don't run red lights.
- Observe posted speed limits. Speeding only makes it more difficult to stop for pedestrians.
- Keep your eyes on the road. It's illegal to use a handheld phone/device or text while driving.

The Riverdale Park Police Department proactively enforces Maryland's traffic safety laws. It's not about the ticket, it's about saving live. Remember, Traffic Safety is Public Safety!


