### **Mayor's Report**

2019 has passed, and a new year has begun. While the days are slowly getting longer, the nights have gotten dark as the holiday decorations have been taken down and put into storage. With the beginning of the year, I'm looking forward to spring and making plans and resolutions for the year ahead.

#### **Holiday Events**

Before giving a final farewell to 2019, I'd like to thank everyone who contributed to the success of the many holiday events that went on in town. I enjoyed the food, drinks, music, and shopping at the Holiday Market (and Festival of Lights), and heard reports that the Children's Holiday Party and Senior Luncheon went well too! As always, I enjoyed seeing Santa on Christmas Eve as he rode around town on one of the Riverdale Volunteer Fire Department's trucks. I was extremely happy that the Town was able to provide holiday baskets and similar programs for dozens of families in need during the holiday season.

#### Trash Pickup

Town staff has been collecting data about the issues residents have experienced with trash, yard waste, and recycling pickup, and provided the information from the last few months to the Town Council. To facilitate further collection of this data, you can now file complaints on the Town's web site at http://www.riverdaleparkmd.info/how\_do\_i /trash\_concerns/index.php, or you can call Town Hall and they will enter it into the same system for you.

We are using this information for a couple of reasons. (1) To inform us about how (and whether) to negotiate future contracts with the current contractor, and (2) To determine whether, by the terms of the current contract, the town will withhold payment to the contractor for poor performance. The contractor is provided opportunities to correct issues once informed, and staff must verify that there is not a legitimate reason for reported issues (such as placing items at the curb later than required). We have seen improving performance in many areas since starting in late summer, but other areas still need attention. I encourage all residents to report issues so that we can continue working with the contractor to ensure that the level of service meets your expectations.

#### **Purple Line Construction**

I typically only get a few weeks (at best) of advance notice on Purple Line activities, so it is best to sign up for announcements directly from https://www.purplelinemd.com/construction /. There is nothing new (continued construction including temporary lane closures all along the path of the project through town), but I wanted to remind everyone that bridge ramp construction will make enough progress in the next 1-2 months that turns across Kenilworth into/out of Quesada and Quintana will no longer be allowed. The Town Council will need to remove the one-way restriction on 54<sup>th</sup> between Quintana and Quesada to allow drivers to enter and exit the neighborhood via the shopping center parking lot. ## Kaiser-Permanente Foundation Place-Based Initiative

As I mentioned in December, Kaiser Permanente (KP) is working on a Community Health initiative to

benefit residents in County Council District 3 (Dannielle Glaros' district). KP is working with the Central Kenilworth Avenue Revitalization Community Development Corporation (CKAR) to promote a broader vision for the health of our community, which includes making schools a hub for community health initiatives, strengthening non-profit institutions in our community, providing economic opportunity through support for small businesses, fostering entrepreneurs, providing tactical workforce development, effectively addressing affordable housing, and increasing financial literacy. January had two more focused visioning meetings, and February will start the next phase of the project, during which KP Foundation will determine which organizations will help implement the vision with financial and logistical support from KP. CKAR will coordinate with KP Foundation to host a Town Hall meeting to wrap up this phase of the project. Keep an eye on the CKAR-CDC web site, the Town's web site, and the Town's social media outlets for dates, places, and times for these events.

### Ward 2 Report

#### **New Legislation**

Recently, the Prince Georges County Council unanimously passed legislation concerning how our county police will interact with residents who have committed the civil offense of coming into the United States (U.S.) or remaining in the U.S. in violation of federal immigration policy. Prior to the legislation, the county police were operating under policy guidelines that were substantially similar to the new legislation. Codifying policies that limit officers from assisting the U.S. Department of Immigration and Customs Enforcement with the enforcement of civil immigration laws sends an important message to our immigrant communities and assists local law enforcement in establishing positive relationships with these communities. Similar legislation has passed in Brentwood, Cheverly, Colmar Manor, Edmonston, Forest Heights, Greenbelt, Mt. Rainier, and Hyattsville. I plan to propose similar legislation for Riverdale Park. Like, the county police, the Town's Police Department currently operates under a similar policy. Codifying such a policy reinforces not only our commitment to the immigrant communities

but also makes clear that the Town values diversity and inclusion. My goal is to have legislation introduced within the next two months. I look forward to input from the community.

#### **Centennial Trees**

I feel that a great gift we could provide to our community during its centennial celebration is the planting of appropriate native trees in available spaces all throughout Riverdale Park. I would love to see our tree planting program grow by leaps and bounds over the next couple of years. I have suggested that the town bring in an arborist to find 100 areas throughout town to plant trees for Arbor Day as we prepare to celebrate our Centennial birthday.

#### **Centennial Celebration**

Make sure to mark your calendars for June 13<sup>th</sup>, 2020 for our centennial celebration. It also happens to coincide with the 2<sup>nd</sup> annual Trolley Trail Day. We envision a festive event that will feature local performers, arts vendors, local food vendors, and music. ## Ward 3 Report

Council Member David Lingua

The Central Kenilworth Avenue Revitalization CDC received good news to close out the year 2019 and begin 2020. CKAR is the recipient of several grants, totaling over \$330,00.00. They are as follows:

• A grant of \$40 thousand from Prince George's County will support programs and operations;

- A grant of \$25 thousand from the Wells Fargo Bank's Neighborhood Lift Grant Program will support the Guest Chef Program at the Sarvis Empowerment Cafe;
- A grant of \$ 90 thousand towards planning from the Kaiser Foundation Health Plan of the Mid-Atlantic States Community Health Program. The grant will fund the three awarded Host Site CCMA AmeriCorps VISTA positions for Health & Wellness, Workforce Training & Development, and Affordable Housing;
- A grant of \$75 thousand from the Redevelopment Authority of Prince George's County towards capital improvements for the Sarvis Empowerment Cafe;
- A grant of \$100 thousand from the Maryland Department of Housing and Community Development (MD DHCD) FY2019 National Capital Strategic Economic Development Fund towards infrastructure utility ad HVAC upgrades as well as interior and exterior rehabilitation;
- A grant of \$2016.00 from the Town of Riverdale Park for the reimbursement of permit fees.

While the preceding is welcomed news, CKAR was not awarded grant funding totaling over \$337 thousand going towards operational support (\$200k), capital funding (\$50k), technical support for the Capital Campaign for and the operations of the Sarvis Empowerment Cafe (\$37+k), and tax credits to leverage donations to the cafe's programing (\$50k). To add to this, CKAR has learned recently of its need to install a new doublewalled kitchen flu, eight stories upwards, with an estimated cost of \$42 thousand.

Executive Director Patricia Hayes-Parker has reached out to the state delegation about sponsoring a bond bill to help with the build-out and other funding needs. What helps a request like this is the demonstrated support to date; both from the county as well as the municipality. Thanks to the substantive efforts of County Councilmember Glaros and the long-term nominal and recently added creative efforts by this municipality, the state delegation would see such support. What helps greatly towards an award of such funding, selected over other submitted bills from around the state, is the demonstration of individual support by area residents in the form of donations. Of consideration here is the number of people donating, more so than the total amount donated. This is the strength in numbers which helps with funding requests being awarded; where George, Abe, even Alexander, can mean a great deal.

Previous reports have highlighted the efforts CKAR has made to date; be that the Edmonston Road Rain Garden, the Greater Riverdale Empowerment Center, or the Sarvis Empowerment Cafe. The empowerment cafe is the most ambitious physical project to date. As stated previously, the learning cafe can bring opportunity as well as amenity to area residents. To do so requires the support of many, including ourselves individually. As well, the time to do so is upon us. Please, donate, at sarviscafe.org.

## **Neighborhood Services**

If you have concerns regarding a property in your neighborhood, please contact Neighborhood Services. One of the primary duties of the Neighborhood Services team is to educate residents about the Town's community standards. In most cases residents simply do not know that they are not meeting the Town's community standards as defined in the Town Code. In some cases, another community partner such as Prince George's County, may be needed to address your concerns. ## **Collection Reminders**

#### **Residential Trash**

Residential trash should be placed in durable, leak proof bags <u>before</u> it is placed in cans. Be sure that the can's lid is tightly closed to keep rainwater out- this will help to reduce spillage. Excess trash should be placed beside your container.

Trash cans should be curbside by **6:00 a.m.** on **Mondays and Thursdays** or the night before collection.

#### Yard Waste

Do NOT mix yard waste with household trash. Yard waste must be placed in paper bags or in reusable bins marked as yard waste.



Branches and limbs need to

be bundled with rope or string (do not use wire), additionally all branches, limbs, and bundles must be:

- less than 4 feet long,
- $\circ$  less than 3 inches in diameter
- o weigh less than 60 pounds

Yard Waste should be curbside by **6:00 a.m**. on **Mondays** or the night before collection.

#### **Bulk Trash**

Bulk trash collection is **by appointment only** on **Wednesdays**. Residents must schedule their collection by 2:00 p.m. on Tuesday by calling 301-773-2069 or by completing a Request Service form online at *www.batestrucking.com*. The Request Service form can be found on Customer Center tab at the top right corner of the Bates website.

Please note that bulk trash collection is limited to three (3) items per week.



#### Recycling

Recycling bins should be curbside by **6:00 a.m**. on **Wednesdays**. As a reminder, no plastic bags are permitted. Curbside recycling is provided by Prince George's County Department of the Environment. Please call 311 or 301-883-4748, if you have any questions or concerns.

## Snow Season – Rules to Remember

The Department of Public Works is gearing up for snow season with a goal to work around the clock as necessary to remove snow and ice quickly and safely. Here are important snow removal facts the Department wants you to remember.

Snow emergency conditions are in effect in the Town of Riverdale Park when Prince George's County, the Maryland State Highway Administration **or** the Maryland State Police declare a **snow emergency**.

When a snow emergency is in effect, please follow these rules:

- Do not park any vehicle on any part of any street with a posted sign that says Snow Emergency Street;
- ✓ Only park on the even-numbered side of non-Snow Emergency Streets (parking on the <u>odd-</u><u>numbered side of any public street</u> is prohibited during a snow emergency, except if parking is already restricted on one side of the street).
- ✓ Move your car(s) off the street so that snowplows can remove the snow from the street from curb to curb.

 ✓ Clear sidewalks in front of your house and, please, <u>do not</u> shovel snow into the roadway.

Be patient during a snow emergency as crews work around the clock to clear your street and nearby public spaces.

Remember your vehicle may be removed and impounded by or under the direction of any duly authorized police officer if you violate these rules and you will be charged a towing or impound fee and be liable for a fine of \$250.

Public Works will only plow Town-owned streets. The State or County is responsible for snow and ice removal on the following roadways:

- A Kenilworth Avenue (Route 201)
- Baltimore Avenue (Route 1)
- East-West Highway (Route 410)
- 🚔 Good Luck Road

## Reminders from the Police Department

During the cold winter months, area drivers may be tempted to warm up their cars while they stay warm inside their home or business. However, cars left running, unlocked, and unattended are quick and easy targets for thieves. RPPD offers the following tips so you won't be left out in the cold:

- Never leave your car running or the keys in the ignition when are away from it, even for just a minute.
- When at the gas station pumping gas, never step to the rear of your car, or turn your back on the car doors while leaving your engine running. Thieves have been known to drive off with the pump handle still inserted in the fuel port.
- When visiting your local convenience store for that morning coffee, make sure your car engine is turned off and doors are locked. It takes only seconds to break a window, and thieves know how to do it without making a sound, and without effort
- Be alert when approaching your car, have a plan of action, and have your keys in your hand. Check around, under and in your vehicle for suspicious

individuals. Immediately leave the scene to get help if you have any concerns for your safety.

## **Pedestrian Safety Tips**

#### 1. Watch Your Walkways

Walk on sidewalks and in crosswalks whenever possible. Pay attention to walk signals. Never stand in the street while waiting to cross. Keep a safe distance back on corners as turning trucks and buses



occasionally run up onto sidewalk corners.

## 2. Be Extra Alert in Parking Lots, Filling Stations and Rest Stops

Locations where trucks must back up and navigate tight spaces can be particularly dangerous. Stay out of the way (and out of blind spots).

#### 3. Take Extra Care at Bus Stops

Before crossing in front of a stopped bus, make sure the bus is not about to proceed, and that the driver sees you.
