This is to give notice that the Riverdale Park Town Council has introduced and intends to take action on Ordinance 2023-OR-01, Ordinance 2023-OR-02, and Ordinance 2023-OR-03.

ORDINANCE 2023-OR-01

Ordinance 2023-OR-01 will designate the polling place and hours of operation for the 2023 Town Election to be held on May 1, 2023; designate the type of ballots to be used in that election; and establish the candidate filing deadline and candidate filing fee for the 2023 Town Election to be held on May 1, 2023.

ORDINANCE 2023-OR-02

Ordinance 2023-OR-02 will alter the boundaries of the six wards in the Town of Riverdale Park effective beginning with the Town municipal election to be held on the first Monday in May, 2023; provide for the continuation in office of current Council Members in the wards from which they were elected until a certain time; provide for the repeal of current ward boundaries as of a certain date; and generally relate to the revision of ward boundaries in the Town of Riverdale Park.

ORDINANCE 2023-OR-03

Ordinance 2023-OR-03 will alter the boundaries of the six wards in the Town of Riverdale Park effective beginning with the Town municipal election to be held on the first Monday in May, 2023; provide for the continuation in office of current Council Members in the wards from which they were elected until a certain time; provide for the repeal of current ward boundaries as of a certain date; and generally relate to the revision of ward boundaries in the Town of Riverdale Park.

Mayor Thompson's Message—February 2023

It's a cold, gray day in the middle of January as I write. That being said, I can tell the days are getting longer, and there were only snow flurries today, so it could have been worse. Happy New Year!!!

Helping Out Residents: I often praise the activities of town staff in my reports, but the response to some emergencies in December really showed that town government is working well.

Near the end of the day on December 13, I got a phone call from a resident that the natural gas in one of our multifamily buildings was out, and had been out for many hours. Even though it was near the end of the day, staff jumped into action as soon as I contacted the Town. We worked for several hours with the owner to try to get the issue fixed, but as the evening wore on and temperatures were dropping below freezing, we asked apartment management to provide hotel rooms to their renters. After the town helped the apartment management past an internal difficulty of theirs (the town agreed to cover "incidental expenses" if any occurred) all renters were offered a warm place to sleep in nearby hotels. We also opened up town hall as a warming center, should the residents who chose to stay in their apartments need it in the middle of the night. Natural gas was restored the next day, but staff from all departments worked past midnight to make sure that residents would be OK. I was really proud of our staff, and thank them for serving our residents when they needed it most.

I had hoped that this would be the only emergency before the holidays, but that was not to be the case. A different multifamily building had a partial failure of the heating system on December 22, and the forecast was for temperatures in the single digits the next day. Town staff again carefully monitored the situation and worked to ensure that the heat would be working. Fortunately the building management was able to keep their residents warm during the cold snap.

Last but not least, in October I received an email that a person without housing was living in town. We started trying to connect him with social services provided by the County then, but he had refused assistance. Officers from our police department had been regularly checking in on him to make sure he was OK, but we became quite concerned as the late-December frigid weather approached. He continued to refuse assistance, but officers checked several times a day while temperatures were low. He fortunately got through that weather OK, but I was again proud that our staff stepped up to make sure that even our most vulnerable resident was OK – it shows that we care about all of you.

After these events, we are thinking about amendments to both internal processes and our rental licensing program so there will be detailed plans in place should similar emergencies occur in the future.

COVID-19: The COVID-19 pandemic continues, with just under 3,000 deaths per week nationwide. It is the third highest cause of death in the United States for 2022, and even with the relatively low death rates we have seen recently (compared with last January) it is still killing people at a rate that's around a quarter of the rate of death by cancer (there were approximately 11,500 cancer deaths per week in 2022 in the United States, compared to the 3,000 deaths per week from COVID right now).

Mayor Thompson's Message Continued—February 2023

I said it last month, and dozens (hundreds?) of times before that, and I'll say it again: the evidence continues to

mount that it is a Really Bad Idea to catch COVID, and you should work hard to avoid exposure to the virus, even if you are vaccinated. The impact of Long COVID can be devastating (and is for around 4 % of people infected with COVID), even if the initial infection is mild and you are young and healthy. The US CDC and Maryland Department of Health tell us that vaccination is incredibly helpful at preventing hospitalization (and worse) during the acute phase of the disease (recent studies show that the bivalent vaccines that came out last fall, as expected when they were approved, provide more than 80 % protection against currently-circulating variants). Unfortunately, these vaccines do little to prevent



Long COVID, providing only around 15 % protection. Every little step you take to prevent infection, from wearing one of the N95 masks that the town delivered to you in November while attending an event or shopping, to propping open a door to let in some fresh air at a large indoor gathering, to staying home when you wake up with a scratchy throat, can help to prevent tragedy for yourself (or someone else). Please stay safe. Little measures, if many people practice them, will add up to less sickness and misery in the world.

Development - Apartments: The Legacy Mixed-Use Town Center (LM-UTC) Local Design Review Committee last met in November to review the proposal for "The Lofts", an apartment complex proposed for the southwest corner of Queensbury and Rhode Island Avenue. The committee provided high-level comments (mostly reflecting their desire to preserve the character of the historic commercial core, and not overwhelm nearby properties). We were hoping to hear back from the developer in early January, but they were not ready so they have promised to present a new design at the meeting on February 1. We are also looking forward to hearing back from the developer with a project at the Chamber's site at the corner of and Cleveland Avenue and Madison Street in Ward 1 – stay tuned!

Redistricting: The Redistricting Committee recommended two maps to the town council in late December. The town council will choose the final map and is allowed to adjust the Committee-recommended maps before adoption. A special work session was held on January 17 to finalize proposed maps, and a map will need to be finalized and adopted at the February 6 legislative meeting to have us ready for elections on May 1.

New Businesses in Town: We have a few new businesses in town this month. The first, which began operations on January 5th, is Catalyst Hotdogs, which has taken over the kitchen at Denizen's Brewing in Riverdale Park Station. I haven't been yet but have heard they are great. The second is Manifest Bread in the historic town center, near the train station. I bought some chocolate babka and an Italian savory pastry (I can't remember the name of that one!) – both were delicious! They are selling sandwiches at lunch time and coffee as well as baked goods.

Snow Season - Rules to Remember

The Department of Public Works is prepared for snow season with a goal to work around the clock as necessary to remove snow and ice quickly and safely. Here are important snow removal facts the Department wants you to remember.

Snow emergency conditions are in effect in the Town of Riverdale Park when Prince George's County, the Maryland State Highway Administration **or** the Maryland State Police declare a **snow emergency**.

When a snow emergency is in effect, please follow these rules:

Do not park any vehicle on any part of any street with a posted sign that says **Snow Emergency Street**;

- Only park on the even-numbered side of non-Snow Emergency Streets (parking on the <u>odd-numbered</u> <u>side of any public street</u> is prohibited during a snow emergency, except if parking is already restricted on one side of the street).
- Move your car(s) off the street so that snowplows can remove the snow from the street from curb to curb.
- Clear sidewalks in front of your house and, please, <u>do not</u> shovel snow into the roadway.

Be patient during a snow emergency as crews work around the clock to clear your street and nearby public spaces.

Remember your vehicle may be removed and impounded by or under the direction of any duly authorized police officer if you violate these rules and you will be charged a towing or impound fee and be liable for a fine of \$250.

Public Works will only plow Town-owned streets. The State or County is responsible for snow and ice removal on the following roadways:

- \Rightarrow Kenilworth Avenue (Route 201)
- \Rightarrow Baltimore Avenue (Route 1)
- \Rightarrow East-West Highway (Route 410)
- \Rightarrow Good Luck Road

Calvin Cafritz Enterprises is responsible for snow and ice removal from roadways in Riverdale Park Station.

Senior Call Check

Senior Call Check is a FREE service available to adults 65+ in Maryland. Seniors can receive an automated daily call at a time they designate. After 3 attempts and no answer, the department will contact designated alternates to check on residents. Report Streetlight Outages

Streetlight outages can be quickly and easily reported through the PEPCO website at <u>https://pepco.streetlightoutages.com/</u> or by calling 1-800-735-2258. The online streetlight outage reporting tool is available 24/7.

Emergency Repairs Grant Available

The Town is soliciting grant applications from homeowners and businessowners for the Emergency Repair Grant Program. This grant program is designed to assist with emergency repairs in homes and businesses that would otherwise not be addressed. An "emergency repair" is defined as a situation that is life-threatening or one that prohibits someone from living in decent, safe, and sanitary conditions or is needed for the safe and continual operation of a business.

Successful applicants can be reimbursed for up to \$2,000 after work has been completed and paid for or \$5,000 if the applicant can demonstrate the emergency repair is due to a natural disaster. Applicants that have a household income of no greater than 50% of the Area Median Income can have the matching requirement waived. Grants require a 1:2 match for the first one thousand dollars (\$1,000) and a 1:1 match thereafter. Grants are subject to funding availability

Register to Vote in 2023 Town Election

How do I register to vote?

The Town of Riverdale Park will hold an election on May 1, 2023 to elect a mayor and all councilmanic seats. Residents may register to vote in one of the following ways:

- If you are a U.S. citizen, a Maryland resident, and at least 16 years old; you may register to vote by using the State of Maryland Voter Registration Application found on the Town's website www.riverdaleparkmd.gov; OR
- If you have, or will have, the Town of Riverdale Park as your primary residence, for at least fortyfive (45) days immediately prior to May 1, 2023 (March 17, 2023 to April 30, 2023); are at least 16 years old; do not claim the right to vote elsewhere in the United States; and have not been found by a court to be unable to communicate a desire to vote; register to vote by using the Town of Riverdale Park Supplemental Voter Registry Voter Registration Form found on the Town's website www.riverdaleparkmd.gov.

What forms of identification and proof of residence will be accepted for the supplemental voter registry?

- An identification card issued by a federal, state, or local government entity of the United States or any foreign country or school provided that the identification document contains the applicant's name and date of birth; AND
- A document that establishes your current residence in the Town of Riverdale Park if not already established by (1.) above. Examples include a copy of house or apartment lease, utility bill, paycheck, bank statement, school record, or other document that shows your legal name and current address in the Town of Riverdale Park.

Can I register to vote on the day of the election?

Yes, anyone may register to vote on the day of the election. If you do not have sufficient proof of age and residency, you will need to complete an affidavit in order to vote.

Collection Reminders

Residential Trash: Place residential trash in durable, leak-proof bags before placing it in containers. Close lid tightly to keep rainwater out to reduce spillage. Clean trash can regularly. Place trash can curbside by 6:00 a.m. on Mondays and Thursdays or the night before collection.

Yard Waste: Do NOT mix yard waste with household trash. Place yard waste in paper bags or in reusable bins marked as yard waste. Bundle branches and limbs with rope or string (do not use wire). Bundles must be less than 4 feet long and less than 3 inches in diameter and weigh less than 60 pounds. Place yard waste curbside by 6:00 a.m. on Mondays or the night before collection.

Recycling: As a reminder, NO PLASTIC BAGS ARE PERMITTED. Curbside recycling is provided by Prince George's County Department of the Environment. Please call 311 or 301-883-4748, if you have any questions or concerns about this service. Place recycling bins curbside by 6:00 a.m. on Wednesdays.

Bulk Trash: Collection is by appointment only on Thursdays. Schedule collection by 12:00 p.m. on Wednesdays by calling 240-604-6077 or online at www.jedatruckinginc.com/book-online. Please note that bulk trash collection is limited to three (3) items per week. Set out bulk trash scheduled for pickup by 6 a.m. on Thursday.

Report a Concern: To report a concern, call 301-927-6381 or submit a request online. The Trash Concerns app can be used to order a new trash container, report missed collections and report any other trash-related concerns. Visit www.riverdaleparkmd.gov and click on the Trash Concerns icon.

Disposing of Bamboo: Bamboo should be placed in a trash container or tied together in bundles no longer than 4 feet long and 12 inches across. Bamboo may also be dropped off at the Public Works building on Bulk Trash Drop off Saturday but is limited to a maximum of 15 bundles (4 feet by 12 inches) on a given drop off day.

Bulk Trash Drop off Saturday the Public Works facility takes place on the 3rd Saturday of every month from 9:00 a.m. to 2:00 p.m. The Public Works facility is located at 5012 Queensbury Road.

Honoring Thurgood Marshall

U.S. Senators Ben Cardin and Chris Van Hollen introduced legislation, S.3863, to replace the statue of Roger Brooke Taney, author of the infamous Dred Scott



decision that ruled that African-Americans were not U.S. citizens and that Congress could not prohibit slavery, with a bust of Supreme Court Justice Thurgood Marshall, the first African-American to serve on the nation's highest court.

"Supreme Court Justice Thurgood Marshall is an inspiration, a person who propelled his rise from West Baltimore to the highest court in the country through hard work, intellectual evolution and unwavering morality," said Senator Cardin. "A civil rights icon, Thurgood Marshall argued cases that began to bring down the walls of segregation in his home state and nationwide. Among other landmark cases, his arguments in Murray vs. Pearson led to the desegregation of the University of Maryland School of Law and his arguments in Brown vs. Board of Education led this nation to recognize that the doctrine of 'separate but equal' was antithetical to our ideals of freedom and liberty. I can think of no better person for us to highlight and celebrate in the U.S. Capitol."

Senator Cardin closed out the momentous occasion by stating "as our country continues to grapple with the past and future of civil rights and systemic racism, we should highlight leaders in history that have propelled us towards justice and put an end to the glorification of those who stood in its way. From his neighborhood in Baltimore to the halls of the Supreme Court, Thurgood Marshall worked his entire life to help build civil rights in America from the ground up," said Senator Van Hollen. "Marshall's work is a crucial reminder that we must continue pressing forward. His steadfast legacy should be memorialized in the Halls of Congress and never forgotten."


