#### Mayor's Report

Mayor Alan K. Thompson

It is June, the first month of summer, though local tomatoes, sadly, aren't available yet. This year, it is the month when the new Council takes the oath of office, and, this year, the month where we kick off our Town's centennial celebration!

#### **Town Budget**

The Town's budget for the next fiscal year has passed, with only minimal changes from the budget that was first presented in April by Town Manager Lestitian. This is a very lean budget, focusing on delivery of core services – police, infrastructure maintenance, trash pickup – and the administrative activities that support those services.

#### **Town Elections**

The elections this year were challenging, as they always are. I take the opportunity of elections to get out and talk to people, to find out what we are doing well and where we need to improve. It is a major investment of time to do this, but vitally important to keeping me connected with the issues that residents are concerned about. I do my best every election cycle to let voters know (through my social media presence) where I will be and that I'm out, but I will talk with anyone who I find out in their yard, whether a registered voter or not. If I didn't get to your door (and a case of the flu took me out of campaigning for a few weekends, so I didn't get to a lot of houses I planned to visit) please contact me – my contact information is at the end of this article – and I will be happy to stop by and discuss any concerns.

While campaigning, I took notes of concerns raised by voters, and have added them to my list of next actions. There were a lot of issues raised, and some of them can't be fixed quickly, but feel free to contact me anytime if you want a status update!

Many thanks to everyone who turned out to vote, including the almost 200 people who didn't even have a contested race on the ballot!

#### **Purple Line Construction**

I typically only get a few weeks (at best) of advance notice on Purple Line activities, so it is best to sign up for announcements directly from https://www.purplelinemd.com/construction/. The schedule for the closing of the Campus Drive underpass (under the Metro/railroad tracks near the College Park metro station) is looking like it will be between graduation for the University of Maryland and fall move-in day next summer (2020). The announced plans for the next six months in Riverdale Park are focused on the new bridge over the Anacostia next to the existing River Road bridge, and storm drain activities on Kenilworth Avenue north of East-West highway (you can see for yourself right now that the columns for the aerial bridge at the Riverdale Park – Kenilworth station are being constructed, and that will continue). #### Ward 2 Report

#### May 6<sup>th</sup> Election

I just wanted to take this time to thank everyone that came out to vote in our election on Monday, May 6<sup>th</sup>. I am remarkably humbled by the opportunity that you have given me to be Ward 2's councilmember for a 2<sup>nd</sup> term. We saw an increase of around 50 votes overall from the 2017 election with the majority of them coming from Ward 2. Ward 2 led all wards in voting with 138 overall votes. This was in no small part due to the fact that we had a contested election. Elections are a place for the public sharing of ideas, even if those beliefs don't align with each other. I want to congratulate and thank my opponent Spiro Dimakas for throwing his hat into the proverbial ring. I can speak from experience that it is both challenging and sometimes uncomfortable having your opinions out for public criticism. Knocking on constituents' doors is not the easiest thing to motivate yourself to do. The challenge from Mr. Dimakas made me leave my comfort zone and ultimately made me work harder than I have ever had to getting my ideas and beliefs for Riverdale Park out into the community while simultaneously hearing the thoughts of more constituents than ever before. It was a remarkable learning experience that I will utilize in order to become better at representing the people of Riverdale Park.

#### **PGCPS Facilities Master Plan**

On Tuesday May 14<sup>th</sup>, I was able to attend a public hearing at William Wirt Middle School on the state of the renovations being introduced by the school board. PGCPS is looking at new ways for funding critical infrastructure projects. Critical infrastructure projects have been placed in the school district's "Cycle 1" renovation cycle and include both the new William Wirt Middle School rebuild as well as much needed renovations to our very own Riverdale Elementary. I was there to speak out on behalf of keeping both schools in the Cycle 1 renovations and encouraging that the district put in place necessary funding to move Cycle 1 forward in in the guickest possible timeframe. Please make your voices heard on this matter before the June school board meeting. There has been some suggestion from the entire board that too much of the renovation money is

going to schools in the northern portion of the county. As state Senator Paul Pinsky noted, the reason that the money is coming to northern schools is because the data indicates that's where the most need is. Please communicate with our school board to support that the William Wirt and Riverdale projects maintain their position in the Cycle 1 renovations and that they move forward in a timely fashion. We need to be actively engaged in supporting the education of our young students. These infrastructure projects are a major step in the right directions. #### **Mosquito Control Program**



The Town will once again participate in the Maryland Department of Agriculture's Mosquito Control Program. Spray season began on May 29<sup>th</sup> and is anticipated to end on **September 17**<sup>th</sup>.

Spraying will take place after dark on **Tuesdays** and may continue until midnight or later. Spraying will commence as soon as it is dark. As a <u>precaution</u>, it is advised that residents stay inside their homes and close their windows while the spray truck is in the vicinity, bring in any pets, and remain in the home for 20-30 minutes after the spray truck has passed by. If there are people outside when the truck passes by, no spray will be released, and the truck will not make another pass down that street.

The spray schedule will rotate every 3 weeks meaning that Riverdale Park may not be sprayed each week. The frequency of spraying will be determined by surveillance data collected and complaints received. In order to determine if your community will be sprayed on its scheduled spray night, please contact 301-422-5080 between 2-4 p.m. that day. Any unscheduled sprayings will be announced on the Maryland Department of Agriculture's webpage www.mda.maryland.gov or on Twitter @MdAgMosquito and @MdAgDept.

As a reminder, to reduce the presence of mosquitos, residents must keep their property free of mosquitos breeding containers, stagnant water, bird baths, wading pools, pet watering dishes, tin cans, old tires, clogged gutters or flowerpots. Other water holding containers should be stored upside down.

Please note that this service is only offered to Town residents so identification may be required.

# Neighborhood Services Frequently Asked Questions

I want to build something on my property, do I need a Town building permit?

In most cases, yes. If you are planning to build a fence, driveway, garage, or anything that will require a building permit from Prince George's County, you will also need to obtain a building permit from the Town. # Who should I call to report a concern regarding an animal?

To report a missing, vicious, injured, or deceased animal, please call the Prince George's County Animal

Services Division at 301-780-7200. You will need the following information when you call:

- Name, address, phone number (this information will be kept confidential)
- Address where the animal was last seen
- Animal's physical condition
- Color of animal
- Type of animal

# I have a concern about a property in my neighborhood, what should I do?

If you have concerns regarding a property in your neighborhood, please contact Neighborhood Services. One of the primary duties of the Neighborhood Services team is to educate residents about the Town's community standards. In most cases residents simply do not know that they are not meeting the Town's community standards as defined in the Town Code. In some cases, another community partner such as Prince George's County, may be needed to address your concerns. # See the Art for Riverdale Park's Purple Line Stop

Riverdale Park's upcoming Purple Line stop will include some dynamic public art. The Maryland Department of Transportation has selected Boston artist Mikyoung Kim to build a series of interactive sculptures at the stop, which will be at the intersection of Riverdale Road and Kenilworth Avenue.

Taking advantage of the overhead rail line — the only point in Route 1 corridor communities that the transit system will be this high — Kim envisioned a grove of trees enhanced by vertical folded columns that double as seats at ground level.

"These stainless steel kinetic sculptures are triggered by engagement: when people sit in the folded seats, the columns will sway and reflect a play of colored lights above them," she wrote in a project description. "The columns will stretch up into the overpass and taper off into a reflective cap, lit by LED lights, which will mimic light filtering through surrounding grove of trees."

The public art is part of the agency's broader effort to put public art at most of the Purple Line stops. Mount Rainier artist Valerie Theberge, who you may know for her "Great Wave Off Anacostia" mural at the Melrose Skatepark in South Hyattsville, was also chosen to do a mural at the Beacon Heights station.

#### **Denizens Opened May 25th**

Denizens Brewing Co. opened on Saturday, May 25<sup>th</sup>, at Riverdale Park Station. The Silver Spring-based brewery will open a 12,000-square-foot production house and taproom across from Whole Foods as its second location.

"This new location will allow us to maintain and even improve upon our standards of quality at a much larger scale, which means putting pints of Denizens beer into more hands," said co-founder Jeff Ramirez, who serves as chief brewing officer. The location will include a 150-seat taproom and a 9,000-square-foot production space, which will brew Denizens' four core beers: Southside Rye APA, Born Bohemian Pilsner, Third Party Tripel and Lowest Lord ESB. While the taproom will enhance Denizens' reputation as a destination for beer-drinkers, the production space will allow it to build out its customer base, selling more wholesale to local distributors.

Co-founder Julie Verratti, who serves as chief brand officer, said the brewery matched out on its production capacity three years ago and has had to turn down retail customers at bars, restaurants and liquor stores. Denizens' beer can currently be found everywhere from Busboys and Poets and MOM's Organic Market to Nationals Park. Executive Chef James Marroquin has planned a menu featuring globally inspired dishes that have been designed with specific beer pairings in mind.

The taproom will be open from 11 a.m. to 11 p.m. on Sunday through Thursday, and to 1 a.m. on Fridays and Saturdays. Lunch will be offered Monday through Friday and brunch on Saturday and Sunday from 11 a.m. to 3 p.m.

# Riversdale Exhibition to Celebrate 220 Years of Wedding Traditions

Personal items from Maryland's Founding Family to be exhibited

Riverdale Park, MD - June 11, 2019 will mark the 220<sup>th</sup> Anniversary of the 1799 marriage of George Calvert, grandson of the Fifth Lord Baltimore. In that year, he married Rosalie Stier, the daughter of a wealthy Belgian aristocrat whose family came to America in 1794 to escape the spreading French revolution.

To commemorate this important date in Calvert family history, the Riversdale House Museum is mounting a special exhibition, "Your Presence is Requested: Calvert Weddings 1799-Today", opening June 2, 2019.

Patrick Gossett, President of the Riversdale Historical Society, stated, "This exhibition will illustrate Calvert family weddings and wedding traditions throughout the past 200 years, and the social lives of some of Maryland's most prominent citizens. As a counterpoint, it will also include material about wedding customs within the African American community, so important in building this country."

Docent-led tours are available to the public on Fridays and Sundays from Noon until 3:30pm, for an admission fee of \$5.00. Group tours can be scheduled 7 days a week, booked in advance through the Riversdale Office (301-864-0420).

Gossett elaborated, "In order to fully illustrate the rich legacy of Riversdale, we will include heirlooms from Calvert weddings throughout the years, generously loaned to the Museum by Calvert descendants. They include elegant clothing and

jewelry worn at the weddings, photographs, invitations, unique wedding gifts, and other items that have been tucked away in attics and basements for many years."

The exhibit will also examine the relationships of the family of Adam Francis Plummer, an enslaved worker at Riversdale, and other enslaved families who lived and worked around Riversdale, as told through letters and diary entries. Plummer was born into slavery in 1819 and was moved to Riversdale at age 10. There he learned to read and write and started a diary in 1841 after his marriage to Emily Saunders, continuing it until his death in 1905. Their marriage was atypical for slaves, as they were granted a marriage license and their marriage was considered legal.

The Calverts were descended from the First Lord Baltimore, who received the charter for the Maryland colony from King Charles I in the 17<sup>th</sup> century. The family remained as the Barons Baltimore for over six generations and 150 years.

Rosalie's father, Henri Stier, began construction of Riversdale in Prince George's County in 1801, but returned to Belgium with most of his family in 1803, leaving it to be completed by George and Rosalie in 1807. There the Calvert family raised their family of nine children.

The exhibition will fill the entire museum and will feature not only George and Rosalie Calvert's wedding, but also the weddings of their children and seven generations of the family, including the 1839 wedding of their son, Charles Benedict Calvert, Founder of the University of Maryland.


The exhibition will include several items from the Riversdale Historical Society permanent collection including:

- a copy of the invitation to dinner at Mount Vernon hosted by George and Martha Washington to celebrate George and Rosalie's wedding
- the engraved silver cup given to Caroline Calvert to commemorate her wedding

- a magnificent display of Philadelphia Tucker porcelain purchased by Charles Benedict Calvert, as he and his wife settled into married life at Riversdale
- silver flatware given to many Calvert family brides as wedding gifts

The exhibition will open on June 2 and conclude in November 2019.

The Riversdale Historical Society is a 501(c)(3) non-profit, volunteer organization dedicated to the preservation, protection and presentation of the Riversdale House Museum and Gardens and The Calvert Memorial Park, in cooperation with The Maryland-National Capital Park and Planning Commission.
