Mayor's Report

As we start moving into winter, we are faced with an active (and apparently worsening) COVID-19 crisis. Fortunately, there are multiple vaccines moving through the approval process, so I am cautiously optimistic. I'll update my report on the September 10th flood from last month and discuss a few other items in this month's report. There's a lot of information here, so let's dive right in!

SEPTEMBER 10 FLOOD UPDATE

I have a few small updates on my report on the September 10th flood from the October Town Crier.

The first is that I, Council Member Lingua, and several members of town staff attended a virtual meeting hosted by the Town of Edmonston to discuss what appeared to be a failure of the pumping station at the southern end of Taylor Road in Edmonston. (The concern was that this failure contributed to flooding of houses near the collection pond for the pumps). County staff briefed everyone in attendance with information of what happened, but seemed surprised by information from attendees who had witnessed the flooding firsthand. I was not satisfied with the level of information provided (and as of the time I am writing this report I have not received information that was promised at the meeting), and I have requested that relevant Prince George's County public works staff meet with Riverdale Park residents and government officials to discuss this, as well as other flooding issues in town. That meeting is scheduled for October 29th. I have also submitted a letter to County Executive Alsobrooks asking for a detailed investigation and root cause analysis.

The second is that in my October report I *incorrectly* stated that during a "100-year" flood, when compared to the pre-developed state, the Cafritz project ejected additional runoff of approximately 100 cubic feet per second (cfs) at the peak of runoff. I met with the stormwater engineers who had written the report, and they pointed out an offset I had missed. In fact, there is no difference in the amount of runoff between the undeveloped state and the developed state. An interesting detail is that the project was not allowed to count many of the project's advanced storm water features in their calculation, and those advanced features effectively reduce the impact of a 500-year

flood to that of a 100-year flood. I was correct that there is a mismatch between the incoming capacity of Wells Run (where it crosses from University Park into Riverdale Park) and where it passes under the CSX railroad tracks. That mismatch is 1000 cfs, and is what filled the neighborhood during the September 10 flooding event. I met with many residents of the neighborhood to discuss these issues on September 26th.

COVID-19

Every week I spend many, many hours staying up to date on the COVID-19 pandemic and response. I said last month that while the news was good, we must remain vigilant. Unfortunately, cases are increasing across the state as I write this report (this was reported at a briefing by the state to municipal officials on October 16th). On that same call, state officials reported that contact tracing of new cases indicates that transmission is occurring at bars and restaurants (and other social gatherings without masks), small gatherings at homes, during travel (even local travel), and in dorms and other "congregate settings." Large parties, which are still occurring, are also a source of new cases (this is not a surprise).

As part of the Town's response to the current status, we made some hard decisions to recommend against traditional trick-or-treating on Halloween, and we have canceled the Holiday Market (we are hoping to have some form of the Festival of Lights still).

COVID-19: Vaccine

As I did last month, before I talk about the COVID-19 vaccines that are under development, I'm going to encourage you (and ask you to encourage everyone you know) to get the *flu* vaccine. The flu vaccine is safe, effective, and available now. Because the symptoms of flu and COVID-19 are similar, you will at least save yourself from being scared if you avoid getting the flu (and the flu is a serious illness all by itself). I got my vaccine as I promised in last month's report and it was quick and easy (I made an appointment at an in-town pharmacy about 30 minutes before I got the vaccine, and could have just walked in). It was completely paid for by my health insurance.

On to the vaccines.....

The most important thing to know about the vaccines is that every vaccine that is approved by the US Food and Drug Administration goes through a careful and thorough screening process to ensure that it is safe and effective. The COVID-19 vaccines will have gone through the same process – in fact, the FDA has set much, much higher standards for approval of the COVID-19 vaccines than are legally required. The only safety check that will NOT have happened upon approval is long-term monitoring of the vaccine recipients for health issues that could take time to develop; this monitoring typically lasts for two years after the large-scale "Phase 3" tests that are currently underway. Given the seriousness of the disease (as I am writing 821 people have died in Prince George's County, almost 1 death for each 1,000 population), public health experts are almost universally recommending that the vaccines be used before the long-term monitoring is complete. As a member of a high-risk group, I believe that taking the vaccine will likely be safer than being unvaccinated, and plan to be vaccinated as soon as I possibly can be.

The main reason that approval and deployment of these vaccines is happening so quickly is that the risks to pharmaceutical companies developing a vaccine (the cost of the clinical trials, and the cost of producing huge numbers of doses of the vaccines) will be covered by the federal government. Our federal government has ordered 100,000,000 doses of each of the vaccines so that production can begin even as the trials are underway, with more to be ordered if the trials are successful.

Just as a reminder, vaccines work by teaching your body's immune system to recognize the attacking virus. In the case of COVID-19 the body needs to be trained to recognize a "spike" on the surface of the virus, which acts like a key to let the virus into your cells. Once the virus is in your cells, it seizes control and makes copies of itself. Those copies then go on to infect other cells.

There are three different ways of teaching the body to appropriately respond to the "spike" so your immune system will respond and learn to keep you protected.

The first I'll discuss is a brand-new idea — it convinces your cells to make copies of the "spike" and recognize it as a foreign invader. While there are no existing vaccines that use this technique, it is performing well in the trials. There are two companies — Moderna and Pfizer — that are working on this approach. A disadvantage is that it seems that you'll need two injections of this over a few week time frame for it to be effective, and a *lot* of people in the trials reported fever, fatigue, and chills after the second dose.

The second technique is to take another virus, that does not cause serious illness, attach the "spike" to it, and then introduce it into your body. The fact that it's a foreign virus stimulates your body to react to it, and your body learns to recognize the "spike" without getting you too sick. These vaccines – produced by AstraZeneca and Johnson & Johnson, seem to be fairly effective at producing an immune reaction, but produce fever/fatigue/headache/pain for a fair number of the recipients. The Ebola vaccine approved for use in Europe is similar to these vaccines and has been used safely there. (That being said, trials for both of these are currently suspended in the United States because one recipient in each trial became seriously ill – they are investigating whether it was related to the vaccine and have stopped administering it to new people as they investigate).

The third technique is to produce (using standard pharmaceutical technology) a huge number of copies of the "spike," and attach them to a chemical that stimulates your immune system. This vaccine, developed by Maryland-based Novavax, seems to be highly effective with not many people experiencing side effects like fever, etc. It seems to be a month or so behind the other vaccines, so it may not be the first one approved or available.

The last thing I'll discuss is what's going to happen when one or more vaccines is approved.

Even though there are going to be a huge number of doses available when approved, it's still going to take time to get those doses where they need to be — in the hands of someone who can give it to you. Because we can't give everyone the vaccine at once, it will be necessary to prioritize who should get the early doses. The first people who will get it are those most likely to be infected or become seriously ill — front line medical workers, public safety personnel and other essential workers, and then the elderly and people with preexisting conditions. This is partly because the high risk for these people means they (and the FDA) are more comfortable using a recently-approved vaccine — the risk of not being vaccinated means the minimal risk of side effects from the vaccine is less troubling.

I'll close this discussion by saying that vaccines are not going to make the pandemic go away overnight, and even after vaccination becomes widespread, we may need to continue to use masks and (some) separation to be safe. Vaccines, if widely taken, will be a big step back to normal life, but it will take time to complete that journey and we will need to continue to use our existing tools to keep the spread of the virus in check.

Voting

If you haven't voted yet and it is on or before election day (November 3) as you read this, you can still vote inperson either early or on election day (October 20 was the last day to request a mail-in ballot). The nearest early-voting site (which will also be open on Election Day) is at the Pavilion at University of Maryland (8500 Paint Branch Drive in College Park) and is open from October 26 to November 2nd. Nearby election-day voting sites are at Northwestern High School, Bladensburg High School, and Parkdale High School. All in-person voting sites are open 7am to 8pm. You can register to vote when early voting or voting on election day (online registration closed on October 13). I view voting as a duty of every citizen and hope that you will all carefully consider the candidates and carefully cast your vote!

Thanksgiving

At the end of November we will celebrate Thanksgiving, and before closing my report I want to say that I have a lot to be thankful for: a stable job, a healthy and happy family, hard-working and devoted town employees (including my colleagues on the Town Council), a wide variety of businesses to meet my every need, and a fantastic community to live and work in. I am grateful and extend my thanks to everyone who makes Riverdale Park a great place to live, work, play, and shop. Though this year's Thanksgiving will be subdued compared to other years, I look forward to that peaceful day of gratitude.

Rental Properties in Town

Guidelines for Property Owners

- All properties not occupied by the legal owners of record must be inspected and must obtain a Riverdale Park rental license.
- All bedrooms in rental dwellings must have a clear ceiling height of not less than 7 feet.
- Basements CANNOT be separated from the upstairs portion of a house by way of a key locked door or a separate entrance.
- All rental properties built prior to 1978 MUST have a lead paint certificate issued from the Maryland Department of the Environment (www.MDE.state.md.us).
- All bedrooms must have a secondary means of escape (window or door).
- Window must be openable from the inside "without the use of tools, keys, or special effort".
- A clear opening of 5 square feet for windows at or below grade (5.7 square feet if above grade)
- Bottom of the window sill must not exceed 44 inches above the floor.

International Property Maintenance Code

The Town began its review of the 2018 International Property Maintenance Code (IMPC) in September of 2019. Updates and discussion on various aspects of the proposed IPMC have been discussed at many Council meetings over the last year. When adopted the provisions of the code will apply to all existing residential and nonresidential structures and all existing premises. This code will establish the minimum requirements and standards for premises, structures, equipment and facilities for light, ventilation, space, heating, sanitation, protection from the elements, a reasonable level of safety from fire and other hazards, and for a reasonable level of sanitary maintenance. In the next several weeks, the staff team will conduct a final review of the model IPMC and the proposed local amendments. This review will include seeking input from code officials from neighboring jurisdictions. The results of this review and any additional amendments will then be presented to the Mayor and Council prior to a recommendation for adoption. If anyone has input, staff ask that they email

Leaf Collection

Residents are encouraged to bag their leaves and/or mulch them during lawn mowing instead of pushing them into the streets. It is extremely important to keep storm drains clear of leaves to allow the system optimal performance during a rain event. Public Works staff distributed five (5) leaf bags to all single-family residences in October. Free leaf bags will also be available for pick up on the third Saturday of the month (9 a.m. to 2 p.m.) at the bulk trash drop off at the Public Works building until mid-January. Identification confirming residency is required. Bagged leaves should be set out curbside by 6 a.m. on Monday for collection by the Town's hauler.

Collection Reminders

Residential Trash

Residential trash should be placed in durable, leak proof bags before it is placed in cans. Be sure that the can's lid is tightly closed to keep rainwater out- this will help to reduce spillage. Excess trash should be placed beside your container.



Trash cans should be curbside by 6:00 a.m. on Mondays and Thursdays or the night before collection.

Yard Waste

Do NOT mix yard waste with household trash. Yard



waste must be placed in paper bags or in reusable bins marked as yard waste.

Branches and limbs need to be bundled with rope or string (do not use wire),

additionally all branches, limbs, and bundles must be:

- less than 4 feet long,
- o less than 3 inches in diameter
- weigh less than 60 pounds

Yard Waste should be curbside by 6:00 a.m. on Mondays or the night before collection.

Bulk Trash

Bulk trash collection is by appointment only on Wednesdays. Residents must schedule their collection by 2:00 p.m. on Tuesday by calling 301-773-2069 or by completing a Request Service form online at www.batestrucking.com. The Request Service form can be found on Customer Center tab at the top right corner of the Bates website.

Please note that bulk trash collection is limited to three (3) items per week.

Recycling

Recycling bins should be curbside by 6:00 a.m. on



Wednesdays. As a reminder, no plastic bags are permitted.
