FOR THE PURPOSE OF establishing a meeting schedule and defining a regular meeting of the Council.

WHEREAS, Article II, Section 202 of the Town Charter states, “The council shall meet at least once a month, excluding the month of August; at which time the council shall be in recess.”; and

WHEREAS, the Council historically establishes a meeting schedule in order to provide clarity for the new Administration, the community, and the staff team; and

WHEREAS, the Council typically meets on the first Monday of every month for a Legislative Meeting and the last Monday of every month for a Work Session, except for when the meeting date falls on a holiday or another anticipated conflict; and

WHEREAS, Article II, Section 209 states that a vacancy shall be declared if a member of the Town Council fails to attend three (3) consecutive regular council meetings without being excused by the council, but does not define a regular council meeting; and

WHEREAS, the Council desires to establish a meeting schedule and define a regular meeting of the Council;

NOW, THERFORE, BE IT RESOLVED that the Council of the Town of Riverdale Park does hereby establish the following definitions and meeting schedule:

A regular Council meeting as referenced in Section 209 of the Charter is defined as scheduled Legislative and Work Session meetings, Budget Hearings, and the State of the Town Address, as delineated herein but does not include Special Meetings as noted in Section 204 of the Charter.
