# Mayor's Report

Mayor Alan K. Thompson

It's hard to believe that the summer has slipped by, but the calendar doesn't lie. While the Town Council did not meet in August, council members and town staff have been quietly busy....

## Riverdale Road Bridge

I am excited to report that the Maryland State Highway Administration (SHA) contacted the town this summer to let us know that they are going to replace the Riverdale Road bridge over the Anacostia River. While Riverdale Road is a town street, the bridge belongs to (and is maintained) by SHA. We don't yet know the schedule for replacement, but the road will be closed during construction. We are discussing the bridge's heavy pedestrian traffic, in particular to and from Riverdale Elementary, with SHA, and will work with them to come up with a plan to maintain pedestrian access during construction.

## Riverdale Park Station

Some of the new businesses in the Riverdale Park Station development are getting closer to opening. District Taco, Gold's Gym, and Xfinity all brought sign proposals to the Mixed-Use Town Center Local Design Review Committee in early August, and the proposals were approved. From looking at construction it looks like they could be open this month or early October. (I know that Xfinity has planned a grand opening for early in October.)

The trolley trail through the development was originally scheduled to be open by now, but the active construction zone has prevented that, in consideration for the safety of the trail's users. The latest reports are that a *temporary* trail will open in late summer, with the permanent trail installed when interfering construction is complete. I am working with our partners in both the M-NCPPC and in the county to open it as quickly as possible, and am really looking forward

to using it myself. At this point, the opening, depends on the completion of the construction for the townhomes and businesses on the north side of the site. The good news is that it looks like they're getting close!

## Bridge Construction

Construction of the bridge connecting the Cafritz development to Rivertech Court is also well underway, although the completion date is now the fourth quarter of 2017. The girders and decks for the main span are in place already, and the predicted construction completion is slated for early November. The opening date (probably a few weeks later) will be determined by the county. ## Purple Line

The Purple Line is moving forward! The Town Council's recommendations for station naming and art that I discussed in July's report will come before the Council for action at the September 5<sup>th</sup> legislative meeting.

## Leaking Trash Trucks

The Town has been in ongoing discussions about performance issues with the company we pay to pick up trash (hopefully this will be resolved by the time you are reading this). One issue in particular is that some of the trucks are leaking rancid liquid from the garbage onto the streets. There are multiple reasons this might happen, but you can do your part by keeping liquids out of your trash, as is required by the town code. If you notice smelly stains on the street on trash days please contact the Public Works department as quickly as possible at 301-864-1803 so the contractor can come clean up the mess (and Public Works can track compliance).

### **East-West Highway / Riverdale Road Intersection**

In more good news from SHA, the project to improve pedestrian safety on East-West Highway between Kenilworth Avenue and the Baltimore-Washington Parkway (in response to the tragic death of Thelma Flores while crossing East-West Highway in September, 2014) started accepting bids on the project this summer. While the town has been pushing for an even faster response, we are well ahead of the original schedule for the project.

### **Discovery District Development**

Development activity in the “Discovery District” (formerly known as M-Square) on the north side of town is heating up. The College Park Academy building will open for classes this month, and development plans for “flex-space” (research/development/light industrial) buildings near the new bridge over the CSX tracks are

almost complete, with construction possibly starting this year. We will be meeting soon with the owner of other parcels in the Discovery District (4400-4600 River Road in particular) to discuss their plans. Finally, for those of you who haven’t seen it, there is a new “pop-up” park at the corner of University Research Court and River Road, with an mBike bike share station and lunchtime food trucks.

There’s even more going on, so please feel free to contact me if you have any questions or concerns about what’s going on in town. If you leave me a voice mail message please be sure to tell me what times of day I can call back – I do a lot of my work as Mayor on weekends and evenings, and want to be sure I don’t disturb you when I call back (I’ll reply to e-mail at all sorts of odd hours!).

Enjoy the weather this month as things cool off from summer, and I’ll be back in October!

# Ward 3 Report

Over the summer, the Feherty Troops First Foundation began placing residents in the Leroy Petry Village of Honor, located just off Lafayette Avenue, south of Longfellow Street. On behalf of the neighbors in Ward 3 and the Town of Riverdale Park, a warm welcome to the new residents.

Speaking of Longfellow, along it and a portion of 48th Avenue are signs asking drivers to slow down. This past spring a traffic and speed study was conducted along Longfellow to determine the extent speeding was occurring. The survey results showed approximately one in twenty are traveling greater than ten miles over the speed limit. Whether they were residents or not was undetermined. Along with Stop signs, the topic of driver courtesy and mindfulness has been brought up before on these pages. Advocating for such practice is ever more important in the present day. While staff will do what they can to promote safe driving, ultimately it comes down to the driver. With that in mind, please, be aware of your driving speed and the area you are traveling through. What's more, share this value with a friend.

The Town has held several discussions with Bates Trucking about their diminished level of service as to trash collection. On June 19, with staff and before the council, and again on August 4, there have been substantive discussions regarding Bates making marked and noticeable improvements regarding trash collection. To that end, be sure trash being put out is in a tightly secured bag, one which is not overfilled. As well consider if the items can be recycled.

In July, the Town received a Crime Prevention Through Environmental Design (CPTED) Assessment Report for the Trolley Trail; created by the Virginia Center for Policing Innovation at

the request of the College Park City - University Partnership. Specific to Riverdale Park, the report discussed improvement measures for the portion south of Queensbury Road, the intersection with Queensbury Road, Town Center parking lot and Maryland Avenue, and the portion north of the lot. While in appreciation of the report and its findings, implementation will occur in conjunction with the FY18 and future budgets.

The Central Kenilworth Avenue Revitalization CDC (CKAR-CDC) will be holding ESOL and Job Readiness Training sessions starting August 28 and running through September 25. Sessions will be held at the Greater Riverdale Empowerment Center, 6801 Kenilworth Avenue, Suite 203. As well the CDC is beginning another opportunity for businesses and residents to receive a tree (or two) at no cost with the "Go Green Plant Trees" project. The spring planting saw the allotment all accounted for at locations in an around town. For more information, visit the new website, [www.ckarcdc.org](http://www.ckarcdc.org).

Again this year, for four weeks the Town is flying the Star Spangled Banner in recognition of both the Battle of Bladensburg and the Battle of Baltimore. Each year the Riversdale Mansion holds a modified reenactment of the August 24th battle as part of an effort to encourage the discovery and understanding of early 19th Century American history here in Maryland and Prince George's County. It is in this same spirit in which the banner waves at town hall. Should family or friend come to visit and there is the opportunity to tour Riversdale, please do.

# Public Works

**Saturday Drop Off** – Bulk trash drop-off is scheduled for the third Saturday of each month is from 9:00 a.m. to 2:00 p.m. at the Department of Public Works, 5012 Queensbury Road. The 2017 dates are: September 16, October 21, November 18, and December 16.

**Reminder regarding items accepted for recycling:**

- Glass - Food and beverage containers
- Metals - Aluminum foil, aluminum, bimetal, ferrous, and steel food and beverage containers, empty aerosol cans
- Mixed Paper/Corrugated Cardboard - All paper, aseptic/gable-top milk and juice cartons, catalogs, flattened corrugated cardboard (boxes), frozen food packaging, hard- and soft- covered books, paper bags and wrapping paper, magazines, newspapers with inserts, paper board (cereal and cracker boxes), telephone books
- Plastics - Drinking cups/glasses, flower pots, narrow-neck containers with code identification numbers 1 through 7, empty prescription bottles, wide-mouth containers with code identification number 1 through 7, including peanut butter, yogurt, cottage cheese, sour cream, mayonnaise and whipped topping and margarine/butter tubs

**Trash Toter Repair/Replacement** – Residents should call the Department of Public Works for the repair or replacement of damaged trash toters, i.e., broken lids, missing wheels, cracked toters, etc. When repairs or replacements are needed, a list will be provided to Bates Trucking each Friday, with the expectation for deliveries to occur during the following week.

**Office Closing** – In observance of the Labor Day holiday, Town offices will be closed on Monday, September 4<sup>th</sup>.

**Holiday Trash Collection** – Regular trash will **NOT** be collected on Monday, September 4<sup>th</sup>. The next collection day is on Thursday, September 7, 2017.

**Mosquito Control Program** – The State/County Mosquito Control Program ends on September 17, 2017.

**Summer Youth Enrichment Program** – The Town of Riverdale Park participated in the Prince George's County Summer Youth Enrichment Program by employing six (6) youth during the months of July and August. The program offered the youth the opportunity to get training and experience on what it means to be in a work environment where promptness, reliability, and the ability to take and follow instructions is expected. They also learned about the tasks performed by a public works department. Each of the students were given Certificates of Achievement for successfully completing the program.
