Mayor's Report

As required by our charter the Mayor shall report to the Council regularly, but no less than yearly the condition of municipal affair and make recommendations as he deems proper for the public good and welfare of the town.

Traditionally, mayors have chosen the month of January for this purpose.

Financial: As a result of our property tax cap and loss of taxable property due to the acquisition of a large amount of industrial property by the University of Maryland, the Town suffered a large loss of tax revenue during this fiscal year. At the present time our taxable assessable base is \$300,000,000. Our non-taxable base is an unbelievable \$65,000,000 which if taxable would increase our revenues by an additional \$325,000 per year, only in property taxes.

Fortunately our two year efforts to induce NOAA to locate their new climate and atmosphere building in Riverdale Park, when completed, will yield our town an additional \$200,000 + in tax years starting 2006-2007.

We are continuing our efforts to have the Cafritz Properties developed as soon as possible. We have had many discussions both with developers and Cafritz representatives for the use of property.

We are also cooperating with the Potomac Development Company as regards the Eckerd Project. Jey's Service Center for the Cleveland Ave/US 1 Redevelopment Project, the Puglisi Project on US 1 for the proposed office center, and the Corporation for the Town Home Project on the 4500 Block of Madison Street, and Chambers LLC for four new homes at Dupont Circle and Harrison Street.

We continue our efforts to obtain tenants for the Town Center, as well as, the Credit Union building and the former Bike Shop Site.

The economic future looks good for our Town and many thanks need to be given to the many State & County Officials and departments who continue to give us their support and assistance.

Services: In order to meet budgetary requirements each department was required to not fill certain positions when some employees left for any reason. While this has been difficult in many ways, on a whole no Town service to our residents has suffered and in fact our employees are performing in an outstanding fashion. Hopefully our new Fiscal year 2005-2006 would allow us to increase the amount of employees.

Infrastructure: I am pleased to report we have awarded close to \$500,000 in contracts for resurfacing a large number of streets commencing in March – weather permitting. These projects are over and above projects which will also begin in March for work to be completed as a result of grants applied for – storm sewer and road improvements on the 6200 block of Rhode Island, storm sewer in the 4800-4900 blocks of Somerset and Sheridan resurfacing and road reconstruction on Spring Lane, 54th Ave and Jefferson Street. These projects are over \$300,000. We have and are also applying for an approximate \$5,000,000 project under Priority Places for Kenilworth Avenue North of East West Highway to Goodluck Road. A \$100,000 project for reconstruction of 48th Ave between Riverdale Road & Rittenhouse, through CDBG Funding.

December calls for police service increased from 654 in 2003 to 1029 in 2004, for an increase of 57 percent. This contrasts with a November 2003-November 2004 increase of 24 percent and a decline of 14 percent between October 2003 and October 2004. This substantial increase in workload has been shouldered by a force that has

lost staff over the last several months, partially due to our town's budget crunch.

I support the purchase of a new ambulance for our Fire Department. I hope you will use the flyer in this month's Crier to make a generous contribution towards that end.

Kenilfair Shopping Center Planning Study

The final step before our "Application to Maryland Priority Places Program"

Last year the Town of Riverdale Park completed a streetscape revitalization project for Kenilworth Avenue, using the services of the Neighborhood Design Center and their volunteers from the firm of Louvierre Stratton and Yokel. During that project it was recommended that Kenilfair Shopping Center be given a facelift. The team also recommended that an old bridge connection to the trail and park network be reinstated.

In 2005, The Neighborhood Design Center has mobilized two volunteer Landscape Architects from Rodgers Consulting to complete a planning study for the Kenilfair Shopping Center on Kenilworth Avenue. This team will look at the possibility for façade improvements to the existing businesses and the potential for adding new businesses to the center, since currently the parking lot is underutilized. Ideally these businesses should be at the street edge and should attract potential customers from the burgeoning University of Maryland, research park on River Road, known as "M Square". Destined to be the largest research park in the state of Maryland If there were lunch options in the Kenilfair Center, more people would be attracted there.

In order to attract potential pedestrian traffic, a strong trail connection needs to be made to the existing trail network to the rear of the center. This will necessitate building a new bridge.

Finally the parking lot will be redesigned to add parking lot islands with trees and other plantings. Ideally these should be bio-retention areas, that trap pollutants during heavy rains and stop those going into the storm drains and then to the Chesapeake Bay.

We have been advised by the Neighborhood Design Center that mid to late March 2005, the study team will be prepared to make a presentation to the Mayor & Council and community on the Kenilfair Shopping Center Planning Study.

The Kenilworth Avenue Streetscape Improvement Project along with the aforementioned study will be the major focus of the application to the State of Maryland Priority Places Program. As previously reported we are currently working the Maryland Department of Transportation, State Highway Administration (SHA), Maryland Department of Planning, University of Maryland and Maryland Department of Business and Economic Development (DBED) to explore funding opportunities for the implementation of streetscape and redevelopment improvements along the Kenilworth Avenue Corridor.

As always we encourage community input on these proposed plans.

Our long range planning for over \$7,000,000 worth of infrastructure improvements is well on schedule with projects planned annually well into the future.

Taxes: As a result of the final payments having been made for the Town Municipal Center and Police Department buildings and some of our long term leases purchases, our Town's debt is at the lowest point in over thirty years. For the proposed budget for 2005-2006, I will propose a significant tax reduction in our special tax which is used to pay debt, but I will also ask for an adjustment in our general tax cap, to either raise the limit or remove it in its entirety. This is necessary to assure the continuation of our town services at a high level, to assure our staffing remains adequate and competitive with our surrounding municipalities.

In general: Our Town is on an upswing. We are blessed to have employees such great in our Public Works, Police Department, Code Enforcement and General Government. Plus our volunteer organizations that has and is continuing to provide our residents with quality services. For this we can be thankful.
