I am requesting the Board make a motion to increase that budget line item to cover the outstanding invoices. # AN ORDINANCE AUTHORIZING THE EMPLOYMENT OF RHONDA SMITH AS A FULL-TIME ADMINISTRATIVE ASSISTANT IN THE DEPARTMENT OF COMMUNITY DEVELOPMENT AND ESTABLISHING A SALARY AND START DATE FOR SUCH EMPLOYEE

**WHEREAS**, City Code Section 110.070 provides for the appointment of employees of the City by the City Administrator with approval of the Mayor and Board of Aldermen; and

**WHEREAS**, City Code Section 110.140 provides for the establishment of the salary of nonelected employees of the City by ordinance; and
