Council President Wilkerson called the Workshop Meeting of the Mayor and Council of the Borough of Roselle, Union County, New Jersey, held at Borough Hall, 210 Chestnut Street, Roselle, New Jersey to order on May 08, 2019 at 6:31 P.M. The flag salute was done and the invocation was given by Councilman Atkins.

SPECIAL COMMUNICATIONS/PRESENTATIONS

Mike Coyle, Public Affairs Manager – Public Service Electric & Gas, Co. (PSE&G), talked about an upcoming project, which was presented to the Development Review Committee (DRC). He said that the main content of the project is replacement of transmission lines. He introduced Jay Cavello, who gave an overview of the timeline for the project. Mr. Covello said that the project will commence in June of 2019, with surveying of the rights of way and then the access roads will be constructed. He estimated that the project will continue through spring into summer. He informed the Council that there will be notification sent out to affected residences and there is an "800" number that will be provided for residents to call PSE&G if necessary.

They entertained and answered questions from the Governing Body.

COMMENTS AND REPORTS BY ADMINISTRATOR

Jack Layne, Borough Administrator, talked about the completion and submittal of the budget. He said that there was an ADP Payroll training held during the preceding week; and that there is another one scheduled. He commented on union negotiations, saying that the unions have begun meeting and that they are moving right along. He announced the upcoming Sexual Harassment Training and the Pothole Killer demo, which was covered by Channel 12 News. He remarked about the Grand Opening of Wawa, stating that it begins at 9:00am, with free coffee for all. He talked about the delay in having the Borough Hall spray washed and gave updates on various facets of the Borough's insurance policies. He said that he would be meeting with the CFO, Mr. Hasseler and the Tax Assessor, Ms. Steele regarding the PILOTS. He wished everyone a Happy Mother's Day.

Councilwoman Shaw asked Mr. Layne for further explanation regarding the ADP Training that was provided; and Mr. Layne provided the rationale for the training. Discussion ensued amongst the Council Members about who has access to personnel payroll records.

Council President Wilkerson asked if there were any questions regarding the ordinances on the agenda for consideration next week.

Acting Municipal Clerk, Lydia Massey, reported that she was still awaiting confirmation from the Chief of Police for Ordinance Number 2598-19, and that upon receipt of the proper paperwork, it would be forwarded to the Governing Body. She said that she expected to have it the next day.

Councilwoman Johnson asked for explanation on the Resolution to increase the amount of the Senior Citizen tax deduction and Veterans Tax Deduction.

Chief Financial Officer, Anders Hasseler gave the amount of the proposed increase; and Council President Wilkerson added that the sentiment behind it stems out of the fact that the amount of the Senior and Veterans deduction has been the same for so long, despite increases in the cost of living.

Councilman Bernier asked if the individuals to be hired by the resolution appointing part-time laborers in the Department of Public Works are all Roselle Residents.

Borough Administrator, Jack Layne, said that it was his understanding that all those to be employed by the resolution are, in fact, Roselle Residents.

Council President Wilkerson then declared the meeting open for Public Comment.

PUBLIC COMMENT

Anthony Esposito, 414 E. 3rd Avenue, read an article from Politifax regarding a settlement.
He said that the article does not state anything about the lawsuit or how it was awarded. He

said that he would be submitting OPRA Requests for the documentation related to the settlement.

Borough Attorney, Karen Brown, stated that there was no lawsuit filed; but rather a Tort Claim that was handled by the Joint Insurance Fund. She said that there was never any public discussion on the matter.

2. Fran Bernier, 430 East 6th Avenue, said that the ability to OPRA Records should not be a political thing. She commented that the demeanor of some Council Members is ridiculous.

Seeing no-one else come forward. Council President Wilkerson then closed the public comment portion of the meeting.
