COMMITTEE REPORTS

Councilman Bernier reported that the communications/Technology Committee met with reps from Konica Minolta, their leas would save \$6,000. DPW is working with PR folks to update modes of disseminating information. Planning Board received an application for subdivision from The Park Apartments, as well as an application from OEM Source to upgrade their building and property.

Councilwoman Johnson, commended the Roselle Police Department on a job well-done. She gave a brief overview of discussion items from the last public safety meeting, including the search for new Parking Meters. She thanked Chief Mucha for his many years of service and thanked OEM for their commitment and support to the Borough.

Councilman Fortuna talked about bulk pick-up and said that the DPW Committee is looking at ways to reduce tonnage. He said that this is important because we pay \$114 per ton and the cost to the Borough is great. He congratulated Chief Mucha on his retirement.

Council President Wilkerson reported from the Finance Committee that the Budget would be introduced that night. From the Recreation Committee, she said that Summer Camp is ramping up and that Recreation has many activities available for residents. She encouraged all to take part in Recreation Activities whenever possible.

INTRODUCTION, CONSIDERATION AND PASSAGE OF ORDINANCES

ORDINANCE ON SECOND READING AND FINAL PASSAGE – Ordinance 2598-19 AN ORDINANCE AMENDING CHAPTER 113 OF THE BOROUGH CODE TO DESIGNATE A HANDICAP PARKING SPACE RESERVED FOR A SPECIFIC PERSON IN FRONT OF A CERTAIN RESIDENCE – (Patricia E. Wilson) - [Public Hearing June 19, 2019 Pending Approval]

WHEREAS, the Police Department has received an application for a personalized handicap parking space pursuant to N.J.S. 39:4-197.7 along with the requisite \$25.00 fee; and

WHEREAS, the Mayor and Council have approved said application and the Borough Clerk has collected the additional fee of \$150.00 for same prior to adoption of this ordinance.

BE IT ORDAINED, by the Mayor and Council of the Borough of Roselle as follows:

1. Article III of Chapter 113 of the "Code of the Borough of Roselle" is amended by adding the following to 113-29.1 – Restricted Handicap Parking Spaces.

Chapter 113-74. Schedule XXIX – Restricted handicap parking spaces reserved for a specific person in front of a certain residence:

- (1) If any person for whom a parking space has been designated pursuant to this section ceases to reside at the specified resident address, he or she (or other person authorized to act on their behalf) shall promptly notify the Borough Clerk in writing that the designated parking space is no longer required.
- (2) In the event that the person holding the designated handicapped parking permit no longer resides at the specified residence address, the designation may be terminated by resolution.

If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision so adjudged and the remainder of the Ordinance shall remain valid and effective.

This ordinance shall take effect after public hearing and final adoption and publication according to law.

Mayor Dansereau read Ordinance Number 2598-19 by title and opened the Public Hearing.

WHEREAS, a municipality may, by ordinance, bank the difference between its final budget appropriations and the 3.5% increase authorized by this ordinance when said difference is not appropriated as part of the final budget; and,

NOW THEREFORE BE IT ORDAINED, that any amount authorized herein above that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and

BE IT FURTHER ORDAINED that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

ORDINANCE ON INTRODUCTION & FIRST READING — Ordinance 2600-19 AN ORDINANCE OF THE BOROUGH OF ROSELLE APPROVING THE FIRST AMENDMENT OF THE FINANCIAL AGREEMENT FOR A LONG-TERM TAX EXEMPTION WITH ROSELLE URBAN RENEWAL, LLC PURSUANT TO THE NEW JERSEY LONG-TERM TAX EXEMPTION LAW (N.J.S.A. 40A:20-1 ET SEQ.) [Public Hearing July 17, 2019 Pending Approval]

WHEREAS, the Borough is a political subdivision of the State of New Jersey, located in the County of Union; and

WHEREAS, Roselle Urban Renewal, LLC (the "Redeveloper") is a limited liability company under the laws of the State of New Jersey and an Urban Renewal Entity under the Long-Term Tax Exemption Law ("Exemption Law"), N.J.S.A. 40A:20-1 et seq.; and

WHEREAS, the Redeveloper has entered into an agreement with the Borough in which it agreed ("Redevelopment Agreement") to redevelop the property identified as Block 7505, Lot 30 on the Official Tax Map of the Borough, the area for which the Borough has adopted a Redevelopment Plan ("Property" or "Redevelopment Plan Area") in accordance with the Redevelopment Plan, the Redevelopment Law "Project"); and

WHEREAS, pursuant to Ordinance No. 2457-13 adopted on May 15, 2013, the Borough and the Redeveloper entered into a Financial Agreement to memorialize the terms and conditions for payments in lieu of taxes; and

WHEREAS, the Redeveloper acquired the Property and undertook the development of the first phase of the Project (each of the five residential unit phases of the Project are referred to in the Redevelopment Agreement as a "Phase"), and at this time the Borough and Redeveloper are making certain modifications to the Redevelopment Agreement concerning the project phasing and established timelines to reflect the progress thus far and diligent pursuit of governmental approvals and financing of the Redeveloper;

WHEREAS, at this time, consistent with the requirements of Section 11.4 of the Redevelopment Agreement, the Borough Planning Board is also reviewing a proposed subdivision of the Property, the approval of which will be conditioned on the imposition of appropriate easements, covenants and restrictions, and other applicable terms and conditions which will be employed in the event that there is an authorized transfer of part of the Project in order to ensure that the five individual residential Phases of the Project will be operated in a coordinated manner by a single management entity; and in order to provide for the continuation of the Financial Agreement with respect to such transferred portion of the Project, the Borough and the Redeveloper have determined that it is appropriate to amend the Financial Agreement to add the certain provisions:

Section 19 Transfer of Project. Transfers of the Project prior to issuance of a Certificate of Completion are controlled by the Redevelopment Agreement. Any change made in the ownership of the Project or any other change that would materially affect the terms of the Agreement shall be void to the extent that it purports to accomplish the transfer of the tax exemption to the transferor unless approved by the Borough Council by resolution; provided however that the tax exemption may be transferred to the owner of an individual Phase of the Project, if the transfer of this Agreement is to a new urban renewal entity eligible to operate under the Exemption Law, the Redeveloper Entity is not in default regarding any performance required of it under the Financial Agreement, full compliance with N.J.S.A. 40A:20-1 et seq. has occurred, and the transferor Redeveloper Entity's obligations under the Financial Agreement are fully assumed by the transferee entity; it being understood that each Phase shall mean each subdivided residential portion of the Project as approved by the Planning Board.

WHEREAS, the Borough has determined that it is in the best interests of the Borough to enter into the First Amendment to the Financial Agreement with the Redeveloper.

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Roselle, in the County of Union, that the First Amendment to the Financial Agreement negotiated by and between the Borough and the Redeveloper, for the Roselle Golf Club property is hereby approved.

BE IT FURTHER ORDAINED that the Mayor is authorized to execute on behalf of the Borough the said First Amendment to the Financial Agreement in substantially the same form as attached hereto as Exhibit A, to be agreed to and approved by Borough counsel and the Redeveloper.

BE IT FURTHER ORDAINED that all ordinances or parts of ordinances inconsistent with the provisions of this Ordinance be and the same hereby are repealed.

BE IT FURTHER ORDAINED, that if any portion or clause of this Ordinance is declared null and void for any reason whatsoever, same shall not affect the validity or constitutionality of any other part or portion of this Ordinance.

BE IT FURTHER ORDAINED, that this Ordinance shall become effective immediately upon final passage and publication as required by law, as the "Ordinance Approving the First Amendment to the Financial Agreement for the Roselle Golf Club."

ORDINANCE ON INTRODUCTION & FIRST READING - Ordinance 2601-19

BOND ORDINANCE PROVIDING FOR VARIOUS IMPROVEMENTS AND APPROPRIATING \$1,640,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$945,250 BONDS OR NOTES TO FINANCE PART OF THE COST THEREOF, AUTHORIZED IN AND BY THE BOROUGH OF ROSELLE, IN THE COUNTY OF UNION, NEW JERSEY [Public Hearing July 17, 2019 pending approval]

BE IT ORDAINED, BY THE BOROUGH COUNCIL OF THE BOROUGH OF ROSELLE, IN THE COUNTY OF UNION, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

The improvements described in Section 3 of this bond ordinance (the "Improvements") are hereby authorized to be undertaken by the Borough of Roselle, New Jersey (the "Borough") as general improvements. For the said Improvements there is hereby appropriated the amount of \$1,640,000, such sum includes the (a) the sum of \$465,000 expected to be received as a grant from the New Jersey Department of Transportation in connection with the improvement described in Section 3(a)(3), (b) the sum of \$120,000 expected to be received as grant monies from a Community Development Block Grant in connection with the improvement described in Section 3(a)(3), (c) \$60,000 expected to be received as grant monies from a Union County Municipal Infrastructure Grant in connection with the improvement described in Section 3(a)(3) and (d) the sum of \$49,750 as the down payment (the "Down Payment") required by the Local Bond Law of the State of New Jersey, constituting Chapter 2 of Title 40A of the New Jersey Statutes, as amended and supplemented (the "Local Bond Law"). The Down Payment is now available by virtue of provision in one or more previously adopted budgets for down payments or capital improvement purposes.

In order to finance the cost of the Improvements not covered by application of the Down Payment, negotiable bonds of the Borough are hereby authorized to be issued in the principal amount of \$945,250 pursuant to the provisions of the Local Bond Law (the "Bonds"). In anticipation of the issuance of the Bonds and to temporarily finance said improvements or purposes, negotiable bond anticipation notes of the Borough are hereby authorized to be issued in the principal amount not exceeding \$945,250 pursuant to the provisions of the Local Bond Law (the "Bond Anticipation Notes" or "Notes").

The Improvements authorized and the purposes for which obligations are to be issued, the estimated cost of each Improvement and the appropriation therefor, the estimated maximum amount of bonds or notes to be issued for each Improvement and the period of usefulness of each Improvement are as follows:

The estimated maximum amount of Bonds or Notes to be issued for the purpose of financing a portion of the cost of the Improvements is \$945,250.

The estimated cost of the Improvement is \$1,640,000 which amount represents the initial appropriation made by the Borough.

All Bond Anticipation Notes issued hereunder shall mature at such times as may be determined by the chief financial officer of the Borough (the "Chief Financial Officer"); provided that no Note shall mature later than one year from its date. The Notes shall bear interest at such rate or rates and be in such from as may be determined by the Chief Financial Officer. The Chief Financial Officer shall determine all matters in connection with Notes issued pursuant to this ordinance, and the signature of the Chief Financial Officer upon the Notes shall be conclusive evidence as to all such determinations. All Notes issued hereunder may be renewed from time to time subject to the provisions of Section 8(a) of the Local Bond Law. The Chief Financial Officer is hereby authorized to sell part or all of the Notes from time to time at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof. The Chief Financial Officer is directed to report in writing to the Borough Council of the Borough at the meeting next succeeding the date when any sale or delivery of the Notes pursuant to this ordinance is made. Such report must include the amount, the description, the interest rate and the maturity schedule of the Notes sold, the price obtained and the name of the purchaser.

The capital budget of the Borough is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. The resolution in the from promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, Department of Community Affairs, State of New Jersey is on file with the Clerk and is available for public inspection.

The following additional matters are hereby determined, declared, recited and stated: The Improvement described in Section 3 of this bond ordinance are not current expenses, and are capital improvements or properties that the Borough may lawfully make or acquire as general improvements, and no part of the cost thereof has been or shall be specially assessed on property specially benefited thereby.

The period of usefulness of the Improvement, within the limitations of the Local Bond Law, and according to the reasonable life thereof computed from the date of the Bonds authorized by this bond ordinance, is 16.83 years.

The Supplemental Debt Statement required by the Local Bond Law has been duly prepared and filed in the office of the Clerk and a complete executed duplicate thereof has been filed in the office of the Director, Division of Local Government Services, Department of Community Affairs, State of New Jersey. Such statement shows that the gross debt of the Borough, as defined in the Local Bond Law, is increased by the authorization of the Bonds and Notes provided in this bond ordinance by \$945,250 and the obligations authorized herein will be within all debt limitations prescribed by the Local Bond Law.

An aggregate amount not exceeding \$500,000 for items of expense listed in and permitted under Section 20 of the Local Bond Law is included in the estimated cost of the Improvements, as indicated herein.

Any funds received from time to time by the Borough as contributions in aid of financing the purposes described in Section 3 of this Ordinance shall be used for financing said Improvements by application thereof either to direct payment of the cost of said Improvements or to the payment or reduction of the authorization of the obligations of the Borough authorized therefor by this Bond Ordinance. Any such funds received may, and all such funds so received which are not required for direct payment of the cost of said Improvements shall, be held and applied by the Borough as funds applicable only to the payment of obligations of the Borough authorized by this Bond Ordinance.

The full faith and credit of the Borough are hereby pledged to the punctual payment of the principal of and interest on the obligations authorized by this bond ordinance. The obligations shall be direct, unlimited obligations of the Borough, and the Borough shall be obligated to levy ad valorem taxes upon all the taxable property within the Borough for the payment of the obligations and the interest thereon without limitation of rate or amount. SECTION 9:

The Chief Financial Officer of the Borough is hereby authorized to prepare and to update from time to time as necessary a financial disclosure document to be distributed in connection with the sale of obligations of the Borough and to execute such disclosure document on behalf of the Borough. The Chief Financial Officer is further authorized to enter into the appropriate undertaking to provide secondary market disclosure on behalf of the Borough pursuant to Rule 15c2-12 of the Securities and Exchange Commission (the "Rule") for the benefit of holders and beneficial owners of obligations of the Borough and to amend such undertaking from time to time in connection with any change in law, or interpretation thereof, provided such undertaking is and continues to be, in the opinion of a nationally recognized bond counsel, consistent with the requirements of the Rule. In the event that the Borough fails to comply with its undertaking, the Borough shall not be liable for any monetary damages, and the remedy shall be limited to specific performance of the undertaking

SECTION 10.

This Section 9 constitutes a declaration of official intent under Treasury Regulation Section 1.150-2. The Borough reasonably expects to pay expenditures with respect to the Improvements prior to the date that the Borough incurs debt obligations under this Bond Ordinance. The Borough reasonably expects to reimburse such expenditures with the proceeds of debt to be incurred by the Borough under this Bond Ordinance. The maximum principal amount of debt expected to be issued for payment of the costs of the Improvements is \$945,250.

This bond ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.

She said that she thought the individual was the Superintendent of DPW; but doesn't have the proper certification to hold such a position. She went on to say that there are other DPW Employees who are currently in school at the same time as the Superintendent. Which will make us very top heavy at the DPW.

Borough Administrator, Jack Layne, answered by saying that JGSC provides economic development outreach and aides in conceptual design for downtown areas. He said that they will reach out to property owners with regard to economic development needs and options and develop economic development marketing materials for the Borough.

Seeing no-one else come forward, Mayor Dansereau closed the Public Comment portion on Pending Resolutions Only.

Mayor Dansereau then declared the time for Public Comment.

PUBLIC COMMENT

- 1. Resident spoke on behalf of residents in the area of E. 7th and 8th Avenues, with regard to the adjacent Borough-owned property, which has been left unkempt for quite some time. She said that the NJ Department of Health had been notified as well as the Union County Board of Health. - 2. Archange Antoine, 195 Cavell Street, congratulated the winners of the Primary Election. He said that he hopes that the issues brought up on the campaign trail will continue to be addressed. He said that some of those issues are: rent control; stronger residency requirements for employment; prioritizing contracts for women and minority owned businesses; the use of force by Police Officers. He said that an Ethics Board should be established to monitor the actions and purchasing practices of Elected Officials; and that a Civilian Review Board should be established as a means of checks and balances. He talked about Ordinance 2619, stating that tax abatements should not be passed from owner to owner when properties are sold.
- 3. William Frolich, asked where Block 7505 lot 30 was located. He said he does not understand why there is no line the agreement that says, "commonly known as." He talked about the Gordon Street Bridge and asked if it is still the intention of the Borough to widen the bridge to 3 lanes. He also asked when the High School Football Field would be ready for use.
- 4. Sylvia Turnage, asked about the budget process and said that she hopes that there will be an indepth budget narrative prior to the budget hearing. She commented on the status of OEM, citing that we have no building and that there is no accounting for the equipment. She asked if Mr. Mollinedo was the Superintendent or Director of DPW. She talked about the number of DPW Employees in school for certification, which is being paid for by the Borough. She asked who the Food Service Coordinator is; and she asked the name of the employee who is being separated.
- 5. Norma Hall, Resident of Roselle, said that it is beneficial to attend monthly Ward Meetings because individuals get more one-on-one time with their Council Representatives. She listed

- some recent repairs that had been completed within the Borough and thanked the Council for the work being done.
- 6. Anthony Esposito, thanked the Mayor and Council for taking care of an issue with vegetative waste.
- 7. Rafael Vanderpool, 330 Burt Drive, asked for updates on various issues, including mosquito control, maintenance of Borough-owned lots and change of flood zone designation from FEMA.
- 8. Jeanne Marie Ryan, Library Director invited everyone to the Summer Reading Club kick-Off. She announced that she would be attending the National Library Conference to present the Library Construction Grant.
- 9. Ethelyne Grimsley, 210 E. 7th Avenue, talked about the area behind E. 7th and 8th Avenues where the water is retained, stating that DPW does need to continue treating and remediating the area. She said that DPW is doing a good job picking up the debris from homes and thanked them for a job well done.

Seeing no-one else come forward, Mayor Dansereau closed the public comment portion of the meeting.

Mayor Dansereau and Council Members responded to residents' questions with updates, where appropriate.

COUNCIL COMMENT

Council President Wilkerson thanked the public for coming out and being a part of the process. She gave condolences to the families of Walter Durylak, Ralph Johnson and Nancy Bolden on the loss of their loved ones. She congratulated Chief Paul Mucha on his retirement, and the Firefighters who were promoted. She also congratulated all of the young graduates of the Borough. She thanked the voters who came out to vote and she thanked her family for their support.

Councilman Bernier thanked Chief Mucha for his years of service to the Borough and congratulated newly installed Chief Eric Pearson. He mentioned the recent gas main replacement on Chandler Avenue and said that all of Chandler from 3rd Avenue down to St. Georges Avenue should be repaved in the upcoming months. He talked about reporting dangerous trees and encouraged residents to reach out in any way available regarding any issues. He said that there should be demolition of the house on E. 10th Avenue soon and he congratulated the Borough graduates. He announced his upcoming Ward Meeting and invited all to attend. He thanked Mr. Frolich for the letter he sent in May.

Councilwoman Johnson began by reading a letter addressed to Assemblyman Holley. She thanked Donald Shaw and Archange Antoine for running a clean campaign; and she congratulated the Mayor on her re-elected. She thanked all of those who voted and stated that she would continue to represent the residents of the 3rd Ward and hold elected officials accountable for keeping their campaign promises. She announced the upcoming Gospel Explosion, to be held August 10, 2019.

Councilwoman Shaw congratulated the Washington Elementary School Drama Club on their 2nd Annual play presentation. She congratulated Chief Mucha and said that it was an honor to work with him on the Public Safety Committee over the years. She also congratulated the Firefighters who were promoted and the young graduates. She stated that the night's Executive Session was lengthy; but it was necessary because there was much to be considered. She asked that an Executive Session be permitted at each Workshop Meeting. She ended by saying that school will be out soon, so motorists should be extra vigilant.

Councilman Fortuna congratulated Chief Paul Mucha on his retirement and said that he's a great guy. He said that the third 5th Ward Meeting was held the previous week, and Mr. Mollinedo was in attendance to address Public Works issues. He addressed comments made by Mr. Vanderpool and Ms. Turnage and congratulated the graduates.

Councilman Atkins congratulated all who received commendations and promotions and gave his best wishes to Chief Paul Mucha. He thanked Assemblyman Holley and Dave Biunno for securing grant funds to help keep Roselle moving forward. He announced the Annual Car Show and said that the items mentioned by Mr. Archange Antoine are near and dear to his heart, especially rent control. He said that something that has not been addressed is the growing population of homeless people in Roselle. He commented on Juneteenth; and said that though there has been much progress, there is still much today. He shared quotes from Dr. Martin Luther King, Jr.

MAYOR'S COMMENT

Mayor Dansereau thanked the public for coming out to be a part of the meeting. She gave remarks about the past campaign and the hard work it takes to run for elected office. She thanked the Grant Writer for the Borough and talked about the Neighborhood Preservation Grant that was awarded. She also gave her condolences to Mr. Ralph Johnson on the loss of his wife. She reminded residents that the new Resource Guide is available in print and online, and encouraged everyone to sign up for NIXLE Alerts so that they may stay abreast of the goings on in the Borough. She commented that when the Administration is chosen, it is not the job of the Council Members to run the departments. She said goodnight and wished everyone a wonderful summer.

Borough Administrator, Jack Layne, announced the beginning of Summer Hours and said that there would be a drop box in the Police Department for Tax Payments to be left on Fridays, when Borough Hall will close at 1pm.

ADJOURNMENT

On a motion by Councilman Bernier, seconded by Councilman Fortuna, with all in favor and none opposed, the meeting was duly adjourned at 10:22 p.m.
