Mayor Dansereau then announced that there would be several presentations as follows:

SPECIAL COMMUNICATIONS/PRESENTATIONS

William Perry, Senior Consultant Corporate Real Estate, PSE&G talked about the current project underway to relocate a sewer line that is obstructing the path of the base of towers that are being replaced. He said that there is a reimbursement agreement, which the company is looking to have to have the Council adopt, which will pay for the Borough's Engineering and Contracting for the sewer line to be replaced. He referenced the original project, to replace towers along their right-of-way, which runs along the railroad tracks owned by the New Jersey Department of Transportation (NJDOT). He said that mailings have gone out to the residents in the affected areas.

He then entertained questions from the Governing Body.

David Biunno, Grant Writer, talked about Resolution Numbers 13 and 14. He reported that the Borough was awarded the Neighborhood Preservation Grant, which will focus on upgrading Chestnut Street between First and Third Avenues. The Green Acres Enabling Grant Resolution will pay for the Arminio Field Project. The Safe and Secure Communities Grant Resolution had Borough of Roselle

to be amended to include language detailing the matching funds provision. He said that a grant was filed with the county to complete upgrades at our local polling locations; and that the Library Grant is proceeding.

He answered question from the Mayor and Council regarding the various grants.

DEPARTMENT AND OFFICIALS' REPORTS

Pamela Steele, Tax Assessor, provided a handout titled," NJ Homeowner's Guide to Property Taxes," and gave an overview of the process of property tax assessment. She explained determination of a tax rate as it relates to assessment. She talked about the statute governing the Office of the Tax Assessor and described some duties of the Assessor. She said that the current tax rate is 8.304 and explained the formula for calculating individual property taxes. She said that there is a process for tax appeal and she also talked about home improvements that require permits, which may affect assessment.

COMMENTS AND REPORTS BY ADMINISTRATOR

Borough Administrator, Jack Layne spoke to the status of the Arminio Field Project, stating that the field itself is done; but there are some ancillary items that need to be completed. He said that we are waiting on the Board of Education to get a few things nailed down. He reported that the copiers in Borough Hall and our other buildings have been replaced, with an expected savings of about \$5,900. He said that contract the collective bargaining units are meeting to discuss contracts and that negotiations are underway with the Police Department He talked about the Pothole killer fixing a huge pothole on the Gordon Street Bridge. He also announced that Roselle First would be moving to the Community Center, with OEM moving into Borough Hall.

Council Members Atkins and Johnson voiced concerns about Roselle First Moving to the Community Center.

Mayor Dansereau explained that the reason for the switch was to give the Office of Emergency Management a place to muster in the case of an emergency. She said that OEM needs to be located in a place where there is a generator, so that communication equipment will work without interruption.

Discussion continued as to the efficacy of the move of each office.

Councilman Atkins asked if there was a timeline for the accessory items to be completed for Arminio Field; and discussion ensued surrounding Arminio Field and its completion.

Mayor Dansereau asked if there were any questions regarding the ordinances and resolutions listed for voting on the Regular Meeting Agenda, as set forth below.

Councilman Bernier asked about Ordinance Number 2603-19, specifically if the Board of Health has to recodify any ordinances; or if they have to independently adopt the codification.

Borough Attorney, Karen Brown said that the ordinance could be discussed in more detail in Executive Session.

Councilman Fortuna commented on resolution #18 to appoint Jaffe Communications, stating that the numbers don't add up.
