WHEREAS, the parties desire to enter into a Settlement Agreement to memorialize the terms and conditions of their understanding, as well as the respective obligations of the Parties.

Mayor Dansereau then opened the meeting for Public Comment

PUBLIC COMMENT

- 1. Juli-Anne Benjamin, 5th Ward Resident, spoke about Little Free Libraries and bringing the joy of reading to all around her. She explained what a Little Free Library is and the hope that it will expand the availability of books and increase literacy in the community.
- 2. Mr. Drew, Roselle Resident reported an accident that occurred at the corner of E. 2nd
 Avenue and Walnut Street a couple of weeks earlier. He said that speeding and reckless
 driving are the issues affecting the Borough, and that no-one would believe how fast most
 people are driving on the streets. He posited that the remedy for this is a four-way stop.
 He said that the NJ Transit buses and utility trucks are the worst offenders.
- 3. Captain Richard Gregorio, Roselle Fire Department, announced the 22nd Annual Senior Brunch.
- 4. Anthony Esposito, 414 East 3rd Avenue, said that it was his understanding that the Audit Report was recently received. He said that he could imagine that many documents required to complete the audit were not available due to mismanagement by the Administration of 2018. He remarked that for many years, he's complained about the Audit Report being late.
- 5. Michele Johnson, 200 Walnut Street, reiterated the seriousness of the auto accidents that are occurring at the corner of Walnut Street and East 2nd Avenue. She said that she

wished the same energy given to arguing would be put into doing work for the citizens. She commented that she's afraid to park in her yard because people have come into her yard twice. She asked that the Governing Body address this issue immediately. She asked that the Council also reconsider the amount of tax increase; and that the Mayor and Council simply respect each other. She requested more time to speak.

Motion by Councilman Fortuna, seconded by Council President Wilkerson, with all in favor, none opposed, Ms. Johnson was granted an additional minute to speak.

She continued by saying she was glad no students were in the audience to witness the meeting because the behavior of the Council Members was shameful. She also said that if the Council Members don't want to work for the people, they shouldn't take office.

6. Sylvia Turnage commented that the Mayor was the gift that keeps on giving, and that she noticed that another employee was able to sue the Borough and get a settlement. She mentioned the change to the Staffing Levels Ordinance, saying that the Mayor is again trying to hire her good friend. She asked if the Borough was going to let go of some of the media firms we employ. She talked about the Borough Attorney being in charge of the work done by outside Counsel. She said that the issue with the Bill List was super petty; and that if the Council continued to belittle and degrade the Borough Attorney, they would be setting the taxpayers up for another lawsuit.

Motion by Councilwoman Johnson, seconded by Council President Wilkerson, with all in favor, none opposed, Ms. Turnage was granted an additional two minutes to speak.

She continued by stating that the Council is breaking its own laws by allowing the Planning Board Secretary to be paid a salary that is not in the Salary ordinance. She said she didn't know who made the decision to hire the outside Counsel, but suggested that the Mayor and Council follow the proper procedures in doing so in the future.

- 7. Garret Smith, 636 Jackson Avenue, talked about the finances of the Borough, saying that the Borough has an opportunity to save money on insurance by going into the State Health Benefit Plan. He said that real tax savings are not being discussed, but that the Council is discussing cutting the Summer Camp and not sending Council Members to the League of Municipalities. He said that this was not the opportunity to build a plantation. He commented that Executive Sessions are not supposed to be secret meetings to demean people. He said the secretive Ku Klux Klan thing going on and the plan to attack black women was a problem. He said remarked that intimidation through voting and fake investigations were understood because of history; and that the Mayor was not fooling anyone with Councilwoman Wilkerson as a window dressing.
- 8. Jeanne Ryan, Library Director, announced the upcoming Census Job Fair, which would be held at the library.

Seeing no-one else come forward, Mayor Dansereau closed the Public Comment portion of the meeting.

COUNCIL COMMENT

Council President Wilkerson thanked the public for keeping her family in mind and calling to check on her mom. She commented on the issue of auto accidents at the corner of East 2nd Avenue and Walnut Street. She said that the Borough is in fact looking into cost savings for insurance and in other areas. She remarked that residents are correct when they say that the Governing Body members owe them a certain level of decorum. She spoke to the comment that she is just window dressing, saying that she is a proud, strong, African American woman who gives to her community; and is not interested in the opinions of sideliners. She said that brighter days are coming in Roselle.

Councilman Bernier greeted the public and said that he wanted to address some of the comments made by the public. He agreed that the intersection of 2nd Avenue and Walnut Street is dangerous, and said that it requires more permanent solutions. He addressed the 3rd quarter tax bills and the Staffing Levels Ordinance, which adds the position of the Public Information Officer. He talked about the salary of the Planning Board Secretary and said that the law states that the Planning Board can set the salary of the Secretary within their budget. He addressed the comments made by the former Mayor and gave statistics of how taxes increased under the former Mayor's administration. He said that the racial comments by the former Mayor didn't even warrant response. He announced his next Second Ward Meeting and said that the Board of Education President would be his guest at the meeting. He asked residents to check their garbage schedules before they put their garbage, recycling and bulk trash out for pick-up. He gave instructions for downloading Recycle Coach and recommended that all residents use it.

Councilwoman Johnson greeted the public thanked the 3rd Ward Residents for supporting her. She talked about some of her initiatives, including Hoodies for the Homeless, the Circle of Sisters Bus Ride and the Look at Me Now Mentoring Program. She said that she will no longer be shutdown. She commented that she will no longer defend the Municipal Attorney because they are both targets. She asked what could be done when questions are being asked of the Borough Administrator and he can't answer. She iterated that when she speaks, she speaks for her residents. She announced her next Ward Meeting and the Hoodies for the Homeless Event.

Councilwoman Shaw said that she felt like she fell asleep and woke up in a Totalitarian Society where she can't even ask questions. She talked about the role of Council Members and said that they are charged with working on behalf of the people. She remarked that some people always deflect from the issues at hand and go into long dissertations about unrelated subjects. She read the policy of the Governing Body policy regarding the procedure for use of outside Legal Counsel. She said that she was called by Mr. Jalloh and she asked him questions about the investigation that were unanswered. She said that she will not vote to approve anything that she

does not know about and that is unsanctioned. She talked about the League of Municipalities and said that the Mayor and Borough Administrator tried to deny herself and Councilman Atkins the opportunity to attend the League of Municipalities Conference at the Borough's expense. She said that games were played with the budget, asking why there was no budget in April or May. She talked more about issues and said that she will continue to be a voice whether she's on the dais or on her front porch.

Councilman Fortuna greeted the public and thanked Ms. Benjamin for getting involved with literacy in the Borough. He said that he, too, will sponsor a Little Free Library and he gave his email address. He thanked the Board of Education President for coming to his last Ward Meeting and said that she was a hit with the residents. He said that to make progress, we have to step outside of ourselves. He said that the only way we'll make improvements is to work together because we're all one and we all need each other.

Councilman Atkins thanked Ms. Benjamin for the Little Free Libraries initiative. He talked about his feelings toward African American women; and making sure that they are not disrespected in any way. He read a Facebook Post and said that the behavior of some Council Members is absurd. He said that there has been a lot of discussion, but no-one is dealing with root causes. He talked about the League of Municipalities and said that the time spent trying to keep him from going to the League Conference at the Borough's expense should have been spent thinking about cost savings. He talked about insurance rates and said that we could have saved significantly. He said that wrong is wrong and he will always call it out.

MAYOR'S COMMENT

Mayor Dansereau greeted the public and said that she was not going to go back and forth with anyone about the things they said. She referenced the traffic study that had been done and some of the results that it yielded. She spoke to the matter being handled by Jalloh and Jalloh, saying that she is still not at liberty to speak about the situation publicly; but when she can, she will. She said that she knows that she is a target, but she's like an oak tree and that she bends but doesn't work. She said that the rest is just political rhetoric from people who are leaving December 31st. She mentioned the League of Municipalities Annual Conference, saying that it is not just about partying. She talked about the lawsuit brought against herself by Jamel Holley and said that there were Council Members trying to give him more money, but he too got paid by the Borough.

ADJOURNMENT

On a motion by Councilman Fortuna, seconded by Councilman Bernier, with all in favor and none opposed, the meeting was duly adjourned at p.m.
