### INTRODUCTION, CONSIDERATION AND PASSAGE OF ORDINANCES

ORDINANCE ON 2<sup>nd</sup> READING & FINAL PASSAGE — Ordinance 2609-19 AN ORDINANCE AMENDING ORDINANCE NUMBER 2465-13 PROCEDURE FOR PAYMENT FOR POLICE OFFICER OFF-DUTY EMPLOYMENT [Public Hearing December 18, 2019 Pending Approval]

WHEREAS, contractors, utilities, and retailers often require the services of off-duty police officers to direct traffic at shopping centers and construction sites, in and out of the public right of way; and

WHEREAS, retailers often wish to utilize services of an off-duty officer to deter shoplifting and other criminal behavior as well as serving their customers by providing traffic safety services; and WHEREAS, Attorney General Opinion 1997-No 23 provides that regular members of a police department are permitted to engage in such off-duty police services if an arrangement has been made between the private entity and the employing municipality; and

WHEREAS, in order to comply with the Federal Fair Labor Standards Act and the laws of the State of New Jersey which require a municipality to make timely payments to officers but prohibits payments for services rendered prior to the receipt of funds which are to finance the cost of services; and

**NOW, THEREFORE, BE IT ORDAINED**, the Borough of Roselle Finance Department shall establish a general trust account to be known as "Police Outside Employment Account."

**NOW, THEREFORE, BE IT FURTHER ORDAINED**, that the following procedure shall be adhered to:

- A. Whenever a contractor or vendor (hereinafter referred to as the requesting party) requires the services of a police officer, the requesting party shall be required to notify the Chief of Police or his designee (hereinafter referred to as the Chief).
- **B.** The requesting party shall advise the Chief of the scope of the assignment, number of hours, and the number of man hours required.
- C. The Chief shall in his discretion determine the number of hours that can be reasonably anticipated notwithstanding the hours projected by the requesting party, see *infra*
- **D.** The Chief, after consultation with the PBA, shall promulgate a schedule of fees which may vary depending upon the nature of the services, the identity of the requesting party (profit or non-profit and whether the requesting party is a regular requestor. In addition, an administrative fee from 7% to 18% shall be added to the schedule.
- **E.** The schedule of fees shall be reviewed on an annual basis by the Chief and the Chief Municipal Finance Officer and may be changed by ordinance of the governing body.
- **F.** The schedule of charges for 2020 shall be as set forth on the following schedule:
  - 1. Change of Hourly Rate: From \$60.00 to \$80.00 per hour.
  - 2. Terms of Workable Hours: Minimum of four (4) hours covering callout. At least one (1) hour notice of cancellation prior to the start time of the job is required or the four (4) hour minimum applies.
  - 3. Full Day Hours: Any hours worked over the four (4) hour minimum to be compensated to a full Day of Work consisting of a full eight (8) hours.

- **4.** Overtime Rate: Any hours worked beyond eight (8) hours to be compensated at the rate of one and one-half (1-1/2) times the job hour rate and time worked shall be rounded off the next hour.
- 5. Emergency\* Call-Out Rate: To be compensated at the rate of one-half (1 ½) times the job hour rate. \*If less than 12 hours notice is provided.
- **6. Night Hour Rate:** To begin at 1800 hours and to conclude at the **completion** of the officer's detail assigned. To be compensated at a rate of one and one-half (1-1/2) times the job hour rate.
- 7. Weekend Hour Rate: To include any detail that is started on a weekend (Saturday or Sunday). Other than regular monthly posted details with predetermined terms and conditions. To be compensated at a rate of one and one-half (1 ½) times the job hour rate. Rate is to remain in effect until the completion of the detail assigned even if it concluded on a Monday.
- 8. Holiday Rate: Consisting of any known holiday when the United States Post Office or Public Schools are closed. To be compensated at a rate of one and one-half (1 ½) times the job hour rate.
- 9. Exempt Details: All regular posted scheduled details will be compensated at normal rate and terms. Excluding the night hour and overtime rate charges that have been set when detail is secured.
- 10. Sporting Events: \$150.00 per event
- 11. Special Events: From \$45.00 per hour to \$60.00 with a 4 hour minimum, and the rate remaining from \$45.00 to \$60.00 each additional hour. (Special events consist of private and school functions, dances, raffles and fundraisers, night clubs.)
- **12.** The Rates for Regular Posted Scheduled Details: will be compensated at normal rate and terms that have set when the detail is secured.
- 13. Marked Police Vehicle: Marked Police Vehicle at certain off-duty traffic details when requested by the contractor and/or needed for safety reason from the rate of \$100.00 to \$150.00 per day. This rate will be paid to the town, not the officer.
- **G.** It shall be the obligation of the Chief or his designees to ensure that subscriber's checks are presented to the finance officer within forty-eight hours of receipt.
- **H.** Should a subscriber fail to make payment in a timely fashion, termination of the services shall result.
- I. The rate of \$1.00 per hour of pay earned by each officer assigned Outside Duty Employment shall be transferred to P.B.A. Local 99 to be deposited in its treasury.
- **J.** General. The aforementioned recitals are incorporated herein as though fully set forth at length.
- **K.** Severability. If any part of this Ordinance shall be deemed invalid, such parts shall be severed and the invalidity thereby shall have not affect the remaining parts of this Ordinance.
- L. Availability. A copy of this Ordinance shall be available for public inspection at the offices of the Borough Clerk.

M. Effective Date. This Ordinance shall take effect at the time and in the manner as approved by law.

All ordinances and part of Ordinances inconsistent with the terms hereof are hereby repealed to the next extent that same are inconsistent herewith.

Mayor Dansereau read Ordinance Number 2609-19 by title and opened the Public Hearing on the ordinance.

### **RESOLUTION NUMBER 2019-308**

## A RESOLUTION ESTABLISHING THE BOROUGH OF ROSELLE COMPLETE COUNT COMMITTEE

WHEREAS, preparations for the 2020 U.S. Census are well underway, signaling once again our nation's decennial effort to count and analyze its growing population; and

WHEREAS, the Census, mandated by Article 1, Section 2 of the U.S. Constitution, is a civic activity that affects people of all ages, races, cultures, and ethnicities; and

WHEREAS, the importance of a complete and accurate 2020 Census cannot be overstated, as its results help decide how more than \$675 billion in federal funds are spent annually across the country on services ranging from emergency response and fire departments to clinics and hospitals; and

WHEREAS, Census results also determine the number of Congressional districts that New Jersey is allotted and will also be used to draw state legislative district lines; and

WHEREAS, failing to achieve a complete count of the Borough of Roselle's residents could deny funding in federal grants for each person not counted; and

**WHEREAS,** when Census Day arrives on April 1, 2020, people will, for the first time, be able to respond anytime and anywhere, online, from any device, by mail or by phone; and

WHEREAS, conducting the 2020 Census will nonetheless be a massive human undertaking, requiring the hiring of thousands of workers, community leaders, and volunteers to carry it out.

**NOW THEREFORE RESOLVED,** that the Mayor and Council of the Borough of Roselle do hereby proclaim that April 1, 2020 as "2020 Census Full Participation Day" throughout the Borough of Roselle. In doing so, we pledge our full support to a thorough and accurate count of all Roselle residents. We urge all of our municipal counterparts to do likewise, and we commend the U.S. Census Bureau for all of its hard work toward achieving this objective.

**BE IT FURTHER RESOLVED,** that the Mayor and Council of the Borough of Roselle desires to establish a "Complete Count Committee" whose objective will be to advise and assist the Mayor and Borough Council in working towards "2020 Census Full Participation Day" and achieving an accurate 2020 Census count by increasing awareness and response rates by motivating residents to respond to the 2020 Census through events and activities.

a. The Mayor and a member of Council shall be members of the Complete Count Committee. In addition, the Mayor shall appoint other Borough Officials and members of the Roselle community to serve on the Committee including, but not limited to; head(s) of the public

school system, head(s) of the public library, business community, faith-based organization or place of worship, and major community organizations such as JCC and YMCA. The names and members of the "Complete Count Committee" being appointed today are attached to this resolution as Exhibit A.

- b. The Mayor reserves the right to add or delete members of the Complete Count Committee as deemed necessary and/or appropriate.
- c. The Complete Count Committee is designed as an ad hoc subcommittee of the Mayor and Borough Council of the Borough of Roselle and shall serves at the pleasure of the Mayor and Borough Council. The Complete Count Committee shall disband after the 2020 U.S. Census is completed or when the Mayor and Borough Council deem appropriate
- d. The Complete Count Committee shall organize immediately upon its appointment. The Mayor shall serves as Chairman of the Complete Count Committee and can appoint other members to serve in leadership roles as necessary. All members will serve without compensation, except they may be reimbursed for out-of-pocket expenses.
- e. The Complete Count Committee shall hold meetings and events as necessary to accomplish its goal of a complete count of the Borough of Roselle.
- f. The Mayor and Borough Council may appropriate funds for expenses and authorize the Complete Count Committee to expend such funds, at their option, by majority vote.
- g. The Complete Count Committee shall have the right to draw upon the resources of the Borough, which shall include, but not limited to such other consultants and/or members of the public to enable it to accomplish its goals and objectives. The use of the above individuals will be coordinated and approved by the Borough Administrator or designee.
- h. The Borough Clerk is directed to forward an adopted copy of this Resolution to each member of the Complete Count Committee.

WHEREAS, the Borough of Roselle strongly believes in and supports open transparent government, and that citizens and residents have the right to be informed about the workings of government in order to best participate in a democracy; and

WHEREAS, on January 8, 2002 then Acting Governor DiFrancesco signed into law the Open Public Records Act (OPRA) which mandates that government records shall be available, with limited exceptions, for public access and simplifying the procedures for requesting specific records; and

WHEREAS, the intent of the law was to provide the public with easy access to government records with an uncomplicated process for obtaining the records and eliminating bureaucratic red tape; and

- WHEREAS, over the course of 18 years OPRA has been a positive light, but it has also been fraught with abuse and misuse, and has become an unanticipated financial cost to the taxpayers of New Jersey; and
- WHEREAS, the Borough of Roselle has labored under a well-intended law that has spiraled out of control, due to the volume and nature of requests, the cost to taxpayers in responding to the requests, and the potential liability in having to pay disproportionate prevailing party attorney's fees should the request turn into litigated matters, as well as the liability in determining which documents shall be released, with or without redaction, while attempting to maintain individual privacy; and
- WHEREAS, it is not only the volume of OPRA requests that challenge our resources, but it is also the cost associated with reviewing, retrieving, and processing the OPRA requests(s) by public personnel and counsel and possibly defending our actions(s) before the Government Records Council or in Superior Court; and
- **WHEREAS**, the Borough of Roselle received and responded to approximately 853 requests in 2016, 862 in 2017, 1057 in 2018 and in 2019 has received and responded to 966 as of December 11, 2019; and
- WHEREAS, the requirements of Municipal clerk's role in the law are broad and complex; the requirements of OPRA, time to respond, what to redact, the redacting process, denial of records, failure to be able to locate records; and the consequences to the clerk in this law are unfair; and
- WHEREAS, due to the often conflicting case law and Government Record Council decisions, as well as the unique characteristics of OPRA requests, the Borough of Roselle must often times rely on the municipal attorney to review certain OPRA requests, resulting in additional fees in in response to OPRA request in response to OPRA requests; and
- WHEREAS, requests for records that must be located via IT staff have costed thousands of dollars and taken countless hours of the Municipal Clerk's time, prohibiting and affecting all of her other many responsibilities; and
- WHEREAS, with limited exceptions OPRA has not been amended to address the clear and apparent advancement in technology that has changed the way government records are created, stored, and/or the ever increase cost to taxpayers; and
- WHEREAS, as the current law approaches it twentieth (20<sup>th</sup>) anniversary, it has outgrown its original intended use and has become ripe for comprehensive review and reform;
- NOW, THEREFORE, BE IT RESOLVED, that the Governing Body of the Borough of Roselle in the County of Union, New Jersey, appeals to the legislature to form a Commission comprised of Mayors, Municipal Clerks, Municipal Managers, Attorneys, Police Chiefs, open government advocates, privacy experts, members of the media, citizens and other

Mayor Dansereau then declared the meeting open for general public comment.

### **PUBLIC COMMENT**

- 1. Lorraine Brooks-Body, talked about the 2020 Census and her experience using the Census Track. She stated that she is definitely qualified to be a part of the Complete Count Committee. She said that it was a shame that the Borough cannot find the documentation needed for FEMA.
- 2. Mr. Drew talked about traffic safety and the accidents that occur near his crossing guard post. He also mentioned that there were some scheduling issues with the Crossing Guards and that a communication breakdown caused all Crossing Guards to be shorted two-days' pay. He asked that a definitive chain of command and lines of communication be established.
- 3. Sylvia Turnage, Roselle Resident, thanked Councilwoman Shaw and Councilman Atkins for their service to the Borough, as well as Borough Attorney, Karen Brown. She asked if there was a stipend in the budget to pay anyone who will volunteer on the Complete Count Committee. She talked about the need to recover paperwork for FEMA; and said that someone could have at least suggested that the company hired to recover the documents give a presentation. She said that she has asked time and time again about the Public Information Officer; but the position has now showed up on the Borough website; but that the closing date of the application was Thanksgiving Day.
- 4. Sam Bishop asked how someone from the outside could possibly find what people inside the Borough had not been able to find. He thanked Council Members Shaw and Atkins
- 5. Shekinah Atkins, presented an award to her father, Councilman Reginald Atkins.
- 6. Cynthia Atkins, presented an award to Councilwoman Shaw and said that she looks forward to the next season of life for her husband, Councilman Atkins. She also sang a song.

- 7. Courtney Washington Roselle Resident, thanked Councilman Atkins for helping put Bold Community Care Services on the map. She then presented an award to Councilwoman Kim Shaw.
- 8. Garrett Smith, 636 Jackson Avenue, voiced his concerns about computers and Finance. He said that it is not clear where the Borough is in reference to the cyber security breach. He asked why the Mayor and Council went to Atlantic City to stay at the most expensive hotel, when there are residents struggling to stay in their homes. He said there seems to be some confusion on the Pothole Killer, as the funds seems to have been spent before it was transferred.

Seeing no-one else come forward, Mayor Dansereau closed the Public Comment Portion of the meeting.

### **COUNCIL COMMENT**

Council President Wilkerson, congratulated young scholar, Erica Igere. She thanked Freeholder Andrea Staten for being so thoughtful; and bringing toys for the 3 Kings Celebration and Proclamations for the outgoing Council Members. She thanked Lorraine Brooks-Body for volunteering for the Complete Count Committee, and said that she's a great example of people in the community to want to help where needed. She thanked Council members Atkins and Shaw for their service to the Borough. She addressed Mr. Drew and thanked him for informing the Council of the accident he talked about. She talked about the Pothole Killer and the need for paperwork to submit for FEMA. She encouraged everyone to check on their neighbors.

Councilman Bernier said that he wanted to echo Council President Wilkerson's sentiments, and encourage everyone to check on their neighbors. He gave an update on the cyber security breach, saying that the Borough has replaced computers and upgraded to Windows 10. He gave an update from the Planning Board and said that they approved the signage for the Dollar Tree on St. Georges Avenue. He thanked Councilwoman Shaw and Councilman Atkins for their service to the Borough and wished them well. He addressed some of the issues brought up during public comment, including the accidents at Walnut and 2<sup>nd</sup> Avenue; FEMA paperwork recovery and budget transfers. He congratulated the two new Police Officers and wished the Borough of Roselle a happy 125<sup>th</sup> birthday.

Councilwoman Johnson read statistics from the Police Department Monthly report. She commended the Police and Fire Departments for doing a phenomenal job keeping their books in order and not going over budget. She said she had concerns about being questioned about the work being done on her home; and said that everything was done in order with the proper permits. She commended Councilwoman Shaw on a job well done and said that she learned a lot from her. She thanked Councilman Atkins for challenging her and helping her grow. She wished them both well and asked for their continued support. She thanked everyone who came out and said that she's looking forward to working with the newly elected Council Member. She talked about the accident that Mr. Drew mentioned and said that she's fighting for the safety of Mr. Drew and the students he crosses every day.

Councilwoman Shaw thanked the public and said that it was an honor to serve the Borough over the years. She spoke about issues with the Finance Department and the way money was budgeted. She talked at length about an investigation conducted by outside counsel that was not assigned by the Borough Attorney. She said that she hoped the people on the dais would be impartial and fair to those they are elected to serve.

Councilman Fortuna said bid best wishes to Council Members Shaw and Atkins. He gave an update from the DPW Committee regarding Wood Avenue and the Shade tree Division. He talked about budget transfers and the Pothole Killer, stating that transfers were not made illegally. He posited that people often tend to look for perfect solutions and get upset when there is no perfect solution available. He said that he had a great first year as a Councilman listening to people; and that is what he really likes about being a Councilman. He thanked everyone for making his first year great and giving him the opportunity to serve.

Councilman Atkins said that it was a delight to see everyone out at the meeting. He thanked the Borough Attorney for a job well done; and he thanked the Borough Clerk for always being courteous and helpful. He thanked his family for their support and said that he thanks God for them. He wished the Mayor and Council Members well and bid all a goodnight.

### **MAYOR'S COMMENTS**

Mayor Dansereau greeted the public and thanked everyone for coming out to the meeting. She extended her thanks to all who donated toys and volunteered for the Make a Child Smile Toy Drive. She said that the holidays are a hard time for some, as the loss of loved ones looms over many; but that she prays for brighter days. She said that in spite of a challenging year, the CFO, Tax Collector and Finance Committee were able to work together to put together a responsible budget. She commended the Borough Administrator for working around the clock to take care of the operations of the Borough. She talked about the Economic Development Representative, Victor Klymenko; and she lauded the efforts and accomplishments of the Grant Writer, David Biunno. She announced the formation of the Neighborhood Preservation Program (NPP) Grant Committee and said redevelopment is a priority. She said that her vision is to see Roselle flourish into a community where all are served. She said that she believes that there is hope and growth in the future for Roselle. She wished everyone Happy Holidays and a Happy New Year; and wished the best to Council Members Atkins and Shaw.
