COUNCIL COMMENT

Councilwoman Sousa said that she hoped everyone had a great Mother's Day and gave condolences to the families who had lost loved ones. She also gave condolences to the Walker and Atkins families. She said that the day was a very special day in Portugal. She acknowledged Principal Andreea Harry and the Dr. Charles C. Polk School for the Mother's Day/ Community Appreciation Parade. She said that the Census was very important and encouraged everyone to complete it.

Councilman Bernier had no comments.

Councilwoman Johnson had no comments.

Councilwoman Thomas acknowledged Nation Police Week and thanked Chief Barnes for all the work the Police Department does in Roselle. She reminded residents to complete the 2020 Census and extended her condolences to the Atkins and Ivy Families.

Councilman Fortuna gave his condolences to the Atkins Family, and all families who had lost loved ones within the past month. He addressed the questions about bulk trash puck-up, which he

Council President Wilkerson echoed the encouragement of her colleagues, to get the 2020 Census completed. She gave her condolences to the Atkins, Blaize and Hossain Families. She said that the Council has tough decisions to make and that she was confident that the Borough would continue to press through the pandemic.

MAYOR'S COMMENTS

Mayor Dansereau addressed the loss of Ms. Dorothy Mae Dobbins and mother Lona Wiggins Nixon, saying that they were very personal losses. She gave her condolences to the Atkins Family and all families who had recently lost loved ones. She asked that everyone keep long time 5th Ward Resident, Alberta McLeod in their thoughts and prayers. She talked about the banner that was ordered to honor the Abraham Clark graduating class of 2020. She said that there would be more signage to promote the 2020 Census and lights to decorate Chestnut Street being put up soon. She announced that there would be a Memorial Day Ceremony, although there would be no traditional parade and festivities. She talked about the coronavirus and herd immunity. She said that the Motor Vehicle Commission was providing many services online, including license renewal.

Motion by Councilman Bernier, seconded by Councilwoman Johnson, to adopt Resolution Number 2020-150 and go into Closed Executive Session.
