Motion by Councilman Bernier, seconded by Councilman Fortuna to adopt Resolution Number 2020-165.

Discussion:

Councilwoman Johnson talked about previous confusion regarding estimated tax bills; and asked for clarification on the resolution.

Tax Collector, Michael Schnurr, explained that the estimated levy came from the Finance Committee

Councilman Bernier added that the increased amount comes from the School Board Budget, which increased 2%; and the increased valuation in the Borough added to the Library Budget. He said that the County of Union also increased taxes. From the Borough side, there was no increase.

RESOLUTION NUMBER 2020-165

RESOLUTION AUTHORIZING THE TAX COLLECTOR TO PREPARE AND MAIL ESTIMATED TAX BILLS IN ACCORDANCE WITH P.L. 1194, C 72

WHEREAS, due to the late adoption of the State of New Jersey's budget the County Board of Taxation is unable to certify the tax rate at this time and the Tax Collector will be unable to mail the tax bills on a timely basis;

WHEREAS, the Tax Collector in consultation with the Chief Financial Officer has computed an estimated tax levy in accordance with N.J.S.A. 54:4-66.3, and they have signed a certification showing the tax levies for the previous year, the tax rates and the range of permitted estimated tax levies;

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE BOROUGH OF ROSELLE, IN THE COUNTY OF UNION AND THE STATE OF NEW JERSEY as follows:

- 1. The Tax Collector is hereby authorized and directed to prepare and issue estimated tax bills for the municipality for the third installment of 2020 taxes. The Tax Collector shall proceed and take such actions as permitted and required by P.L. 1994, c72 (N.J.S.A. 54:4-66.2 and 54:4-66.3).
- 2. The estimated tax levy for 2020 is hereby set at \$66,271,484.46.
- 3. In Accordance with law the third installment of 2020 taxes shall not be subject to interest until the later of; the grace period or the twenty-fifth calendar day after the estimated tax bills were mailed. The estimated tax bills shall contain a notice specifying the date which interest may begin to accrue.

Workshop Meeting (Cont'd)

Councilwoman Johnson asked for an explanation of the fees itemized in Ordinance Number 2624-20, particularly sections (D) and (E).

Councilman Fortuna stated that the Ordinance is designed for most instances where homeowners leave homes and that the fees simply cover the cost of manpower and disposal fee that the Borough is charged in those instances. He said the Borough is just trying to recoup some revenue

Councilman Bernier stated that he was able to find any chapter of the Borough Code entitled "Bulk Trash," so he didn't see how an ordinance that did not exist could be amended. He expressed his concern at making the Department of Public Works an "a la carte" service. He said that all of section 4 was in conflict with Chapter 715 of the Borough Code; and asked if the Borough Attorney had looked at the ordinance.

Borough Attorney, Mohamed Jalloh, answered that he did look over the ordinance.

The consensus was to pull Ordinance Number 2624-20 from the agenda.

Councilwoman Johnson talked about Ordinance Number 2625-20, saying that homeowners should not have to maintain anything that does not belong to them.

Borough Attorney, Mohamed Jalloh said that the ordinance was nothing new; and standard for numerous municipalities across the state.

Councilman Bernier spoke to Resolution Number 4; and asked if it was known what was included in the grant and what streets were covered.

Borough Administrator, Jack Layne, responded that he had inquired with Jacqueline Dirmann from Maser Engineering; and was expecting a full report. He did say that Drake and 4th Avenues were mentioned.

With regard to Resolutions 7 through 9, he asked why not approve the prosecutors from the date of the meeting through December 31st, then go back out for RFP with the rest, in January.

Eric M. Walker, II, Purchasing Agent, gave the rationale for approving the prosecutors on a Fiscal Year cycle.

COUNCIL COMMENT

Councilwoman Sousa acknowledged the protests and said that walking along the community was very deep and powerful. She said that she would continue to pray for those affected by COVID-19; and encouraged everyone to complete the census.

Councilman Bernier had no comments.

Councilwoman Johnson thanked everyone who had participated in the Black Lives Matter marches and protests.

Councilwoman Thomas had no comments.

Councilman Fortuna said that the West 9th Paving Project was on schedule for the following week.

Council President Wilkerson had no comments.
