ORDINANCE ON 1ST READING & INTRODUCTION – Ordinance Number 2695-22

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 155 CANNABIS ESTABLISHMENTS

Borough of Roselle Page 3 of 41

WHEREAS, pursuant to N.J.S.A. 40:48-2 and N.J.S.A. 24:6I-45, the Borough of Roselle ("Borough") previously established zoning requirements and regulations governing personal use cannabis and medical cannabis, including a local license requirement for cannabis establishments who wish to open and operate such businesses within Borough, and a limit on the number of local licenses that may be issued for each class of cannabis establishment; and

WHEREAS, the Mayor and Borough Council have determined that it is in the best interests of the Borough to amend and supplement its regulations governing personal use cannabis and medical cannabis within the Borough, and to provide clarification to prospective licensees regarding the requirements for obtaining a local cannabis license and operating a cannabis business within the Borough.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Borough Council of the Borough of Roselle as follows:

SECTION I. The Code of the Borough of Roselle, Part IV, Chapter 155 Cannabis Establishments, is hereby amended and supplement as follows (additions in **bold and underline**, deletions struck through):

Chapter 155 Cannabis Establishments
§ 155-2 (Reserved) Cannabis establishments prohibited.
Pursuant to Section 31b of the New Jersey-Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act (P.L. 2021, c. 16), all Class 1 cannabis establishments are hereby prohibited from operating anywhere in the Borough of Roselle.
§ 155-3 Cannabis establishments allowed. Class <u>1</u> 2 through 6 Cannabis establishments shall be permitted, pursuant to this chapter, only if the following requirements are complied with

B. Prior to the operation of any cannabis establishment, a permit or license must be obtained from the state and from the Borough of Roselle for the applicable type of cannabis establishment. No cannabis establishment shall be permitted to operate without state and municipal permits or licenses (including, but not limited to, a certificate of occupancy issued by the Borough).

J. Customer Congestion. Cannabis establishments shall implement appropriate procedures for addressing potential issues arising from customer congestion, and shall ensure that their customers and vendors do not impede pedestrian or vehicular traffic over or to neighboring public and private properties (including streets and sidewalks).
K. Police Support. When necessary to address crowd and/or traffic issues, Cannabis
establishments are responsible for obtaining police support pursuant to § 83-16 of the Borough Code.

If the Borough receives multiple pending license applications from the Commission, the Borough shall provide input to the Commission as to the municipality's preferences for licensure in ranking order from the first to last, respectively, for each class of license and each applicant that meets the Borough's requirements set forth in Subsection K.
F. Unless the Borough has previously advised the Commission, in writing, that it is opposed to the application of an applicant for a state license, a A Borough license shall be issued to an applicant that has:
(1) rReceived an annual license from the Commission—and ranked by the Borough Council in preferences if the requirements contained in Subsection J are satisfied; (2) Satisfied the requirements contained in Subsection K, and demonstrated that

ORDINANCE ON 1ST READING & INTRODUCTION – Ordinance Number 2696-22

AN ORDINANCE AMENDING CHAPTER 110 "ACTIVITIES, OUTDOOR," SECTION 1, "DEFINITIONS," SECTION 3, "LICENCES; GENERAL PROVISIONS," AND SECTION 11, "VIOLATIONS AND PENALTIES"

WHEREAS, the Mayor and Council of the Borough of Roselle, in the County of Union, New Jersey (the "Borough"), a public body corporate and politic of the State of New Jersey (the "State"), wishes to create licensing requirements for food drives and community outreach/engagement activities, and prohibit drive-through food drives, in order to protect the health, safety and general welfare of the community, and minimize traffic congestion; and

WHEREAS, the Borough finds it necessary to amend the Borough General Ordinances to include food drives and community outreach/engagement among defined Outdoor Activities, in order to ensure that such events are organized and approved in accordance with State and local regulations, and to minimize disruptions to traffic; and

WHEREAS, the Borough also seeks to amend the license fee for Garage sales to be consistent with the Borough application form for outdoor activity licenses.

NOW THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Borough of Roselle that the Code of the Borough of Roselle, Part IV, Chapter 110 is hereby amended as follows:

SECTION I. The aforementioned recitals are incorporated herein as though fully set forth at length.

SECTION II. The Code of the Borough of Roselle, Part IV, General Ordinances, Chapter 110 Activities, Outdoor, Section 1, Entitled "Definitions," is hereby supplemented to include the following (in alphabetical order):

§ 110-1 **Definitions.**

COMMUNITY OUTREACH/ENGAGEMENT

Gatherings to create community support groups, advocate for community issues, political campaigning, gift and other donation drives.

FOOD DRIVE

A charity event dedicated to collecting food items for distribution to persons who cannot afford food.

SECTION III. The Code of the Borough of Roselle, Part IV, General Ordinances, Chapter 110, Activities, Outdoor, Section 3, entitled "Licenses; general provisions," Subsection A, entitled "General provisions," is hereby supplemented as follows:

(4) Drive-through food drives are prohibited.

SECTION IV. The Code of the Borough of Roselle, Part IV, General Ordinances, Chapter 110 Activities, Outdoor, Section 3, Entitled "Licenses; general provisions," Subsection B.(4), Entitled "Deposits," is hereby amended and supplemented as follows (additions in **bold**, deletions struck through):

SECTION IV. The Code of the Borough of Roselle, Part IV, General Ordinances, Chapter 110 Activities, Outdoor, Section 11, Entitled "Violations and penalties" is hereby supplemented as follows (additions in **bold**):

Failure to obtain a license for an outdoor activity shall be deemed a violation of this chapter.

The sponsor, licensee, the promoter and vendors/operators/concessionaires or their agents shall, upon conviction of a violation of provisions of this chapter, be punished by a fine not exceeding \$2,000, incarceration not exceeding 90 days, or both, per violation to be set by the Municipal Judge. Each day a violation persists shall be a separate violation. Any person participating in or attending an outdoor activity who shall negligently or willfully break, injure or destroy any public or Borough-owned property, or injure, break or destroy any street or guide sign or post, lamp or light bulb or appurtenances thereof or other public property or Borough-owned property on any public street, park or place shall, upon conviction of thereof, be punished by a fine not exceeding \$2,000, incarceration not exceeding 90 days, or both, per violation to be set by the Municipal Judge.

SECTION V. If any section, subsection, provision, clause, or portion of this ordinance is adjudged unconstitutional or invalid by a court of competent jurisdiction, such adjudication shall not affect the remaining sections, subsections, provisions, clauses, or portions, which shall be deemed severable therefore.

SECTION VI. All ordinances or parts of ordinances inconsistent with or in conflict with this Ordinance are hereby replaced and/or repealed to the extent of such inconsistency.

SECTION VII. This Ordinance shall take effect at the time and in the manner provided by law.

RESOLUTION NUMBER 2022-340

RESOLUTION RATIFYING CREATION OF CANNABIS COMMITTEE AND ADOPTING CRITERIA FOR EVALUATING AND RANKING CANNABIS BUSINESS APPLICATIONS

WHEREAS, pursuant to N.J.S.A. 40:48-2 and N.J.S.A. 24:6I-45, the Borough of Roselle ("Borough") previously established zoning requirements and regulations governing personal use cannabis and medical cannabis, including a local license requirement for cannabis establishments who wish to open and operate such businesses within Borough, and a limit on the number of local licenses that may be issued for each class of cannabis establishment; and

WHEREAS, due to the limit on local licenses, in the event that the Borough receives multiple cannabis business license applications, Sections 155-5(C) and (D) of the Borough Code requires that the applicants be evaluated based on a set of public interest factors, and ranked in order of the Borough's preference; and

WHEREAS, in order to assist with the evaluation and ranking of cannabis business applications, the Borough Council wishes to formally recognize and ratify the creation of a Cannabis Committee, consisting of the Mayor, Council President, one Council member, the Borough Administrator, the Borough Planner, and Chief of Police, which shall be responsible for providing recommendations to the Borough Council as a whole with respect to the evaluation and ranking of local license applications; and

WHEREAS, to provide clarity to prospective local license applicants, and ensure that applications are evaluated fairly and consistently, the Borough Council believes that it is in the best interest of the Borough to adopt a detailed set of weighted evaluation criteria, based on the public interest factors set forth in Sections 155-5(D) of the Borough Code, which shall be used in the evaluation and ranking of local cannabis business license applications.

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Roselle, County of Union, State of New Jersey, that the creation of a Cannabis Committee, consisting of the Mayor, Council President, Councilman Bernier, the Borough Planner, the Borough Administrator and Chief of Police, is hereby ratified.

BE IT FURTHER RESOLVED that the Cannabis Committee is responsible for providing recommendations to the Borough Council with respect to the evaluation and ranking of local license applications and, for this purpose, the Cannabis Committee may solicit the input of other Borough Department and non-elected Borough officials as it deems necessary to assist in providing information and analysis with regard to cannabis business license applications.

BE IT FURTHER RESOLVED that the weighted evaluation criteria attached hereto is hereby adopted for use by the Borough Council when ranking applicants for a local cannabis business license when necessary, in accordance with the public interest factors set forth in Section 155-5(D) of the Borough Code.

BE IT FURTHER RESOLVED that the attached weighted evaluation criteria may be reevaluated and modified from time to time by the Borough Council by way of further resolution.

WHEREAS, said resolutions also authorized and directed the Borough's Planning Consultant, Maser Consulting P.A., now known as Colliers Engineering & Design Inc. (hereinafter "Colliers"), to perform the preliminary investigation and prepare a report containing its findings; and

WHEREAS, Colliers undertook the preliminary investigation and prepared a report containing its findings entitled "Redevelopment Area with Condemnation: Determination of Need Study Block

2601, Lots 10-16, Block 2602, Lots 7-17, Block 2603, Lots 4-9, Block 2901, Lots 14-19" (the "Report"); and

WHEREAS, based on the reasoning set forth in the Report, the recommendation of the Planning Board, and in accordance with the requirements set forth in the Redevelopment Law, the Borough Council duly adopted Resolution No. 2022-312 on September 21, 2022, designating the properties in the Study Area identified on the tax maps of the Borough as Block 2601, Lots 14 &16; Block 2602, Lots 7, 8, 9, 10, 11, 12, 15, 16, & 17; Block 2603, Lots 4, 4.01, 6, 7, & 9; and Block 2901, Lots 14, 15, 16, 17.01, & 19 (the "Non-Condemnation Redevelopment Area") as noncondemnation area in need of redevelopment and designating those properties in the Study Area identified as Block 2601, Lots 10, 11, 12, 13, & 15; Block 2602, Lots 13 & 14; and Block 2603, Lots 5 & 8 (the "Condemnation Redevelopment Area" and together with the 'Non-Condemnation Redevelopment Area' the "Redevelopment Area"); and

WHEREAS, to carry out its powers under the Redevelopment Law, the Borough has a need for professional planning consultant services in connection with the preparation of a Redevelopment Plan (the "Redevelopment Plan") for the Redevelopment Area (the "Services"); and

WHEREAS, the Borough of Roselle (the "Borough") desires to undertake redevelopment projects within the Borough and the planning services desired by the Borough are in the best interest of the health, safety and welfare of the general public of the Borough; and

WHEREAS, the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1 et seq. (the "Redevelopment Law") sets forth a specific procedure for establishing an area in need of redevelopment to empower and assist local governments in efforts to promote redevelopment; and

WHEREAS, the Borough Council previously adopted a resolution authorizing and directing the Planning Board of the Borough (the "Planning Board") to conduct a preliminary investigation to determine whether the properties identified as Block 3802, Lots 25, 26, 27 & 28 on the Borough's official tax map (the "Original Study Area") meet the criteria set forth in the Redevelopment Law for designation as an area in need of redevelopment; and

WHEREAS, thereafter, the Borough determined to expand the Planning Board's preliminary investigation of the Original Study Area to include the following additional properties identified as Block 4802, Lots 2 and 3 on the Borough's official tax maps and the property known as Laurel Street, a "paper street" on the Borough's official tax maps, (the "Additional Study Area" and together with the 'Original Study Area', the "Study Area") and determine whether the entire Study Area meets the criteria set forth in the Redevelopment Law for designation as an area need of redevelopment; and

WHEREAS, if the Study Area is determined to meet the criteria for designation as an area in need of redevelopment and the Borough so designates the Study Area, then the Borough shall be authorized to exercise the powers provided under the Redevelopment Law for use in a redevelopment area, including the power of eminent domain; and

WHEREAS, the Borough previously issued a Request for Qualifications seeking engineering and design services and received responses from several firms; and

WHEREAS, on January 4, 2022, the Borough Council, after review of responses, deemed certain firms, including Colliers Engineering & Design (the "Planning Consultant"), as "Qualified" in accordance with the terms of the Request for Qualifications (Resolution No. 2022-18) and the Borough Council subsequently awarded the Borough Engineering Contract to the Planning Consultant (Resolution 2022-0055); and

WHEREAS, the Planning Consultant is familiar with the process necessary to conduct a preliminary redevelopment area investigation, and has performed similar services for the Borough and other municipalities; and

WHEREAS, on May 18, 2022, the Borough Council adopted Resolution 2022-182, authorizing the Planning Consultant to perform the preliminary investigation to determine whether the properties in the Original Study Area qualify as an area in need of redevelopment, in accordance with a proposal dated May 2, 2022 (the "Proposal"), in an amount not to exceed Fourteen Thousand Seven Hundred Seventy Dollars (\$14,770.00); and

WHEREAS, the Planning Consultant advised that it will perform the preliminary redevelopment area investigation of the Additional Study Area in accordance with the terms and limits, including the not to exceed amount, set forth in the Proposal; and

WHEREAS, the Borough Council has deemed it necessary and in the best interest of the Borough to retain the Planning Consultant to perform the Services and now desires to direct the Planning Consultant to perform the Services described therein with respect to the Additional Study Area; and

WHEREAS, the Chief Financial Officer has previously certified that sufficient funds are available within the current and/or previously adopted budget for said purpose.

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Roselle, in the County of Union, as follows:

<u>Section 1:</u> The foregoing recitals are incorporated herein as though fully set forth at length.

Section 2: The Roselle Planning Board is hereby directed to undertake a preliminary investigation and conduct a public hearing to determine whether the properties in the Study Area

Borough of Roselle Minutes of the November 9, 2022 Regular Meeting Minutes meet criteria necessary for designation as an area in need of redevelopment under the Redevelopment Law and, if the Study Area so qualifies, to recommend whether it should be so designated.

<u>Section 3:</u> In the event the governing body designates the Study Area as a redevelopment area, the Borough shall be authorized to use the powers provided under the Redevelopment Law for use in a redevelopment area, including the power of eminent domain.

<u>Section 4:</u> The Planning Consultant is hereby authorized to perform the preliminary investigation to determine whether the properties in the Additional Study Area, qualify as an area in need of redevelopment, in an amount that, together with the investigation regarding the Original Study Area, will not exceed Fourteen Thousand Seven Hundred Seventy Dollars (\$14,770).

WHEREAS, the Site is located in the Mixed-Use Commercial Sub-Zone of the Central Roselle Revitalization Plan Area, Amendment # 11, where "Cannabis Retailer" is a conditionally permitted use pursuant to the Central Roselle Revitalization Plan, if the following conditions are met:

- (a) Said establishment shall be licensed and shall be located more than 1,000 feet from the property line of any elementary or secondary school property; and
- (b) No outdoor consumption areas are permitted; and

WHEREAS, the zoning officer of the Borough has analyzed the applicable law and public records and has made such other inquiries as necessary and opined that the proposed site is appropriate as a cannabis micro-dispensary if the conditions contained in Amendment # 11 of the Central Roselle Revitalization Plan are met; and
