RESOLUTION NUMBER 2022-229 (WO)

A RESOLUTION OF THE GOVERNING BODY OF THE BOROUGH OF ROSELLE FORMALLY CENSURING COUNCILWOMAN CYNTHIA JOHNSON

WHEREAS, it is imperative that each member of the Governing Body conducts his or herself to reflect the highest standards of honesty, integrity, and ethical conduct; and

WHEREAS, it is imperative that a public meeting be conducted in an orderly manner, without deliberate interruption in order to serve the needs of our residents; and

WHEREAS, Councilwoman Cynthia Johnson, ("Councilwoman Johnson"), has conducted herself in ways that have negatively impacted the day-to-day operations of the Borough of Roselle ("Borough"), has continuously acted in blatant disregard of the Council Bylaws, has disrupted public meetings, and overall has failed to conduct herself appropriately as a member of the Governing Body; and

WHEREAS, Councilwoman Johnson has performed the following specific acts, which the Governing Body has determined amount to conduct unbecoming her office and does not reflect well on the Borough:

- 1. Has used her position as Public Safety Committee Chair to interfere with the operations of the Borough's Police and Fire Departments, including but not limited to calling and directing the Chiefs to assist her in the intimidation of Chief Financial Officer, Anders Hasseler and seeking information about crimes and fires within the Borough for the sole purpose of creating photo opportunities or otherwise unnecessarily inserting herself into the emergency operations of the Borough; and
- 2. Interfered with the day-to-day operations of the Borough by making excessive phone calls to the then Department of Public Works Superintendent, George Phipps, and the Borough Administrator in an effort to interfere with the disciplinary process of Glenn Nolen; and

- 3. Engaged in prohibited communications with attorneys who are representing person(s) suing the Borough, such as telephone conversations with the Attorney for Glenn Nolen in order to attempt to circumvent the disciplinary process; and
- 4. Engaged in inappropriate conduct and activity during council meetings including but not limited to threatening members of the Council, and the Police Department during public meetings and also visibly assaulting Councilman Richard Villeda on the dais during the executive session; and
- 5. Breached confidentiality and attorney-client privilege on multiple occasions by providing confidential information to the former Mayor and other members of the general public; and
- 6. Potentially exposed the Borough to unnecessary litigation by organizing and holding an unauthorized rally on Borough property in an attempt to intimidate and harass CFO Anders Hasseler; and
- 7. General dereliction of duty to the Council and our residents, on multiple occasions by clearly failing to read Council meeting packets and to understand matters coming before the Governing Body, as evidenced by the quality and scope of her questions to the staff and moreover soliciting questions from the public and staff that not only reflect a lack of understanding of the rules governing meetings, but also potentially expose the Borough to violations of statutes, based on the infringement of the rights of others; and
- 8. Potential illegal activity by using Borough funds to seek reimbursement for untraceable gift cards.
- 9. Disrupted Council meetings by refusing to yield the floor to the Mayor even after being repeatedly instructed to do so and conducting presentations to the public outside the time period allotted thereby holding the council hostage in violation of the Bylaws; and

WHEREAS, these actions collectively and individually have put the Borough at unprecedented risk, and have compromised the integrity of the Governing Body; and

WHEREAS, it has been determined by this body that this type of vitriolic behavior is divisive, dishonest and poisonous to the residents of the Borough; and

WHEREAS, Robert's Rules of Order states that "... an organization or assembly has the right to make and enforce its own rules, and to require that its own members refrain from conduct injurious to the organization or its purposes;" and

WHEREAS, Robert's Rules of Order lists formal censure as an allowed form of disciplinary action which a body may use regarding the conduct of one of its own members; and

WHEREAS, upon executing the oath of office, each member of the Governing Body swears to uphold the constitutional oath of office, which states that he or she will "support, obey and defend the Constitution of the United States and the Constitution of this State, and the laws and ordinances of the Borough of Roselle; and

WHEREAS, one of the governing principles upon which our nation is founded is the "Rule of Law," which means that the law is uniformly applied to all citizens, and that no individual citizen has a status "above the law;" and

WHEREAS, Robert's Rules of Order states the purpose of formal censure is to correct conduct and behavior.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Borough Council of the Borough of Roselle that Councilwoman Johnson's conduct and behavior as set forth in greater detail hereinabove constitutes misconduct, is divisive, violates council rules and violates the highest standards of honesty, integrity and ethical conduct required of elected officials in the Borough; and

BE IT FURTHER RESOLVED that Councilwoman Johnson's conduct and behavior is hereby condemned in the strongest of terms; and

BE IT FURTHER RESOLVED that a formal censure of Councilwoman Johnson is warranted and is hereby issued for her conduct and behavior; and

BE IT FURTHER RESOLVED that Councilwoman Johnson must hereby refrain from any further similar conduct or behavior; and

BE IT FURTHER RESOLVED that consistent with the Bylaws of this Council, Councilwoman Johnson is hereby removed from her appointment as Chair and Member of the Public Safety Committee; and

BE IT FURTHER RESOLVED that Councilwoman Johnson must familiarize herself with the provisions of the *Governing Body's Bylaws*, and the Borough form of Government that touch upon the conduct expected of her not only at council meetings, but as it concerns day-to-day operations of the Borough; and

BE IT FURTHER RESOLVED that this Resolution shall have immediate effect and shall be posted in full in the official minutes of this governing body and shall be published in full in the official newspaper of the Borough of Roselle.
