WHEREAS, on June 21, 2021, the Borough Council adopted Ordinance No. 2657-21 approving and adopting a redevelopment plan for the North Chestnut Redevelopment Area entitled "North Chestnut Redevelopment Plan, Amendment Number 2" (the "North Chestnut Redevelopment Plan"); and, together with the Block 3801 Redevelopment Plan, the "Redevelopment Plans"); and

WHEREAS, the Borough Council now desires to clarify that, upon the adoption of the above-referenced ordinances approving and adopting the Redevelopment Plans, the Borough intended to (i) amend the Zoning Map of the Borough to reference and delineate the property described and governed by the respective Redevelopment Plans and (ii) provide that the provisions of the respective Redevelopment Plans supersede the applicable development regulations of the Borough's municipal code, as and where indicated in said Redevelopment Plans.

**Section 1**. The aforementioned recitals are incorporated herein as though fully set forth at length.
