- The Board of Health held a vaccine clinic on Monday, October 17, 2022 and 180 vaccines were issued for Covid 19 and the flu.

Planning Committee - Councilman Bernier reported the following:

- The Planning Board held a meeting on October 5, 2022 and an application for 1206 Morris Street which was heard and thereafter denied
- The next Planning Board meeting will be a Special Meeting in November 2022 to memorialize the action taken in October 2022.

Redevelopment Committee - Councilman Bernier reported the following:

- Talked about the resolution on the agenda for authorizing the sale of an undersized lot on Chandler Avenue

Finance Committee - Councilman Bernier reported the following:

- The resolution to accept the 2021 Audit is on the agenda for consideration
- Down to 5 audit comments in 2022 from 12 in 2020 and 59 in 2011
- The Fund balance continues to be strong for the Borough
- Departments are working on budget and capital budget requests

Governance Committee - Council President Wilkerson reported the following:

- The Council is taking action to help resolve disciplinary issues
- Working in the best interest of the Borough residents
- Takes employment agreements very serious and obligations of employees to serve the community

Library Committee - Council President Wilkerson reported the following:

- Moving closer to the construction phase of a new library
- The temporary library is open for business and located on the corner of 2nd Avenue and Chestnut Street

PUBLIC COMMENTS

Mayor Shaw opened up the public comments portion of the meeting; thereafter the following public comments were made:

1. Mario Cornejo, 137 Dennis Street, read a letter into the record in Spanish and Yvonne

- **Cornejo** read the same letter in English about the Spanish community in Roselle, the Office of Hispanic and Latino Affairs, Hispanic Heritage month. Thereafter, they questioned why the HLA office was eliminated and talked about inclusion.
- 2. Salam Ismail, Director of United Youth Council, Elizabeth NJ, talked about the Black and Latino community and its growth. Urged the Governing Body to reconsider putting the Office of Hispanic and Latino Affairs back in effect.
- 3. **Jessica Chavez, 1239 Chestnut Street,** talked about the repeal of the Office of Hispanic and Latino Affairs and the contributions of the Latino community in Roselle. In addition, she expressed that members did not abandon the HLA and hopes the Spanish community will be represented in the Multicultural Inclusion and Accessibility Advisory Committee.
- 4. **Francisco**, 113 Poplar Street, asked the Governing Body why there are no more Spanish events. Further, he talked about events prior to the Covid-19 pandemic, questioned why the El Salvador festival was cancelled and hopes will be brought back.
- 5. Raphael Vanderpool, 330 Birch Drive, talked about an issue with a retaining wall in the back of his property every time it rains. Expressed there is damage to his fence and he spoke to members of the Governing Body and a former Councilman. Wherein he was told a survey will be done and is looking for a resolution. Lastly, he talked about commercial vehicles that are parked on his street.
- 6. Barbara Dixon, 271 E. 2nd Avenue, talked about a recent burglary and questioned if it actually happened and feels word should be put out about it.
- 7. Aeisha Turnage, 291 E. 12th Avenue, talked about a memorandum of understanding submitted to the Borough from the Roselle Board of Education for school resource officers and questioned if it went to the Public Safety Committee for review and if it will be considered for adoption by the Governing Body.
- 8. William Fish, 1809 North Wood Avenue, talked about issues in his building and complaints that he made to the property manager and to the Health Department. He also talked about a recent fire where he assisted in rescuing a resident.
- 9. **Assemblyman Reginald Atkins,** thanked Councilman Fortuna for inviting him to speak at his monthly ward meeting. He talked about Breast Cancer Awareness Month, a first-time home buyers' program on October 26, 2022 at 6:00 p.m. at the legislative office in Roselle, the senior freeze property relief program, meals for residents every Friday at 5:00 p.m., temporary library, a loan forgiveness program. Legislation in Trenton includes the following: a bill to help family success centers throughout the State, a bill in higher education to help families with children going to college for the first time. Available to attend other ward meetings to provide information to the public.
- 10. **Dave Cintron, 615 Melville Terrace,** talked about the Office of Hispanic and Latino and expressed his dissatisfaction about the former members leaving the office. He expressed that he feels their leaving was political since he and his wife did the Cinco De Mayo event and when they reached out to the old member they did not want to help.
- 11. Anthony Esposito, 414 E. 3rd Avenue, talked about an interview he recorded of entertainer John Legend and he played the recording for the record. Mr. Esposito reiterated what Mr. Legend said pertaining to one person getting more freedom doesn't take away from other people's freedoms. He also remarked that a multicultural group may be better for each individual type of group because Roselle is multicultural.

- 12. Sylvia Turnage, 291 E. 12th Avenue, talked about the roles of the executive and legislative branch and the Borough Administrator. She made remarks about the Office of Hispanic and Latino Affairs, their members and events. In addition, she talked about the cost of the lighting in the Borough Hall parking lot and the summer outside events and lack of access to books in the temporary library.
- 13. Lorraine Brooks-Body, 926 Harrison Ave., talked about attending the Council and Board of Education meetings. She also remarked that programs cannot operate without dedicated volunteers and emphasized all employees are required to provide customer service. Lastly, Ms. Brooks-Body suggested that professional development be included in the budget for everyone and questioned why everyone is so negative and mad.

Seeing no one else come forward, Mayor Shaw closed the public comment.

Mayor Shaw then allowed the members of the Governing Body to respond to the public's comments.

Mayor Shaw provided the following comments:

- Borough's involvement to the Hispanic and Latino and provides support for several events
- HLA appointments were made in January 2022 and the members resigned thereafter in February 2022.
- Requested Borough Clerk Sanchez to read an email from Yessica Chavez, Reyes Osorio, Silvia Fonseca, Lucia Tlapanco, Mario Cornejo into the record regarding the group's resignation.
- Multiple events for the Latino community were held after the resignations
- No communication with the Board of Education regarding issues in the school
- School lockdown and response to the community

Council President Wilkerson provided the following comments:

- Talked about separation of the legislative, administrative and executive branches
- Action taken on an employee went through administration process
- Obligated to let residents know complaints are addressed and staff are being held accountable
- HLA was for small business to flourish and to improve the lives of Hispanics
- Discussed the creation of HLA in 2013 and appointments made when Acting Mayor
- Latino events took place after February 2022 and support given by the Borough
- New members requests can sign up with the Mayor's Office
- School district can cover the resource officers in their budget

Councilwoman Johnson provided the following comments:

- Hispanic events at Sylvester Land Field turned political
- Requested bylaws for the Multicultural Inclusion and Accessibility Advisory Committee
- Advised she and Councilman Villeda are not on any standing committees
- Resource officers for the school and monies allotted for the program
- Council communicating with Department Heads and sending emails

- Talked about the temporary Roselle Public Library
- School lockdown and response to community

Councilman Villeda provided the following comments:

- Councilman Villeda confirmed he cancelled the El Salvador flag raising and Multicultural event due to vendors and entertainers who opted out because of the forecasted weather conditions.
- Advised he has served in the community for many years as a Board of Education member
- Participated in many Hispanic and Latino events and represents all Latinos, as well as the community of Roselle
- Thanked the Mayor and Council for their support

Councilman Fortuna provided the following comments:

- Confirmed that Councilman Villeda is a member of the DPW Committee, the Public Safety Committee and Recreation Committee
- Will contact Code Enforcement about 1809 North Wood Avenue's roof
- Talked about the ongoing issue on Birch Drive and a survey to be done by Engineering
- Time limits on commercial vehicles can be considered
- Public safety committee does not receive specifics on crimes committed and would be hesitant to discuss publicly

Councilman Bernier provided the following comments:

- Reminded everyone that a third flag pole was previously added by the Borough to ensure flag raisings for different communities
- Addressed the retaining wall issues and gave an explanation of survey proposal
- Funding for resource officers in schools was not anticipated in the budget
- No meetings were held between Borough and the Board of Education for resource officers
- Council is the legislative and executive branch in the Borough form of government
- Multicultural Inclusion and Accessibility Advisory Committee and Diversity in the Borough

- (1) If any person for whom a parking space has been designated pursuant to this section ceases to reside at the specified resident address, he or she (or other person authorized to act on their behalf) shall promptly notify the Borough Clerk in writing that the designated parking space is no longer required.
- (2) In the event that the person holding the designated handicapped parking permit no longer resides at the specified residence address, the designation may be terminated by resolution.

If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to this section, paragraph, subdivision, clause or provision so adjudged and the remainder of the Ordinance shall remain valid and effective.

This ordinance shall take effect after public hearing and final adoption and publication according to law.

ORDINANCES ON SECOND READING/PUBLIC HEARING - Ordinance Number 2694-22

ORDINANCE OF THE BOROUGH OF ROSELLE, IN THE COUNTY OF UNION, NEW JERSEY AUTHORIZING SALE OF PROPERTY AND EXECUTION OF PURCHASE AND SALE AGREEMENT AND AUTHORIZING CERTAIN OTHER ACTIONS IN CONNECTION THEREWITH

WHEREAS, on October 11, 2007, the Mayor and Borough Council (the "Borough Council") of the Borough of Roselle (the "Borough") adopted a resolution designating the entire Borough as an area in need of rehabilitation pursuant to the New Jersey Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1 *et seq.* (the "Redevelopment Law"); and

WHEREAS, the Borough adopted an ordinance, as subsequently amended, approving and adopting the Central Roselle Revitalization Plan (as amended and as may be further amended, the "Central Roselle Revitalization Plan"), a redevelopment plan applicable to the area described as follows:

The Revitalization Plan Area begins at the corner of Chestnut Street and St. Georges Avenue, north on Chestnut Street to Eighth Avenue, east on Eighth Avenue to Spruce Street, north on Spruce Street to Seventh Avenue, East on Seventh Avenue to Chandler Avenue, south on Chandler

Avenue to Morris Place, east on Morris Place to Harrison Avenue, south on Harrison Avenue to Georges Place, east on Georges Place to the western border of Warinanco Park, south along the eastern border of Blocks 1402 and 1404 to St. Georges Avenue, and St. Georges Avenue west to Chestnut Street (the "Central Roselle Revitalization Area"); and

WHEREAS, pursuant to N.J.S.A. 40A:12A-4, the Borough has determined to act as the "Redevelopment Entity" (as such term is defined at N.J.S.A. 40A:12A-3) for the Central Roselle Revitalization Area to exercise the powers set forth in the Redevelopment Law; and

WHEREAS, Marcos Diaz (the "Purchaser") owns the property in the Central Roselle Revitalization Area known as 1116 Chandler Avenue and designated as Block 2505, Lot 6 on the Borough's tax maps (the "Purchaser Property"); and

WHEREAS, the Borough currently owns the property directly adjacent to the Purchaser Property, located on Chandler Avenue and designated as Block 2505, Lot 5 on the Borough's tax maps (the "Borough Property"); and

WHEREAS, the Borough Property is undersized, is incapable of being developed by itself and does not currently generate any tax revenue for the Borough; and

WHEREAS, the Purchaser proposes to acquire the Borough Property and consolidate same with the Purchaser Property; and

WHEREAS, the Borough has determined that the Borough Property is no longer needed for public use, and that the merger of the Borough Property into the Purchaser Property is in the Borough's best interest; and

WHEREAS, the Brough desires to convey the Borough Property to the Purchaser for the purpose of merging same into the Purchaser Property; and

WHEREAS, the Borough now desires to authorize the execution of an agreement (the "Purchase and Sale Agreement") with the Purchaser to set forth the terms and conditions under which the Borough will convey the Borough Property to the Purchaser.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Roselle, County of Union, State of New Jersey, as follows:

- 1. The aforementioned recitals hereof are incorporated herein as though set forth at length herein.
- 2. The Borough is hereby authorized to convey the Borough Property to the Purchaser on terms consistent with those set forth in the Purchase and Sale Agreement, including a purchase price of Ten Thousand and 00/100 Dollars (\$10,000.00).
- 3. The Mayor is authorized to execute the Purchase and Sale Agreement with the Purchaser, in substantially the same form as that on file with the Borough Clerk, along with such

- minor additions, deletions or modifications the Mayor deems necessary, after consultation with Borough counsel.
- 4. The Mayor, the Business Administrator of the Borough and the Clerk of the Borough are hereby authorized to execute, on behalf of the Borough, any and all documents, necessary to effectuate the conveyance of the Borough Property to the Purchaser.
- 5. This Ordinance shall take effect in accordance with applicable law.

Mayor Shaw read Ordinance Number 2694-22 by title and opened the public hearing on the ordinance. Seeing no one come forward, Mayor Shaw closed the public hearing on the ordinance.

WHEREAS, Lucky Buds LLC has provided the Borough with sufficient information regarding their expanded business model at the proposed cultivation and manufacturing site (the "Site") to be located at 244 West 1st Avenue, Roselle, identified as Block 4701, Lot 13, on the current Official Tax Map of the Borough; and

WHEREAS, the Site is located in the Commercial-Industrial Zone, where "Cannabis Cultivator" is a conditionally permitted use pursuant to the Code of the Borough of Roselle, § 650-99B(3) and 650-102.B(9) if the following conditions are met:

- (a) All other regulations for the district in which the use is to be located shall be complied with.
- (b) The design of any building or structure required for such use conforms to the general character of the area in which it is located.
- (c) The cultivation activities of said establishment must be conducted entirely indoors.
- (d) Unusual odors, smells, fragrances, or other olfactory stimulants shall be prohibited beyond the property line. Odor mitigation filtration systems shall be installed and maintained in perfect working order; and

WHEREAS, the Commercial-Industrial Zone permits cannabis manufacturing, pursuant to the Code of the Borough of Roselle, § 650-99(m); and

WHEREAS, the zoning officer of the Borough has analyzed applicable law and public records and has made such other inquiries as necessary and opined that the proposed Site as a cannabis cultivator is a conditionally permitted use under the relevant zoning ordinances; and

WHEREAS, the zoning officer of the Borough further opined that the proposed Site as a cannabis manufacturer is a permitted use under the relevant zoning ordinances; and

WHEREAS, the Borough Council believes that permitting Lucky Buds to operate the Site as a cannabis cultivator and manufacturer will satisfy patients' and consumers' interests and help create jobs and economic opportunity within the Borough and enhance public safety; and

WHEREAS, the Borough Council believes the intended Site is appropriately located and suitable for activities related to the operation of the proposed cannabis cultivation and manufacturing; and
