ORDINANCE NUMBER 2700-22

ORDINANCE OF THE BOROUGH OF ROSELLE, IN THE COUNTY OF UNION, NEW JERSEY AUTHORIZING THE SALE OF CERTAIN BOROUGH OWNED PROPERTY LOCATED ON WHITE STREET AND IDENTIFIED AS BLOCK 2301, LOT 31 ON THE BOROUGH'S OFFICIAL TAX MAP, AND AUTHORIZING THE EXECUTION OF PURCHASE AND SALE AGREEMENT AND AUTHORIZING CERTAIN OTHER ACTIONS IN CONNECTION THEREWITH

WHEREAS, on October 11, 2007, the Mayor and Borough Council (the "**Borough Council**") of the Borough of Roselle (the "**Borough**") adopted a resolution designating the entire Borough as an area in need of rehabilitation pursuant to the New Jersey Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1 *et seq.* (the "**Redevelopment Law**"); and

WHEREAS, the Borough adopted an ordinance, as subsequently amended, approving and adopting the Central Roselle Revitalization Plan (as amended and as may be further amended, the "**Central Roselle Revitalization Plan**"), a redevelopment plan applicable to the area described as follows:

The Revitalization Plan Area begins at the corner of Chestnut Street and St. Georges Avenue, north on Chestnut Street to Eighth Avenue, east on Eighth Avenue to Spruce Street, north on Spruce Street to Seventh Avenue, East on Seventh Avenue to Chandler Avenue, south on Chandler Avenue to Morris Place, east on Morris Place to Harrison Avenue, south on Harrison Avenue to Georges Place, east on Georges Place to the western border of Warinanco Park, south along the eastern border of Blocks 1402 and 1404 to St. Georges Avenue, and St. Georges Avenue west to Chestnut Street (the "**Central Roselle Revitalization Area**"); and

WHEREAS, pursuant to N.J.S.A. 40A:12A-4, the Borough has determined to act as the "Redevelopment Entity" (as such term is defined at N.J.S.A. 40A:12A-3) for the Central Roselle Revitalization Area to exercise the powers set forth in the Redevelopment Law; and

WHEREAS, Akeem Haynes (the "**Purchaser**") owns the property in the Central Roselle Revitalization Area known as 319 White Street and designated as Block 2301, Lot 32 on the Borough's tax maps (the "**Purchaser Property**"); and

WHEREAS, the Borough currently owns the property directly adjacent to the Purchaser Property, located on Chandler Avenue and designated as Block 2301, Lot 31 on the Borough's tax maps (the "**Borough Property**"); and

WHEREAS, the Borough Property is undersized, is incapable of being developed by itself and does not currently generate any tax revenue for the Borough; and

WHEREAS, the Purchaser proposes to acquire the Borough Property and consolidate same with the Purchaser Property; and

WHEREAS, the Borough has determined that the Borough Property is no longer needed for public use, and that the merger of the Borough Property into the Purchaser Property is in the Borough's best interest; and

WHEREAS, the Brough desires to convey the Borough Property to the Purchaser for the purpose of merging same into the Purchaser Property; and

WHEREAS, the Borough now desires to authorize the execution of an agreement (the "**Purchase and Sale Agreement**") with the Purchaser to set forth the terms and conditions under which the Borough will convey the Borough Property to the Purchaser.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Roselle, County of Union, State of New Jersey, as follows:

1. The aforementioned recitals hereof are incorporated herein as though set forth at length herein.

2. The Borough is hereby authorized to convey the Borough Property to the Purchaser on terms consistent with those set forth in the Purchase and Sale Agreement, including a purchase price of Three Thousand and 00/100 Dollars (\$3,000.00).

3. The Mayor is authorized to execute the Purchase and Sale Agreement with the Purchaser, in substantially the same form as that on file with the Borough Clerk, along with such minor additions, deletions or modifications the Mayor deems necessary, after consultation with Borough counsel.

4. The Mayor, the Business Administrator of the Borough and the Clerk of the Borough are hereby authorized to execute, on behalf of the Borough, any and all documents, necessary to effectuate the conveyance of the Borough Property to the Purchaser.

5. This Ordinance shall take effect in accordance with applicable law.

RESOLUTION AUTHORIZING THE AWARD OF A NON-FAIR AND NON-OPEN CONTRACT TO JGSC GROUP FOR PROFESSIONAL SERVICES IN CONNECTION WITH REDEVELOPMENT WITHIN THE BOROUGH NOT TO EXCEED \$35,000.00

WHEREAS the Borough of Roselle has a need to acquire redevelopment consultants as a non-fair and non-open contract pursuant to the provisions of N.J.S.A. 40A: 11-3(b); and,

WHEREAS the Purchasing Agent has certified that the value of the acquisition will exceed \$17,500; and

WHEREAS JGSC GROUP, LLC has submitted a proposal indicating they will continue to provide redevelopment services to the Borough for the period from January 1, 2023 through December 31, 2023; and

WHEREAS JGSC GROUP, LLC has completed and submitted a Business Entity Disclosure Certification which certifies that JGSC Group has not made any reportable contributions to a political or candidate committee in the Borough of Roselle in the previous one year, and that the contract will prohibit JGSC Group from making any reportable contributions through the term of the contract; and

WHEREAS, the Chief Financial Officer of the Borough of Roselle is certifying that the funds will be available for this purpose professional services in connection with redevelopment in the Borough contingent upon the Governing Body's approval and inclusion of said item in the Temporary Budget and adopted in 2023 and there will be sufficient funds to contract JGSC Group, LLC.

NOW, THEREFORE BE IT RESOLVED BY THE BOROUGH COUNCIL OF THE BOROUGH OF ROSELLE:

1. That the Borough awards the existing contract to and appoints JGSC Group, LLC located at 2845 Powell Avenue, Pennsauken, NJ 08110 to provide professional redevelopment services to the Borough, for an amount not to exceed Ninety-Two Thousand and 00/100 Dollars (\$35,000.00), for a period from January 1, 2023 through December 31, 2023.
2. That this contract is awarded without competitive bidding as a professional service under the provisions of the Local Public Contracts Law (N.J.S.A. 40A: 11-5(1)) because redevelopment services are a recognized profession licensed and regulated by law.

3. That a notice, in accordance with this resolution and the Local Public Contracts Law of New Jersey, shall be published in the official newspaper or newspapers of the Borough, as required by law, within twenty (20) days of execution of the contract.

4. That an executed copy of the Contract between the Borough and JGSC Group, LLC, 2845 Powell Avenue, Pennsauken, NJ 08110 and a copy of this resolution shall be filed in the Office of the Borough Clerk and shall be available there for public inspection in accordance with the law.

5. This Resolution is adopted and shall be instituted as part of a Non-Fair and Non-Open Process, established and exercised pursuant to N.J.S.A. 40A:11-5(1).

6. All previous Resolutions and/or orders and directives of Borough employees or officials which are contrary to or inconsistent with the terms of this instant Resolution, are hereby rescinded, repealed and otherwise deemed ineffectual, to the extent of their inconsistency.

7. That this Resolution shall take effect immediately.

RESOLUTION NUMBER 2023-035

RESOLUTION APPROVING QUITCLAIM DEED

WHEREAS, the Borough Council ("**Borough Council**") of the Borough of Roselle (the "**Borough**") acquired title to the property previously designated as Block 223-4, Lots 117B and 118 on the tax maps of the Borough, now known as Block 1208, Lot 15, 1029 Chandler Avenue (the "**Property**") by virtue of that Judgment entered in the Tax Lien Foreclosure Action in the Superior Court of New Jersey, Chancery Division, bearing Docket Number F-1836-54, which Judgment was recorded in the Union County Clerk's Office on August 1, 1955 in Book 2203, Page 422; and

WHEREAS, title to the Property is currently listed in Borough and Union County records as being in the name of Delores and Robert Scott, although neither Borough nor County records include a Deed conveying the Property after the Borough's 1955 acquisition of same, or legislation authorizing such conveyance; and

WHEREAS, Borough tax records indicate that the Property has been treated as being privately-owned, as opposed to being owned by the Borough, since at least 1988; and

WHEREAS, Delores Scott acquired title to the Property after her father, Louis Briggs, passed away in 1982 intestate, by Deed from Eunice Briggs (wife of Louis Briggs) and by Deed from Terry King (Delores Scott's sister) to two parcels that, together, comprise the Property; and

WHEREAS, both of the aforementioned Deeds contain recitations that Tract Two referenced therein (half of former Lot 117 and Lot 118) vested in Louis Briggs by Deed from the Borough dated December 24, 1965; and

WHEREAS, Delores Scott has since passed away and Robert Scott desires to sell the Property, and

WHEREAS, Robert Scott has requested that the Borough take action to clear title to the Property to facilitate the sale thereof; and

WHEREAS, the Borough desires to authorize the execution of a Quitclaim Deed conveying whatever interest the Borough has in the Property to Robert Scott for nominal or no consideration.

NOW, THEREFORE, BE AND IT IS HEREBY RESOLVED by the Mayor and Council of Borough of Roselle, in the County of Union and the State of New Jersey, as follows:




