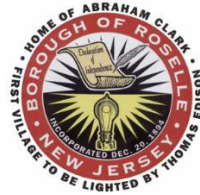

Notice is hereby given that the Planning Board of the Borough of Roselle has scheduled a Regular Meeting for **Wednesday, March 3, 2021 at 6:30 p.m.** prevailing time.

To protect the health, safety, and welfare of our citizens while ensuring the continued functioning of the Planning Board, this meeting will be held via electronic video and audio-conferencing software (Zoom). This is in accordance with the "Senator Byron M. Baer Open Public Meetings Act", which permits a public body to conduct a meeting electronically during a state of emergency, as well as Governor Murphy's Executive Orders No. 103 and 107 declaring a "Public Health Emergency and State of Emergency" and directing residents to quarantine and practice social distancing.

There will be no in-person meeting. Members of the public are invited to view the meeting live using the Zoom client, which allows them to participate and contribute with voice and video when they are invited to do so during public portions of the meeting.
